

# Strong International Links and Business Scholarship

The National Centre for Business Law will benefit from the strong links to China, Japan, Korea and other nations of the Pan-Pacific region forged by UBC Law and the Institute for Asian Research at UBC. The Centre will be strategically positioned to advance international business law research, critical at a time of increasingly cross-border activity.

The Centre will provide a forum for exchange of ideas in respect of business law policy on a nation-wide basis.

The Centre has benefited from an aggressive search for the best and brightest minds in business law. We have scholarship strength in business torts, corporate law, securities regulation, sustainability, international business transactions, international commercial arbitration, corporate tax, natural resources law, commercial insolvency law, pension law, and international trade.

The National Centre for Business Law is now poised to provide a strong centre for intellectual engagement and interdisciplinary research in business law.

### **Current Projects**

#### **ENHANCING EDUCATION:**

The enhancement of business law education for law students has begun. After an intensive consultation with the profession nationally, UBC Law has reformed its business law curriculum. Commencing September 2006, students will have the opportunity to take a Business Law Concentration as part of their LLB. degree, with new courses to ensure that students have the best skills possible for the practice of business law.

The National Centre for Business Law is developing intensive courses for business leaders and legal practitioners on cutting-edge areas of business law developments.

#### ADVANCING RESEARCH:

The Centre has obtained funding and is collaborating with the Toronto Stock Exchange Group and Institute for Capital Market Studies in the TSX Capital Markets Initiative, a project that will advance scholarship and public policy debate on the future of the Canadian capital markets sector.

Scholars affiliated with the Centre are working with national research grants in intellectual property, comparative tax law, securities law reform, corporate governance, commercial insolvency law, natural resource law and international trade in the Pan-Pacific region.

The Centre is developing a program of interdisciplinary and empirical research, attracting scholars from business and law, both domestically and internationally.

The Centre will launch the *UBC National Review of Business Law*, an annual peer-reviewed scholarly journal on cutting-edge business law developments in fall 2006.





#### ENGAGING THE BUSINESS LAW COMMUNITY:

The National Centre for Business Law will host a policy roundtable with the Chairs of the Ontario Securities Commission and British Columbia Securities Commission, "The Future of Securities Regulation, the Potential for Convergence of Ideas", in Vancouver on September 28, 2006.

The Centre will host the *Pan-Pacific Business Law Conference* on "Legal Frameworks for Sustainable Development and Trade Relationships in the Asia Pacific" at UBC Law September 29-30, 2006.

The Centre will co-host the fourth *Annual Review of Insolvency Law Conference*, in Montréal on March 30, 2007.

The Centre has launched a tax newsletter, offering up to date news on developments in tax law.

The Centre will offer a new Business Law Speakers series to be held in Vancouver and Calgary in 2006–2007.

The National Centre for Business Law is actively seeking expressions of interest in affiliation from both Canadian and international business law scholars for its collaborative research projects.
