I. Introduction.

(A) **Brief History of Nagar Haveli Police** :- No authentic record of history could be found so far. But from the officers in the police who have been here since long it has come to notice that during the Portuguese time there was only one Police Station in Silvassa along-with three Out Posts, at Naroli, Dadra and Khanvel. The over-all In-Charge of police of DNH was Chief Of Police. The office of Chief Of Police was in a building which was known as High Building. After liberation in 1954, the previous system continued till 1964. In that year one more Police Station was opened at Khanvel. In the year 1965, the third Police Station was opened at Surangi.

This system continued till 1973. In that year the Surangi Police Station was abolished/made non-functional. Till today the set-up is same except some increase in Out-Posts.

After liberation, usually the post of Chief Of Police was being held by the officers on deputation from Gujarat. Lately, the same post is being filled by the DANIPS officers.

III. Activities :-

1. **Maintaining Law and Order.**

All type of issues related to law and order have been managed in a very professional manner. On all occasions of public gatherings such as religious festivals, political meetings, protests, rallies and bundhs utmost care was taken to make them incident free. Proper care has been taken at the time of handling of criminal cases and other incidents that appropriate and timely action is taken so that the people have confidence in the system and are not exploited by the demagogues. Instructions have been issued to all field officers and staff to be prompt even in cases of accidents and handle the same in a very tactful way without giving anybody a chance vitiate the atmosphere.

On the **labour** front also a fine balance has been maintained about judging the situations where police intervention becomes necessary. It has been clearly briefed down the line as well as to the industry people also that only and only pure law and order situation would be dealt with by the police and in cases of labour management disputes they should adhere to other mechanisms provided by the law. As and when any complaint of criminal nature and break out of law and order problem has been received, prompt action has been taken according to law.

2. **Prevention and detection of Crime**

On this front an analysis was made and check-points as well as patrolling arrangements was made accordingly. A pamphlet of do's and don'ts was circulated for the lonely farm houses which were being targeted by the gang of robbers and sources were deployed to know their whereabouts.

The investigating officers have been well supervised. The special *nakas* and patrolling staffs briefed about the ways of checking the vehicles and persons to control the crime.

3. **Regulation of Traffic.**

This unit has regulated traffic well despite being very small unit, on all occasions of VIP visits, functions during elections, religious festivals and other occasions. They have also regulated traffic at both the bridges, Rakholi and Athal bridges in different conditions.

V. Achievements :-

1. **Successful completion of 14th Lok-Sabha Election -2004**

The political build-up to the preparation for the General Elections for Lok Sabha was managed in a very effective and impartial way. No incident was allowed to take place. All dubious characters, anti-social elements, boot-leggers, known criminals were kept under close watch and required preventive action was taken. No body was allowed to vitiate the atmosphere.

Highly competitive political atmosphere at the time of canvassing by different political parties for General Elections for the 14th Lok Sabha, was kept in a total control and temper of the people at large and political activists in particular was not allowed to rise to

the point to give way to lawlessness. Every complaint, incident and information was treated with utmost care and promptness.

A very close watch was also kept at the police staffs as well and it was ensured that no complaint of impartiality or unfair treatment from any side was received. It was happy to note at the end of election process that not only the Observers from the Election Commission of India, but leaders all political parties also praised the fact that the Election was conducted in a very fair and peaceful way.

Post-election scenario was also managed well and proper patrolling was carried out to ensure that no enmity breaks out among the people in the interior parts of the territory. The people felt secured have had access to express their fears and problems.

2. **Performance of Police during Flood situation.**

During flood situations proper police arrangement were made as per the situations developed on the day of flooding, i.e., on the 3rd August-04 and thereafter. No commotion or situation of panic was allowed to develop. The people as well as senior officers were informed of all developments concerning with flooding of the areas. The department of electricity was informed to cut supply in the areas where water entered and it was doubted that electric supply could cause electrocution. The police officers and the staff took part in rescue operations till the water of flood receded.

Proper police arrangement had been maintained at on both the sides of Athal bridge, Pipariya bridge, Dokmardi bridge, Rakholi bridge and Nalah at Bavisafaliya. Bandobast had been arranged at various flooded areas at Tigra village, Near Fire Station, Collector's bungalow, bus stand and Tokarkhada junction. And sufficient arrangement had been placed at respective Out Post areas.

3. **Detection of Inter-State gangs.**

Sources were deployed to gather the information about the gang of robbers targeting lonely farm houses one after another. The vital clues were collected and concerted efforts were made to arrest them in coordination with Maharashtra Police. A big gang of more than 25 members involved in as many big crimes have been busted and robbed property of *lacs* of rupees including two weapons belonging to Shri Surender Parmar, Advocate, Silvassa, have been recovered. It is expected that many of old undetected robbery and dacoity cases committed in the territory would be opened. Since then, no major crime has been reported in and around the area.

Besides, some positive detection was also done. Around 10 stolen motor cycles from the state of Haryana, Rajasthan and Delhi were recovered and gang members involved in arrested.
