Appendix D Media Policy

Working with Media (Media Policy developed December 2010)

If a report or journalist contacts you and asks to do an interview:

✓ Ask for the questions upfront

✓

- ✓ Ask the media what the intention of their story is.
- ✓ Ask the media how much time they need to spend with you.
- ✓ Ask the media how long their story will be and how much of the story will be taken from your interview.
- ✓ Set a time and place to meet with the reporter or journalist that is easiest for you. Do not invite them to your home. Go to their studio or an allie's office or a public space. Keep your personal space separate from public media work.
- ✓ You are in charge of the interview and can stop the interview at any point. You can ask the report or journalist questions at any time.
- ✓ Ask an ally to be with you when the reporter or journalist is meeting with you to do the interview
- ✓ Go over the questions the reporter sends ahead of time. Have your ally ask you the questions and give you feedback on your answers.
- ✓ Try not to use people's names when answering media questions. Your friends or other people might be upset that you spoke about them publicly.
- ✓ Try not to refer to your own family when answering media questions. Your family might be upset that you spoke about them publicly.
- ✓ If you are asked to pose for a photo or a camera shot then do only what you feel comfortable doing. Have your ally with you during the photo shot of camera shooting.

If you are at a public event and a reporter approaches you and asks to speak with you or interview you:

- ✓ You should ask them to wait and go get an ally to be with you during the interview.
- ✓ Ask the media what exactly they want to discuss with you. Do they have specific questions?
- ✓ Tell the media that you may stop them at any point during the interview.
- ✓ Ask the media any questions you need to ask to have a clear understanding of what they want to talk to you about and what type of questions they want to ask you.

- ✓ Do not use people's names or refer to family members. For example do not say 'My Mom said I cannot go to that event" or "Bill, my friend said he never liked that book." Your friends and family will not appreciate being spoken about publicly and may be mad at you for a long time afterwards. You could say "A person I know said they never liked that book." Or "A friend of mine told me that he/she would never attend that conference."
- ✓ If the reports want to take pictures of you tell them that you have final say on what picture(s) they can use with their story and tell them you do not want your picture kept/stored for future stories that might be related.
- ✓ Ask the reporter to repeat anything you do not understand.

Academics who work with Vulnerable Individuals that involve media

- ✓ Go over expectations of what you or the reporter wants to discuss with the individual and make sure they feel comfortable speaking and sharing.
- ✓ Stay with the individual while the media is present.
- ✓ Ask for interview questions upfront and go over the questions with the individual prior to the interview. A practice run will help organize thoughts and enable you to give feedback.
- ✓ Remember that disclosure can happen when the camera or recorder is running make sure you can stop the process at any time and retract statements or insist they not be used.
- ✓ Protect the individual from the media hype of continue stereotypes of vulnerable individuals use the opportunity to educate the media workers and reporters. Have a list of resources available to give to the report so they can learn more about the struggles and survival of living with a disability.
- ✓ Experience trumps education be humble
- ✓ Think ahead to when the story airs will there be repercussions or fall out for the individual when the story hits the air waves? Will family or friends be upset they were spoken about? Coach the individual to avoid using names and relation indicators (ie my mom said, or Nancy thinks that).
- ✓ We have a responsibility to involve vulnerable individuals whose stories have most often been left out of the Canadian collective memory, but remember we have responsibilities beyond this we must be responsible for how the individual 's story is perceived by the reporter and media. Think about the multiple possibilities before you involve the media.
- ✓ If you are holding a public event that media will be at it might be best to hold a press conference and then have a media contact person identified to all media. If the media approaches someone who is a vulnerable person and not a media contact then the media contact needs to become an ally to that individual.
- ✓ Speak to vulnerable individuals about the possibilities that media might be in attendance and that they might be approached. Suggest that they report any media advances to the media spokesperson as soon as possible.
