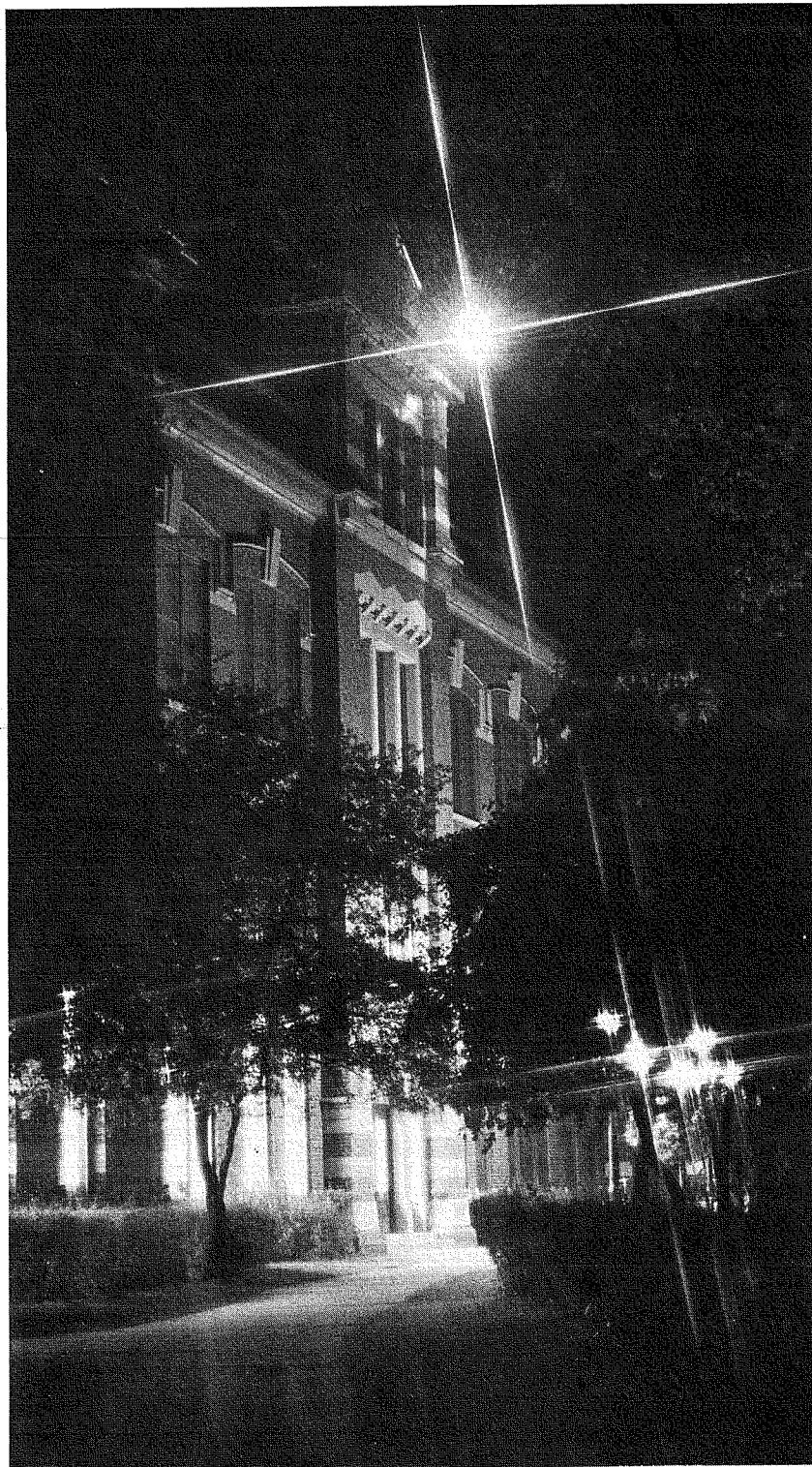

Dear Alumni and Friends,

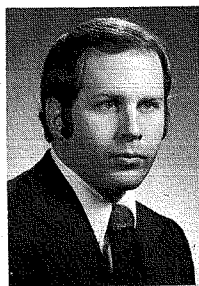

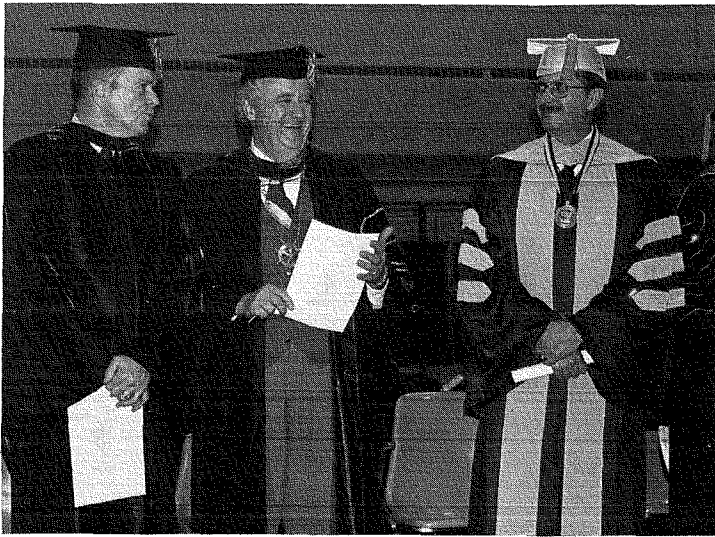

# Lindner Joins Dreyfus Administration



Wisconsin Governor-elect Lee S. Dreyfus (center) delivered the address at December commencement ceremonies. He is flanked by Vice Chancellor W. Carl Wimberly (left) and Chancellor Kenneth E. Lindner. Dr. Lindner has since joined the governor's cabinet as secretary of the Department of Administration; Dr. Wimberly now serves as acting chancellor.

Dr. Kenneth E. Lindner has left his position as chancellor of the University of Wisconsin-La Crosse to become secretary of the Wisconsin Department of Administration. His appointment was announced December 15 by then Governor-elect Lee S. Dreyfus.

In accepting the appointment, Lindner said he looks forward to the challenges presented by the new position and membership in the governor's cabinet.

"I have the greatest respect for Lee Dreyfus," Lindner said, "having been his colleague for many years. I have complete confidence in his ability to govern this state in a responsible and farsighted manner."

"Of course, I do have mixed emotions about leaving my post as chancellor," Lindner continued, "for my work here has been the most rewarding and satisfying of my career." "I have watched UW-La Crosse grow to national prominence in many areas and have had the opportunity to work with some of the finest people I have ever know...faculty, staff and students of the university, many members of the La Crosse community, and an active group of alumni around the state and country," he concluded.

# UW-L Alum is Kenyan Ambassador

UW-La Crosse has many distinguished alumni, but only one of them is an ambassador and United Nations representative.

He's **John Mwaura**, a 1965 UW-L

graduate in political science. Today he's Kenya's ambassador to West Germany, Austria, and the Netherlands, as well as a member of his country's delegation to the UN.

Mwaura celebrated his own personal homecoming last October when he returned to La Crosse for the first time since graduation to visit the campus and see old friends. He found the University far larger than when he attended 13 years ago, but according to the soft-spoken and articulate statesman, the same warm, friendly atmosphere still prevailed.

"It is not always easy for an outsider coming to a place for the first time," he said, "but I felt welcome here. Looking back, I consider myself fortunate to have received a fine education at the University."

Mwaura first came to La Crosse largely through the efforts of Monsignor Anthony P. Wagener, pastor at the La Crosse Blessed Sacrament Church and formerly chaplain of the Newman Center. During his college years Mwaura worked at the La Crosse Country Club, but most of his time was spent getting what he called a "sound, liberal arts education."

A native of Nelson, Wis., Lindner received a B.S. degree from UW-Eau Claire in 1949 and a master of arts and Ph.D. from the University of Iowa in 1953 and 1966, respectively. Following high school graduation, he served with the U.S. Army Signal Corps from 1942-45. After college graduation, he began his educational career as a teacher and administrator in the Wisconsin public schools and in 1956 joined the chemistry faculty of UW-La Crosse. His tenure was briefly interrupted while he completed requirements for the Ph.D. and served as instructor of health physics at the University of Iowa. He returned to La Crosse in 1966 as professor of chemistry and director of the Nuclear Radiation Center.

Lindner left the university in 1967 for Madison to head the Office of Academic Affairs of the Board of Regents of State Universities and serve as director of WSU Field Stations. He was appointed to the leadership of UW-L effective Jan. 1, 1971.

Lindner currently serves as commissioner and consultant examiner for the North Central Association of Colleges and Secondary Schools and is past state representative and a member of the Committee on Federal Relations for the American Association of State Colleges and Universities. Other memberships include the Boards of Directors of the Greater La Crosse Chamber of Commerce and Gateway Area Boy Scouts and the Board of Trustees of the La Crosse YWCA. He previously served on the Board of Directors for the First National Bank of La Crosse. In 1976, UW-Eau Claire honored him with its Alumni Distinguished Service Award.

Lindner's professional memberships include the American Chemical Society, the Health Physics Society, the International Radiation Protection Association and Phi Delta Kappa. He formerly served as consultant on radiation safety and health physics to Gundersen Clinic, Ltd., of La Crosse and on radiation chemistry to the La Crosse Boiling Water Reactor, Dairyland Power Company.

"I had excellent instruction in all areas," he said. "The faculty not only knew the subject matter, but they genuinely cared whether the student was learning or not."

One faculty member who remembered Mwaura as a student was vice chancellor W. Carl Wimberly, then a professor of political science. The Kenyan ambassador was his guest for part of his weekend at the university, and he recalled him as an exceptional student.

"John was always modest about his ability as a scholar," Wimberly said, "but he was the kind of student you liked to have in a class—bright, enthusiastic, and an articulate contributor to class discussion."

Wimberly also said Mwaura brought a different point of view to political discussions. "I used to take John and other foreign students outside the University to participate in lectures and discussions," he said. "His ideas were always challenging—he was a stimulating speaker."

Following his graduation from UW-L, Mwaura returned to Kenya to work as a district administrator in a rural province, where he said he came into contact with the problems of people in a developing country. He joined the Kenyan foreign office in 1968, was posted to London in 1970 as first secretary, and returned to his homeland in 1974. He was deputy secretary in charge of finance and administration for the Kenyan foreign service for three years, then was named ambassador to West Germany, Austria, and the Netherlands. He now heads a 25-member staff in Bonn and travels extensively.

During his visit to the campus Mwaura spoke to students and the press about African politics and his own nation in particular. He explained that while Kenya is attempting to upgrade education, expand its economy, and develop technological skills, the country must remain non-aligned in East-West power politics.

"We are serious about non-alignment," he said. "We have pursued a policy of getting whatever we can get from anybody."

To develop as a nation, Mwaura said Kenya has:

\*Upgraded education, including elimination of some examination barriers which previously kept students from moving on to high school or college.

\*Attempted to develop a series of technical schools to provide a broader based economy.

\*Sought to develop trade contacts with other nations. The embassy he heads in Bonn is aimed at encouraging West German investment, trade, and obtaining technical skills.

\*Expanded tourism and textile industries.

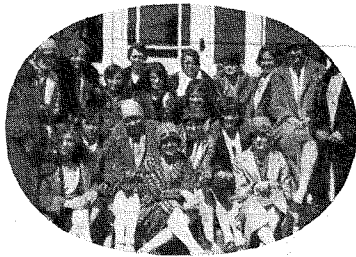
Mwaura explained that while economic growth is possible in Kenya for foreign corporations, Kenyans are usually involved in the management of such firms at the top level.

# The Class of '28

Note: In 1928 **Margaret Halverson** graduated from La Crosse State Teachers' College with a major in elementary education. Naturally, she was excited and full of hope for the future, as well as a little sentimental about the past. Somewhere amid all the excitement of graduation, however, Margaret lost something that contained important memories—her college yearbook.

Now, 50 years later, **Mrs. Margaret Crook** has been reunited with her yearbook. It was found among a number of other La Crosse yearbooks gathering dust in Main Hall. Smiling, she recently sat in the living room of her Wisconsin Rapids home and paged through the memories of the class of '28.



**Dear Marg—we surely deserved an A in biology class. What about all those true-false tests?...I don't know how we ever lived through it...**

The academic schedule of the class of '28 might seem a bit rigorous to today's students. Classes ran from 8 a.m. to 4 p.m. Attendance was mandatory, and cutting classes was almost a sin. "We were all very serious, probably more so than students are today," Mrs. Crook said. "But then, it was a different world. There wasn't nearly as much pressure."

Learning was usually enjoyable for students, she noted. Classes were small, and emphasis was placed on open discussion and group participation. Homework and exams were rarely crucial factors. "That type of environment made school much easier for us," Mrs. Crook said. "Today there are lectures, research, tests...the demands are so great. Perhaps when things were simpler, they were more fun."

**How'd you like the class play picnic?...Don't I paddle a mean canoe? Remember that hike on Grandad...**

Typical college recreation was also simpler 50 years ago, Mrs. Crook said. Trips with the glee club, school picnics, movies, Saturday afternoon football games...these were the major activities. Because 1928 was a prohibition year, the word "party" had different connotations from those of today. "Our social life usually centered around picnics and dances, or an occasional sundae at the Elite," she said. "I guess we were all pretty straight-laced."

There also were no dorms or student housing units. Students either lived with their families or stayed in private homes. Rules were rigid, and college curfews were observed. According to Mrs. Crook's husband, John, also a La Crosse alumnus, hours were firmly set at 10:30 p.m. weekdays and midnight on weekends. "There wasn't much time for cutting up," he noted.

Drug problems were apparently nonexistent among the class of '28. Even cigarettes were considered "taboo." According to Mr. Crook, some professors were known to become quite upset upon detecting "an air of tobacco in the room."

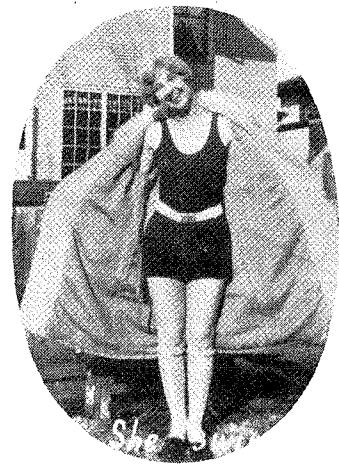
**I'll really miss our chats and giggling together after class...**

Perhaps one of the greatest changes among college students in the past 50 years, Mrs. Crook noted, has been their level of awareness. "Students in my class rarely discussed politics, economics or social problems," she said. "We usually talked about school, parties, teachers... things that were close to us. Our world was much smaller than it is today." With the growth of media coverage, modern young people are exposed regularly to current issues and controversial topics, she said. Consequently, they often come to question established social norms. "When we were young, we followed the rules that were set down for us. We respected what older people told us and usually followed their advice," she said. "Today there's more freedom, more questioning...and in some ways that's good."

**Dear Teacher!—Won't the kids have lots of fun in your class? You're lucky to get a job for next year...**



In the 1920's there weren't many career opportunities for women. Teachers, nurses and secretaries constituted the bulk of the female work force. Mrs. Crook decided to enter the field of elementary education as a result of both her love for children and the nearness of the college. At that time, La Crosse offered programs in primary, intermediate, high school, rural and physical education. After completing the two-year program, she accepted a job as a 5th-grade teacher in Wausau.



In 1928 the job market was fairly open for college graduates, she said. "We were probably more sure about our goals than kids are today." With current fluctuation in job demands, college students often change their majors numerous times before graduation, she said. "The future seemed more secure then. Our plans were set. Maybe that's why we enjoyed college so much."

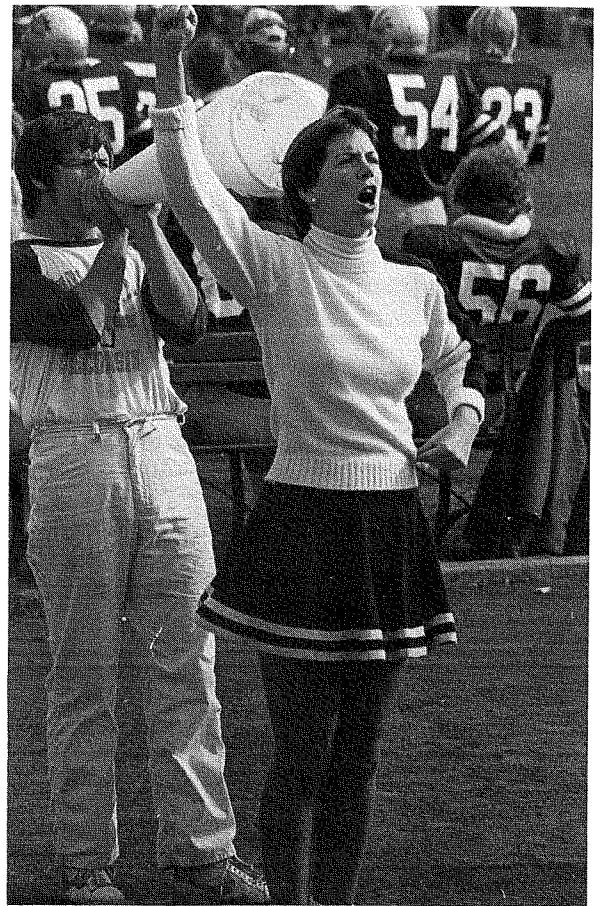
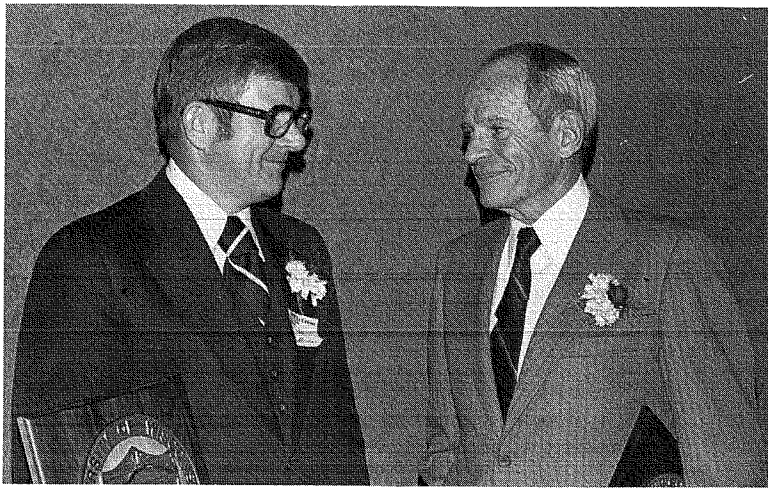

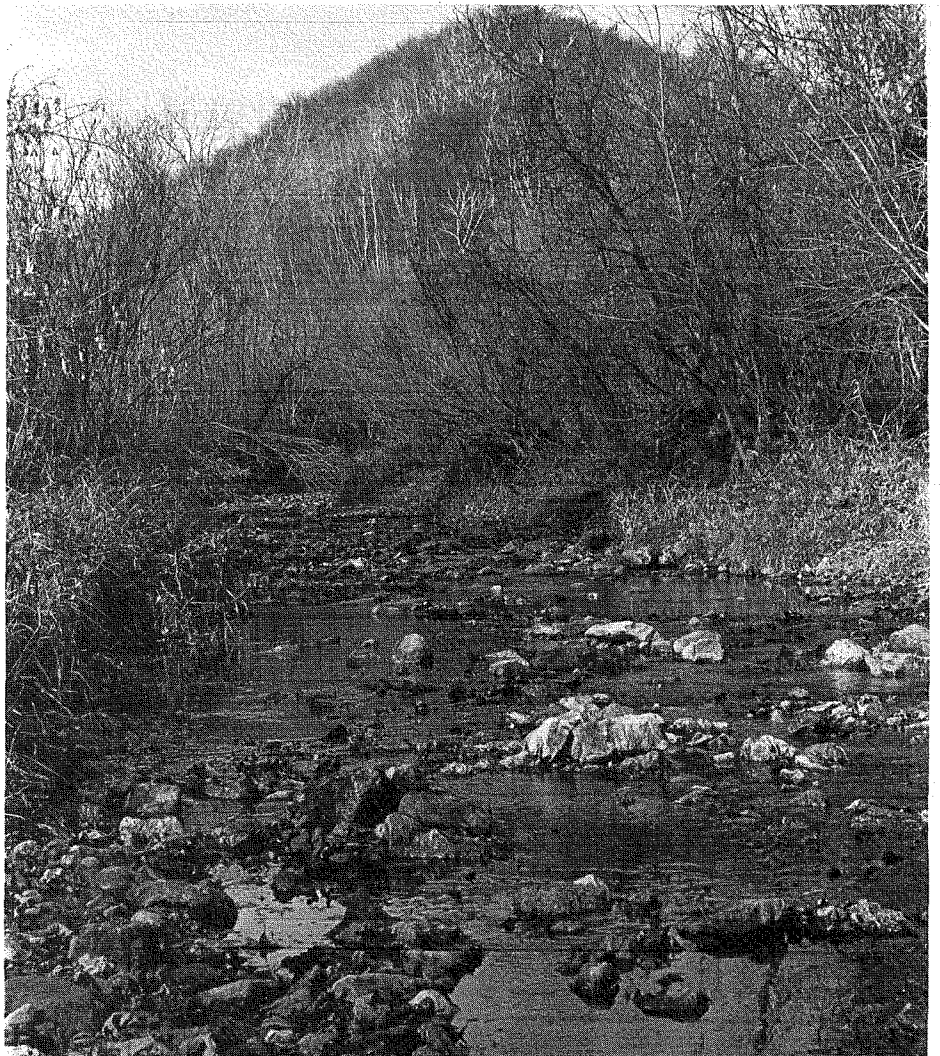
## University Purchases Farm

The UW-La Crosse Foundation announced recently the purchase of a 160-acre farm as part of an arboretum being developed by the University near Coon Valley.

The farm, purchased from the estate of Oscar Ophus and financed entirely through the Foundation's privately contributed funds, is directly above the 120-acre farm of Dr. and Mrs. Alf Gundersen. Last year the Gundersens arranged to give their farm to the University, to be known as the Helga Gundersen Memorial Arboretum.

There are three farms in the narrow valley, with the Gundersen farm located in the middle. UW-L biologists involved in the development of the arboretum saw the upper farm as being critically linked to the project, since it forms the watershed for the entire valley. Several springs on the property lead into a stream which flows through the middle farm. Any use of pesticides, fertilizers, or heavy livestock grazing on the upper farm could have had serious impact on the arboretum.

Chancellor Kenneth Lindner, who has supported the constructive uses of the arboretum since the beginning of the project, said that an important consideration in the purchase was the eventual enjoyment and knowledge students and persons in the Coulee Region would gain from the unspoiled property. "It will become a sanctuary as well as an arboretum," he said. "The University will open the area to school children, nature groups



and others who are interested."

UW-L previously appointed an arboretum committee to work with Dr. Gundersen. A specialist from the UW-Madison arboretum has also been involved in planning for the project.

The committee, chaired by Dr. James Warner of biology, has established guidelines for the facility's use by university and community classes and groups.

## Foundation Forms Legacy Guild

The UW-L Foundation has formed a new organization to recognize and honor those persons who make planned gifts to the University. It's called the **Legacy Guild**, and it's a symbol of the importance the Foundation places on the kind of commitment a planned gift entails.

According to Larry Dittman, executive director of the Foundation, there are seven forms of planned gifts which qualify for the Guild:

- \* a bequest provision in a will.
- \* an insurance beneficiary designation.
- \* charitable gift annuity.
- \* pooled income fund.
- \* revocable trust.
- \* charitable remainder trust.
- \* gift of future interest in a home or farm.

"You don't have to be affluent to make a planned gift," Dittman said. "It's surprising how inexpensive it can

be, and it does a world of good."

Members of the Legacy Guild will be able to receive a periodic newsletter, attend occasional meetings and promotional activities, and take part in an annual Legacy Day. Other activities are also being planned.

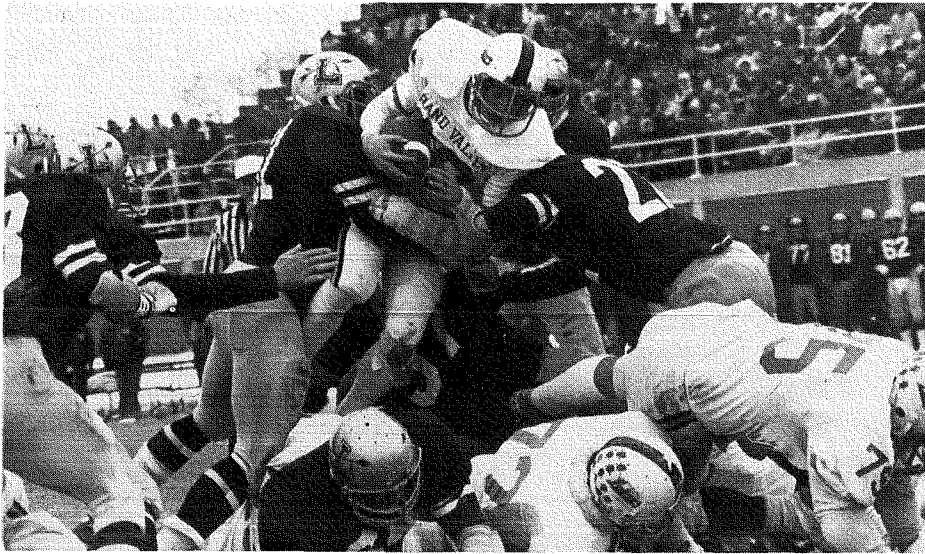

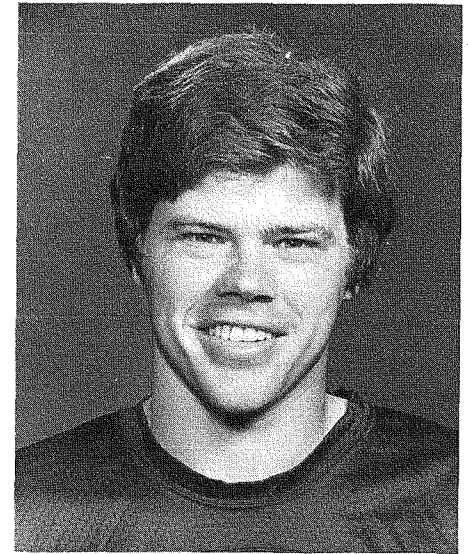

## Indians Gain Playoffs

For the second time in the ten years Roger Harring has been head coach of the University of Wisconsin-La Crosse football team, the Indians advanced to the National Association of Intercollegiate Athletics (NAIA) playoffs. The last time La Crosse saw post-season action was in 1973 when the Indians lost to Elon College of North Carolina in the opening round of competition.

This year the Indians were eliminated in the quarterfinals of the eight-team play-offs by Grand Valley State of Allendale, Mich. Grand Valley jumped out to a 21-7 first-half lead and held on to beat the Indians 24-14 at Memorial Field.

The Indians took the opening kickoff and drove 69 yards for a touchdown with Paul Radcliffe bursting over from six yards out. The Lakers came right back to tie the game at seven on a 38-yard pass from Dave Quinley to Rick VanEss. Then the Indian miscues began to make way for the Lakers. A fumble and an interception set up the next two scores for Grand Valley, giving them a healthy 14-point lead going into the second half.

The Indians came out on the field in the second half ready to take care of that deficit, but once again turnovers hampered the maroon offense.

La Crosse scored early in the fourth quarter on a Dave Draxler 14-yard pass to Dave Robinson to cut the Laker lead to seven. What could have been the tying touchdown took place on the following Laker possession. Indian defensive tackle Bob Fillinger grabbed a Grand Valley fumble and raced 44-yards for six points, but the play was called back because of a clipping penalty.

Grand Valley put the icing on the cake with a 37-yard field goal by Roger McCoy. The loss broke an eight game winning streak for the Indians.

La Crosse qualified for the play-offs by compiling a 9-1 record and winning a share of the Wisconsin State University Conference (WSUC) championship with Whitewater. The Indians' only loss of the season before the play-offs was to Whitewater in the second game of the year. The Indians were rated fifth in the final regular season NAIA poll.

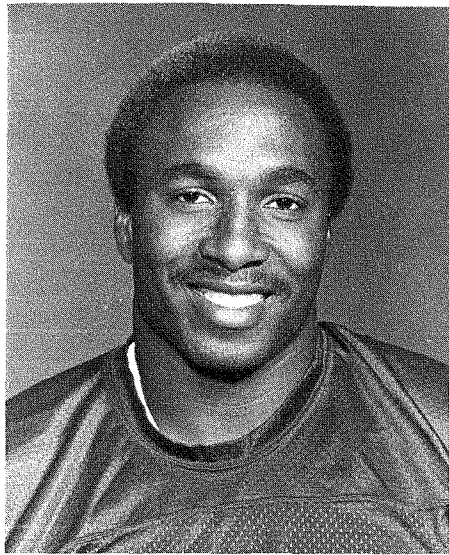

This past season the UW-L "greenies" had the honor of playing host to seven outstanding teams from throughout the Midwest as the Midwest Association for Intercollegiate Athletics for Women (MAIAW) 1978 Field Hockey Championship was held on the UW-L campus.

La Crosse was joined by Michigan State, Kent State, Indiana University, Davis & Elkins (West Virginia), Ohio State, University of Michigan, and Southern Illinois for the two day event.

Southern Illinois captured the team championship with a 1-0 victory over Davis & Elkins in the finals. La Crosse, coming back from a first round loss to Ohio State, defeated the University of Michigan and Kent State to take the consolation championship. First-year UW-L Coach Bobbi Testa said, "Winning the consolation championship is a real tribute to our team. The other players in the tournament are from schools that offer scholarships or are from states that offer field hockey in high school. Almost all our players had never played field hockey until they came to the university."

Interest in field hockey has grown in the past few seasons and will be included as an event in the 1980 Olympic games in Moscow. Summer camps are also gaining popularity across the United States.

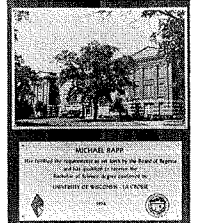
