FILLING OF A VACANCY IN THE OFFICE OF A DEPUTY MAYOR OF THE JAFFNA MUNICIPAL COUNCIL UNDER SECTION 65A(1) OF THE LOCAL AUTHORITIES ELECTIONS ORDINANCE (CHAPTER 262)

WHEREAS the office of Deputy Mayor in Jaffna Municipal Council has fallen vacant by reason of Resignation ;
