## **State Regent's Message**

Dear Massachusetts Daughters,

It was an honor to represent you at the 121st Continental Congress in Washington last month. There were twenty-seven Massachusetts members who attended Congress this year. There was a good turn out at the Massachusetts Hancock-Adams Open House. So many members across the country trace their ancestry to Massachusetts that there is much interest in the room and visitors love to hear the story about it. We had twenty-one Massachusetts Daughters attend the Junior Lunch. We filled two tables! We even had little Maeve McKeeman attend as our youngest prospective member.

As you will see in this issue, the Chapters have been doing some incredible work, with our NSDAR objectives and also with membership. We have fifty-seven new members and of those fifteen are Junior Members! There has been a huge influx in prospective member inquiries since the TV show, "Who Do You Think You Are?" aired in April. The show featured actor Rob Lowe and parts of it were filmed at DAR Constitution Hall.

The State Regent's Project is in its final design stages and scheduled for delivery August 18. Of special note is that the writers have changed the title of the book. It was originally to be called A Sailor's Life. The content of the book is the same, chronicling the lives of crewmembers serving on

USS Constitution during the War of 1812. The new (and more appropriate) title is *Men of Iron: USS Constitution's War of 1812 Crew*. Writer and Research Historian, Matthew Brenckle, will be our featured speaker at the Constitution Lunch of Friday, September 21. He will speak on the book and copies will be available for sale. Also each Chapter Regent who is present will receive three free copies of the book to distribute as the Chapter sees fit to students, schools or libraries in their area. Please plan to stay for the Chapter Officers' workshop also held on Friday, after the Constitution Lunch.

In this third, and final, year of the Administration, we will be focusing on Education. Donna Raymond, National School Chairman is our guest and keynote speaker at the banquet on September 21. Donna will speak about all six of the DAR Schools. Representatives from Hillside School will attend, and then some of the students from Hillside School will entertain us.

Our November Board of Management Meeting (open to all) will have "The Graveyard Girls" speak to us. Their program "Welcome to the Graveyard" will take us from colonial burial grounds up through the present, examining why we have cemeteries and gravestones and why they look like they do.

Lastly, and most important is the Lay Light Project. The members of MDAR have embraced this project and over \$24,000 has been donated so far. As a result, Massachusetts DAR members will be represented as the donor of ½ of a Lay Light. Since the State Regent's Project is now complete, all future donations should go to the Lay Light Project. Thank you Massachusetts Daughters for your generosity. You have left a legacy for the future of our Society. 


# **Captain Job Knapp Chapter**

## Lowell Parks & Conservation Trust Received National DAR Historic Preservation Award for Spalding House

The Old Concord Chapter honored The Lowell Parks & Conservation Trust (LP&CT) on February 15, 2012, with the highly selective National DAR Historic Preservation Award for their work in the protection and preservation of the Spalding House (c 1760). LP&CT, a private non-profit environmental group and land trust operating in Lowell, MA, was donated the Spalding House by the Molly Varnum Chapter of the DAR upon its disbandment in 1996. LP&CT has since been conducting a restoration and fundraising to continue its work, develop exhibits, expand the house's endowment, and complete landscaping. The home will eventually be open as an urban environmental history center with access by boat through national park programming and other partners. "In preserving and restoring the Spalding House located at 383 Pawtucket St, Lowell, the LP&CT has demonstrated a significant commitment to preserving our historic heritage right here in Merrimack Valley and Concord River watersheds," said Kimberly Whitworth, Regent, Old Concord DAR. She was impressed by the care and attention to detail they exhibited in their restoration of this Revolutionary Era house and their efforts to preserve the DAR presence in the house. Stephen Conant, LP&CT co-founder and past president said, "It is a great honor to be recognized for our historic preservation work by the DAR, an organization that has done so much for historic preservation in this country. In truth, our work only continues the work begun to preserve the Spaulding House by the Molly Varnum Chapter of the DAR in 1896 and most recently, by its last Regent, Helen Whiting. I'm sure Helen is looking down on us with a smile knowing that we've been honored in this way."



## Pow-Wow Oak

The now disbanded Molly Varnum Chapter originally erected this sign, located on Clark Road in Lowell, MA, in the 1930's. It commemorated the ancient oak tree and the Minute Men who passed it on their way to Lexington and Concord. The sign fell into disrepair and with the fundraising efforts of the Old Concord Chapter, City of Lowell and local organizations; it was restored to as close to its original condition as possible.

The sign, restored by the Hammersmith Studio of Concord, was reinstalled in May to remind people about the Revolutionary history that took place on Clark Road in 1775.

War when he was 17 and completed seven years of service. Martha was born 1803, taught school for many years and married Rev. Caleb Kimball. She died at her home in Medway 1898 at the great age of 95 years. 

## President General's Lay Light Project

The President General's Project encompasses three vital initiatives of the Daughters of the American Revolution, which for more than a century has worked to promote historic preservation, education and patriotism. The project's three-fold undertaking involves the ongoing restoration of our historic DAR Headquarters complex, strengthening membership through support and training, and the implementation of a financial grant program benefiting projects that further the DAR mission in local communities.

After the earthquake hit Washington last summer, a thorough evaluation of the DAR building was undertaken and it was discovered that the lay lights were in danger of crashing to the floor. The preservation team composed of experts in historic preservation contracting, architectural design, structural engineering and leaded glass work identified a number of serious problems that only a comprehensive rehabilitation and restoration of the lay light could resolve. Restoring these lights became the priority of the current President General and our own State Regent. Each of the 25 light panels measuring approximately 9x8 feet will have to be removed and restored. The estimated cost of repairs is \$1.6 million. The DAR plans to restore the lay light with the highest standards of historic preservation and safety.

Support from the membership and public will help ensure that generations of future visitors will be able to appreciate the breathtaking DAR Library lay light. Please consider donating what you can. ### Young America Takes a Stand: The War of 1812

Andrew, George, John...BOYS! Do stop fighting.

Oh, you say you are pretending to be soldiers?

Would you like to learn something about the war that happened? between 1812 and 1814?

Boys, please don't grumble. You must know, to fight alone is ill, but to fight without knowledge is even worse. Gather round, all of you. I assure you that you will like this lesson. I will tell you about one of the many heroes produced in that war, Francis Scott Key.

No George, he was not famous for being a soldier. Fighting is not the only powerful thing, children. Words may hold more Power than you ever knew. Now let's begin.

It was a September night. I was a young man at the time. My friend Francis, a young, respected, American lawyer, wrote a song about a ferocious battle. The song was liked and sung by many.

Let me refresh my memory about the history of the war. It was a truly difficult time. First, France became very aggressive and wanted to control Europe, especially England, their long-time enemy. They tried to block off all trade between England and other countries. This angered England, causing them to take revenge by declaring a blockade of all ports owned by France. In the beginning, the U.S. did not want to take sides in this conflict. However, that caused American trade to suffer. France would not allow the Americans to stop at British ports, while the British demanded the Americans pay fees whenever they traded with the French. It was not easy for the sailors to be caught in the middle. Soon the conflict became more intense. The British military started to forcibly board American trade ships, claiming to look for British deserters. They said they just wanted to take back British sailors but it was not always the case. American citizens were often captured. It was very horrible indeed. Sue enough, some voices in the Congress wanted a war, and the President, James Madison, listened after much debate. America declared war on Great Britain on June 18, 1812.

Now children, let's go back to Francis. We can hardly say we have even begun the story.

There were terrible rumors flying about Baltimore. Soon everyone knew the story: Dr. William Beans, an elderly man, had been carried off by the British, and could possibly be hung! The people of Baltimore came running to dear Francis for help. On one September morning, Francis and American Prisoner Exchange Agent Colonel John Skinner went to negotiate the release of Dr. Beans. James Madison himself approved of the plan. I the morning light, Francis and John Skinner sailed off, under a flag of truce; to try to save Dr. Beans from the horrible fate the British might hold for him.

When Francis and John Skinner reached the British fleet, it was already on its way to attack Baltimore. Francis and John convinced Admiral Cockburn to let Dr. Beans go. Little did they know that Cockburn has already decided not to hang him. Nonetheless, they encountered another problem. Cockburn wouldn't let them go back to shore and, well, children, in all fairness, would you let the enemy go to warn the village that you were going to bombard?

When the time came to attack, Francis watched anxiously from the *President*, the truce ship he arrived in. From midnight to the morning, Francis knew little of the fight. Poor Francis couldn't see much through the smoke and darkness. My old friend paced the decks of the *President*, driven out of his mind with worry. Still, the little comfort he had was knowing that as long as there was still bombing and smoke, America had not yet given up. Joy was brought to him at that thought, even though he knew nothing of his countrymen's fate.

Back on land, many of Francis's friends were also very worried. Had Dr. Beans, Francis, and John Skinner been hung? In the battle, had any of them been injured? They were as blind to Francis, Dr. Beans, and John's fate as Francis was to theirs.

Dawn came. By the morning light, Francis saw the American flag still waving. Even after the brutal bombing, the Americans had not given up. Francis, overwhelmed with what he had just witnessed, began to write on the back of a paper in his pocket. Those words, jotted down on the back of the paper, became the lyrics to "The Defense of Fort McHenry", also known as "The Star Spangled Banner". Francis's song was very popular. People began to sing it. It was set to the tune of "Anacreon in Heaven".

"The Star Spangled Banner" is valuable in America. During the War of 1812, there were many losses, and "The Star Spangled Banner", a very patriotic song, helped boost countless soldiers' spirits. If the soldiers were depressed with their many losses, then they might not have had as many wins. "The Star Spangled Banner", believe it or not, may have helped make the outcome of the war what it was.

Children, I think this draws our story to a close. I don't want to keep you out too long. However, I hope you understand that words have power. Just like soldiers had songs to cheer them on, you need support in most things you do. You can't always do it alone. Francis and John worked together to free Dr. Beans, and the army worked together to defend Fort McHenry. I hope you will remember that. Don't give me that look, James. It is a valuable thing you should know.

#### Article XI Fiscal Year, Dues and State Funds

#### Current

Section 3.a. The Fund shall be expended by the State Board of Management for the operating expenses of the corporation.

#### Proposed

Section 3.a. The Fund shall be expended by the State Board of Management for the operating expenses of the corporation **and the objectives of the society**.

## Rationale

To make it clear we are financially supporting our objectives.

## The Rationale for the following three proposed Bylaw amendments is:

- 1. Bookkeeping for the State Treasurer will be simpler to have our Fiscal Year match the National Fiscal Year which is changing effective January 1, 2013.
- 2. Tax return preparation will be simpler with the Fiscal Year and calendar year matching.
- 3. With Master Questionnaire and Chapter Achievement reports changing to the calendar year it will make it easier if we have our financial reports to National on those forms.

#### **Article XI Fiscal Year, Dues and State Funds**

The following is for informational purposes only. The bylaw is being changed to follow the wording of Chapter bylaws as mandated by the National Society and therefore requires no vote.

#### **Article XIII Disbandment of Chapters**

#### **Current**

Section a.b. Any monies in the treasury of the Chapter at the time of disbandment shall be given to projects of the National Society of the Daughters of the American Revolution and/or the Massachusetts Daughters of the American Revolution, Inc, selected and authorized by a majority of the members present and voting.

## **Updated**

Section a.b. Although the period of duration of the chapter is perpetual, if for any reason the chapter is to be dissolved or otherwise terminated, no part of the property of the chapter or any of the proceeds shall be distributed to or inure to the benefit of any of the officers or members of the chapter. Upon the dissolution of the chapter, assets shall be distributed by the Executive Board to and only to the state organization.
