

Freed slave, patriot honored in Pike Co. memorial ceremonies

On January 30, Wilkes County patriot Austin Dabney was honored at a grave dedication sponsored by The Sons of the American Revolution. Austin Dabney was honored as a freed slave and patriot of the American Revolution – one of the few slaves recognized to date. The ceremony took place at the Dabney-Harris Cemetery in Zebulon in Pike County.

"The story of Austin Dabney touches your heart," said Washington Mayor Willie Burns. "Austin was a Patriot who fought at the Battle of Kettle Creek and the Battle of Augusta. His wounds left him crippled for life. The Harris family cared for him during his recuperation and a lifelong bond developed. The son of Giles Harris was named for Austin and Austin and Giles are buried side-by-side." SAR Member Bob Galer noted during the ceremonies that Austin Dabney is the first black patriot to be recognized in Georgia with a grave dedication ceremony. The pres-

ence of National SAR Genealogist General Joe Dooley underlined the national stature of this ceremony.

The story of Austin Dabney was told by Robert S. Davis, M.Ed., M.A. of Wallace College, who is considered the world expert on the Battle of Kettle Creek. His concentration on this Battle has spanned over thirty years.

Another highlight of the grave dedication was the talk of Genealogist General Joe Dooley, who spoke of a print brought from the SAR National Office showing George Washington crossing the Delaware and drawing attention to the black

Tourism director lobbies legislature to bring more tourism jobs to Wilkes Co.

Wilkes County Tourism Director jobs here." Ashley Barnett joined members of the Georgia tourism industry in speaking to state legislators last Tuesday about the vital role tourism plays in jobs for rural Georgia.

"We were there to celebrate the significant role that tourism, the state's second largest industry, plays in Georgia's economy," she said. "While we were there, we got to meet with Lieutenant Governor Casey Cagle and talk with him about how absolutely vital tourism is for iobs and businesses in Washington and Wilkes County, and what's in the next state budget that could help us bring more tourists and tourism

The state's latest figures indicate

that tourism in Wilkes County alone carries a \$2.3 million annual payroll, she said.

Stressing that tourism is a \$28 billion industry in Georgia, Barnett and other regional tourism representatives used the 2010 Tourism Day at the Capitol to speak with many senators and representatives about the importance of tourism. "Senator Bill Jackson and Rep. Lee Anderson were excited to see all of us from their districts," she said. "Rep. Mickey Channel was tied up in session and in hearings, but he knew we were there and was glad

to know we were there representing our county. We wanted to make sure our representatives knew that tourism is the second-largest industry in Georgia."

Seven representatives from Wilkes County's tourism region, the Classic South Travel Association, were there to set up a booth in the capitol to promote tourism in the region. "It was a lot of fun," she said. "Seven of us went to the offices of every representative and senator representing our 18 counties to remind them how vital their support of tourism is, and about the importance of funding tourism and economic development promotions."
