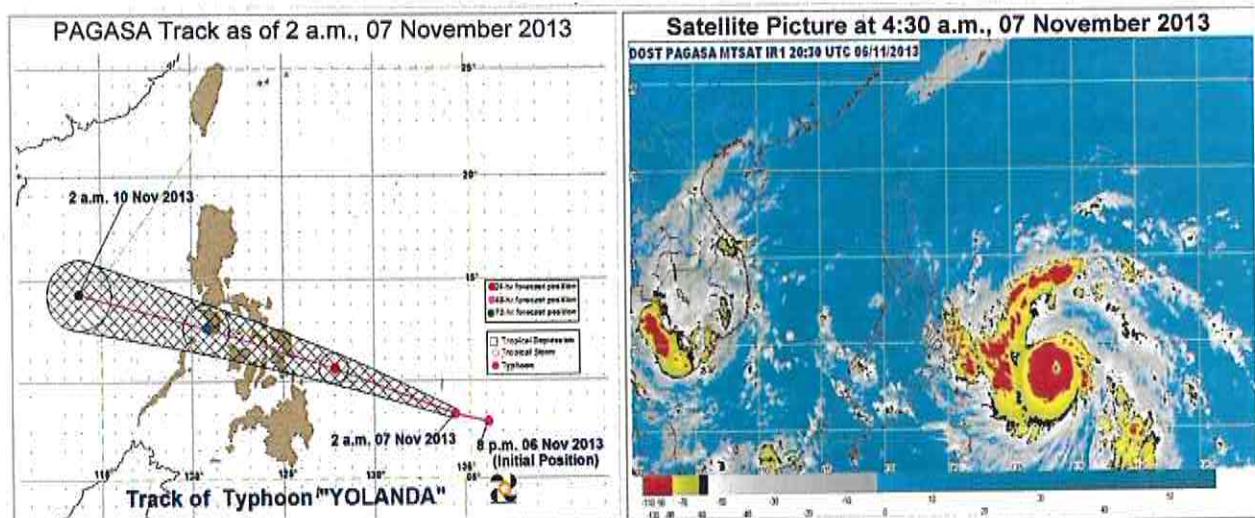
SUBJECT : Severe Weather Bulletin No. 02 re Typhoon "YOLANDA" (HAIYAN)

I. SITUATION OVERVIEW:

Typhoon "YOLANDA" has intensified further as it continues to move west northwest towards Eastern Visayas.



Location of Center: (as of 4:00 a.m.)	822 km East of Hinatuan, Surigao Del Sur
Coordinates:	8.4°N, 133.8°E
Strength:	Maximum sustained winds of 215 kph near the center and gustiness of up to 250 kph
Movement:	Forecast to move West Northwest at 30 kph
Forecast Positions/Outlook:	<p><i>Friday morning:</i> 240 km East Southeast of Guiuan, Eastern Samar</p> <p><i>Saturday morning:</i> Vicinity of Romblon Island</p> <p><i>Sunday morning:</i> 740 km West Northwest of Coron, Palaw</p>

- Estimated rainfall amount is from 10.0 - 30.0 mm per hour (Heavy - Intense) within the 600 km diameter of the Typhoon.
- Sea travel is risky over the eastern seaboard of Southern Luzon and Eastern Visayas.

You are hereby directed to monitor the situation and undertake precautionary measures in your area of responsibility (AOR). Likewise, the public and the Disaster Risk Reduction and Management Councils (DRRMCs) are advised to take appropriate actions.

In order to better inform/warn communities, you are reminded to disseminate these through local/community leaders and through your local media, including community radio stations. Conduct press briefings as often as needed. This local effort will complement and reinforce efforts at the national level. Emphasis should be on proactive actions – evacuation rather than rescue.

Let us untiringly aim for zero casualties.
