

# **Brian L. Roberts** **Chairman & CEO** **Comcast Corporation**



Brian L. Roberts is Chairman and CEO of Comcast Corporation, one of the nation's leading providers of entertainment, information and communication products and services. Under his leadership, Comcast has grown into a Fortune 100 company with 23.6 million customers and about 100,000 employees. Comcast's content networks and investments include E! Entertainment Television, Style Network, Golf Channel, VERSUS, G4, PBS KIDS Sprout, TV One, 11 regional sports networks operated by Comcast Sports Group and Comcast Interactive Media, which develops and operates Comcast's Internet businesses, including Comcast.net. The Company also has a majority ownership in Comcast-Spectator, which owns two professional sports teams, the Philadelphia 76ers NBA basketball team and the Philadelphia Flyers NHL hockey team, and a large, multipurpose arena in Philadelphia, the Wachovia Center, and manages other facilities for sporting events, concerts and other events.

Mr. Roberts is a member of the Board of Directors of the National Cable and Telecommunications Association (NCTA) where he served as Chairman for two consecutive terms from 2005 to 2007. He also served as NCTA's Chairman from 1995 to 1996 when the landmark deregulatory 1996 Telecommunications Act became law. Mr. Roberts is serving his third term as Chairman of CableLabs, the research and development consortium for the cable industry. He previously served as their chair from 2003 to 2005 and 1999 to 2001. Mr. Roberts is a member of the Business Roundtable, a CEO only organization based in Washington, D.C.

Mr. Roberts has won numerous business and industry honors for his leadership. In 2009, Institutional Investor magazine named him as one of America's top CEOs for the sixth year in a row, and named Comcast one of America's most shareholder-friendly companies for the fourth year in a row. In 2008, he was recognized by Big Brothers Big Sisters for his outstanding leadership in the community and for serving as a role model to youth. In May 2007, he was presented with the cable industry's highest honor, the National Cable and Telecommunications' Vanguard Award for Distinguished Leadership. In October of 2006, he was inducted into the Cable Television Hall of Fame. In 2005, he was honored by the National Association for Multi-Ethnicity in Communications (NAMIC) for his commitment to diversity in the cable industry, and by the Partnership for a Drug-Free America (PDFA) for Comcast's unprecedented commitment of resources to champion the PDFA's drug-free message. He also was the recipient of the 2004 Humanitarian Award from the Simon Wiesenthal Center. In 2003, Mr. Roberts was awarded the Steven J. Ross Humanitarian Award by the UJA Federation of New York. In 2002, he was honored by The Police Athletic League of Philadelphia for his commitment to youth programs and community partnerships.

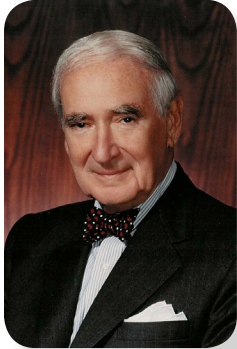
Mr. Roberts co-chaired the 2003 Resource Development Campaign for the United Way of Southeastern Pennsylvania and was a founding co-chair of Philadelphia 2000, the nonpartisan host committee for the 2000 Republican National Convention. An All-American in squash, he earned a gold medal with the U.S. squash team in 2005 and silver medals at the 1981, 1985, 1997 and 2009 Maccabiah Games in Israel.

# Ralph J. Roberts

## Founder and Chairman Emeritus

### Comcast Corporation



Ralph J. Roberts founded Comcast Corporation, one of the nation's leading providers of entertainment, information and communication products and services, with the purchase of a 1,200-subscriber cable television system in Tupelo, Mississippi in 1963. From Comcast's humble roots, Mr. Roberts went on to create a company that today serves 23.6 million customers and employs about 100,000 people. Today, he is Founder and Chairman Emeritus of the Company's Board of Directors, and his son Brian serves as Chairman and CEO.

Prior to starting Comcast, Mr. Roberts was President and CEO of Pioneer Industries, a leading men's clothing accessories company, Vice President of Muzak Corporation, and an account executive with Aitken Kynett Advertising Agency.

Mr. Roberts graduated from the Wharton School of the University of Pennsylvania and served a four-year tour of duty in the U.S. Navy. He also participated in continuing education programs at Harvard Business School.

Mr. Roberts, 89, is involved in numerous community and civic activities. He currently serves on the boards of the Council of Emeritus Directors of the Philadelphia Orchestra and the Brandywine Museum and Conservancy, as well as the Advisory Board of the Greater Philadelphia Urban Affairs Coalition, and the Penn Medicine Board of Trustees, University of Pennsylvania Health System.

His business, entrepreneurial and humanitarian endeavors have brought him many awards including the Distinguished Vanguard Award for Leadership from the National Cable and Telecommunications Association; induction in the Broadcasting & Cable Hall of Fame; the Cable Television Hall of Fame Award; and the Walter Kaitz Foundation Award for contributing to the cable industry's diversity efforts. He received the University of Pennsylvania's Joseph P. Wharton Award, and the conferral of a Doctor of Humane Letters by Holy Family College.

He was honored by the Anti-Defamation League of B'Nai B'Rith with its Americanism Award and by the National Conference of Christians and Jews with its Brotherhood Award. He has also received Philadelphia's Edward Powell Award given to the individual whose efforts most benefit the prosperity of the city of Philadelphia; the Police Athletic League Award; the Urban League of Philadelphia's Whitney M. Young Jr. Award for Leadership, Diversity and Excellence; the William Penn Award given by the Greater Philadelphia Chamber of Commerce; the Trustees Award from the National Academy of Television Arts & Sciences; and (jointly with his son Brian) the Steven J. Ross Humanitarian Award given by the UJA Federation.

**Stephen B. Burke**  
**Chief Operating Officer, Comcast Corporation**  
**President, Comcast Cable Communications**



Steve Burke joined Comcast in 1998 as President of Comcast Cable and has been a driving force in the Company's growth from a cable industry leader to one of the nation's leading providers of entertainment, information and communication products and services. Under Mr. Burke's leadership, Comcast has become the largest cable company, largest residential internet service provider, third largest phone company in America and recently launched a wireless business. In addition to overseeing the Company's products and services, Mr. Burke oversees Comcast's programming networks, advertising and Comcast Interactive Media.

Since his arrival at Comcast, Mr. Burke has led Comcast to leadership in multiplatform video entertainment distribution, including the Company's industry changing video on demand platform and online video offerings. Comcast's On Demand service, which was introduced in 2003, now offers more than 17,000 choices a month and has had over 14 billion customer views since launch. Mr. Burke has been praised for leading the highly successful integration of AT&T Broadband with Comcast.

Before joining Comcast, Mr. Burke served with The Walt Disney Company as President of ABC Broadcasting. Mr. Burke joined The Walt Disney Company in January 1986, where he helped to develop and found The Disney Stores. In 1992, he moved to Euro Disney S.A., where, as President and Chief Operating Officer, he helped to lead a comprehensive restructuring effort.

Mr. Burke serves on the Board of Directors for Berkshire Hathaway Inc. and J.P. Morgan Chase & Co., and he is the Chairman of The Children's Hospital of Philadelphia – rated the #1 children's hospital by U.S. News & World Report in 2009.

Mr. Burke, 51, is a Phi Beta Kappa graduate of Colgate University and earned an MBA from the Harvard Business School. He lives in Haverford, PA, with his wife and five children.

# David L. Cohen

## Executive Vice President

### Comcast Corporation



David L. Cohen is Executive Vice President of Comcast Corporation, one of the nation's leading providers of entertainment, information and communication products and services. Mr. Cohen has a broad portfolio of responsibilities, including corporate communications, government affairs, public affairs, corporate administration, and serves as senior counselor to the CEO. Before assuming this position in July of 2002, Mr. Cohen served as a partner in and Chairman of Ballard Spahr Andrews & Ingersoll, LLP, one of the 100 largest law firms in the country.

A native of New York, Mr. Cohen graduated from Swarthmore College in 1977 with a BA and with a JD from the University of Pennsylvania Law School (summa cum laude) in 1981. From January 1992 to April 1997, Mr. Cohen served as Chief of Staff to the Honorable Edward G. Rendell, the Mayor of the City of Philadelphia. As detailed in the book *A Prayer for the City*, written by Pulitzer-Prize winning author Buzz Bissinger, Mr. Cohen played a critical coordinating role in significant budgetary and financial issues, in economic development activities, in collective bargaining negotiations, and in a wide variety of other policy and operational issues relating to the city.

Mr. Cohen serves as Chairman of both the Board of Directors and the Executive Committee of the Greater Philadelphia Chamber of Commerce, and as a member of the CEO Council for Growth. Mr. Cohen also serves as Chairman of the Trustees of the University of Pennsylvania and its Executive Committee. Mr. Cohen also serves as a member of the Trustee Board and the Executive Committee of Penn Medicine (an umbrella governance structure overseeing both the University of Pennsylvania Health System and the University's School of Medicine). Mr. Cohen serves as a national trustee of City Year and is Chair of the Governance Committee and a member of the Executive Committee. He also serves on the national board of the National Urban League and as a member of the Corporate Advisory Board of the National Council of La Raza. In addition, Mr. Cohen serves as the Vice Chair of the Board of Directors of the Jewish Federation of Greater Philadelphia. Mr. Cohen is a former Chair of the United Way of Southeastern Pennsylvania, former Co-Chair of the 2003 Resource Development Campaign for the United Way of Southeastern Pennsylvania, former Chair of the Southeastern Pennsylvania Chapter of the American Red Cross, former Co-Chair of Philadelphia 2000, the Host Committee for the 2000 Republican National Convention, and the former Co-Chair of the Host Committee for the National Conference of Volunteerism and Service.

Mr. Cohen has received numerous awards for his civic and charitable activities, including the Americanism Award of the Anti-Defamation League (1993), the Philadelphia Commission on Human Relations Clarence Farmer Service Award (1997), the Community Legal Services Champions Award (1997), the Philadelphia Bar Medal (1997), the Variety Club Gold Heart Humanitarian Award (1998), the Philadelphia Hospitality Vision for Philadelphia Award (1999), the American Red Cross Citizen of the Year Award (1999), the Police Athletic League Award (2001), the United Way's Citizen Volunteer of the Year Award (2002), the City Year Philadelphia Lifetime of Idealism Award (2004), National Cable Television Association, Vanguard Award for Leadership and Impact in the Cable Industry (2005), the American Red Cross Celebration of Volunteers Award (2006), the Association of Cable Communicators President's Award (2007), the President's Volunteer Service Award (2007), MS Society Hope Award (2007), the Drexel Business Leader of the Year Award (2008), the National Urban League of Philadelphia Business Leader of the Year Award (2008), the Philadelphia Business Journal Minority Business Leader Award (2009), and the Annual Northwest Philadelphia Community Appreciation Awards Trailblazing Footsteps Award (2009). Mr. Angelakis is a graduate of Babson College and the Owner/President Management Program at the Harvard Business School. He serves as a Trustee of Babson College and is on the board of Big Brothers Big Sisters of America.

Comcast's programming assets include the Comcast Entertainment Group, comprised of E! Entertainment Network, Style Network, G4, and FEARnet; Golf Channel, PBS KIDS Sprout, VERSUS, TV One, International Channel networks, and Comcast Sports Group who operates 11 regional sports networks. Under Mr. Shell's leadership, Comcast's networks have grown in viewership and distribution and have successfully struck programming deals with national partners including The National Hockey League, Tour de France, The PGA, College Football, The Wiggles and Ryan Seacrest Productions.

Prior to joining Comcast, Mr. Shell was CEO of Gemstar TV Guide International where he successfully navigated Gemstar through a number of legal and operational challenges. Before joining Gemstar, Shell held a number of positions within News Corporation including President of the FOX Cable Networks Group, where he oversaw the operations of FOX's entertainment and sports cable programming businesses including FOX Sports Net, FX and the National Geographic Channel. Shell also worked in the Strategic Planning Group at the Walt Disney Company and at Salomon Brothers Inc.

Shell received his Bachelor of Science degrees in Economics and Applied Mathematics from the University of California, Berkeley and his MBA from Harvard University. He currently serves on the Board of several non-profit organizations, including Green Dot and Big Picture Philadelphia.
