# **SCOPE/CONTENT**

The collection consists of travel sketches, project drawings and financial records associated with New Orleans architect James Freret, dating from 1826-1902. Documentation is divided into three series, based on record type and format. The second series is divided into three groups based on project classification.

The first series comprises two sketchbooks and over 70 single-sheet sketches documenting Freret's travels in Europe (1860-1861), where he was studying architecture under the tutelage of Charles-Auguste Questel. Sketches primarily represent English, French and Italian architectural projects and ornamental features, including stained glass windows and stairways. A few pencil sketches relate to Midwest travels to Chicago, Illinois and St. Louis, Missouri in 1891.

The second series consists of project drawings associated with James Freret's New Orleans architectural practice in the Central Business District, dating from 1862-circa 1897. Projects are divided into three groups based on building type: residential; religious/commercial; and institutional. Many of Freret's residential drawings were created on spec, and thus most convey neither client nor location. They vary considerably, from simple camelback structures to multistory mansions with parterre gardens.

Financial records, the third series, cover the widest date range, from 1826-1902. Earliest documents in the collection relate to ancestral land holdings on Poydras Street. Investments on the part of the Freret Brothers are included in this series, as are records associated with James Freret's estate.

Researchers interested in Americans participating in the Grand Tour, post-Civil War reconstruction, residential and religious architecture of the late nineteenth century and the Freret family of New Orleans will be especially drawn to this collection.

# HISTORY/BIOGRAPHICAL NOTE

James P. Freret (1838-1897) was born in New Orleans, the son of cotton broker / sheriff James Peter Freret (†1869) and Livie D'Arensbourg. He studied at Jesuit College and obtained early training in the New Orleans architectural office of Scottish immigrant George Purves (†1888) and then for his older cousin William A. Freret before studying with Charles-Auguste-Questel (1807-1888) in Paris (1860-1861).

The Civil War prompted Freret's return to North America in 1862. He successfully penetrated the Charleston blockade and enlisted in the Confederate engineer corps. Wounded in the Siege of Port Hudson, Louisiana, Freret was captured, released and returned to New Orleans. He opened his architectural office there in 1865 and first garnered acclaim for his completion of the Moresque building, originally begun by William A. Freret in 1860. His design for the high altar of New Orleans' Jesuit Church won first prize at the *Exposition universelle d'art et d'industrie* in Paris

(1867-68) and his exhibition buildings for the Mechanics' and Agricultural Fair Association of Louisiana, located on Gentilly Road and Esplanade Avenue, also received public notice (1868).<sup>2</sup>

The 1870s proved to be an especially productive period for Freret, in which he completed a threestory office building for the New Orleans Gas Light Company, the Saint Charles Borromeo church in Grand Coteau and developed plans for the Jesuits' mortuary chapel in St. Louis Cemetery No. 1. His extant drawings include multiple single-family residences and tenement structures, including a number of camelback structures. In 1878 Freret collaborated with architect-surveyor J.A. D'Hemecourt to design a catafalque and funerary cart for the recently deceased Pope Pius IX, whose obsequies were celebrated in the Crescent City.

During the 1880s, Freret designed the new Convent of the Perpetual Adoration, located in Scranton, Mississippi along the Louisville and Nashville Railroad line.<sup>3</sup> He also provided architectural renderings to the Lhote Sash, Blind & Door Factory for use in its 1883 *Buyers' Guide*. These drawings suggested ways in which to utilize specialized millwork to adorn religious and residential buildings. Temporary architecture proved an intermittent mainstay of his career: his collaboration with carpenter J.A. Sicard & Son to design and outfit exhibits at the 1884 Cotton Centennial Exposition in New Orleans was advertised in *The Daily Picayune*.

Seriously wounded during the Civil War, Freret continued to suffer health problems. Sickness forced him to close his architectural office for several months in 1885 and he succumbed to heart disease in 1897. Architects who trained in his office included his son-in-law Charles Allen Favrot, Rob Roy Bayhi, Louis A. Livaudais (1870-1932) and his own daughter, Helena (†1944).<sup>4</sup>
