#### Directions to the Samoset Resort

From Portland, ME: (90 mins.)

95 North to Falmouth Exit 52 to Route 295 North to Topsham Exit 31 to Rt. 1 North. Turn LEFT on Rt. 90 (Warren) and follow until it reconnects with Rt. 1. Turn RIGHT at this light onto Rt. 1 south. At this point you are 4 miles north of the Samoset. Follow Rt. 1 south, At the fifth light turn LEFT onto Waldo Avenue, you will pass Home Depot on the right and Walmart on the left. (Tim Horton's is on the right at the fifth light) The Samoset entrance road is ½ mile down Waldo Avenue on the RIGHT.

From Augusta, ME: (45 mins.)

Route 17 East approx. 41 miles, when Route 17 meets Route 1 turn left (McDonald's on left), onto Route 1 North. 1/3 mile down turn right at the light onto Waldo Avenue (Littlefield Baptist Church) 1/2 mile on Waldo Avenue to the Samoset Resort entrance.

From Bangor, ME: (75 mins.)

Route 1A South to Route 1 South through Belfast and Camden, 7 miles beyond Camden and 1 mile beyond Penobscot Bay Medical Center, turn left onto Warrenton Street just past the Glen Cove Rest Area, 1 mile on Warrenton Street to the Samoset Resort entrance.

## Keynote Speakers



**Shenna Bellows**

Shenna Bellows has served as the Executive Director of the Maine Civil Liberties Union since March of 2005. She returned home to Maine, where she grew up, after spending two years as a National Field Organizer at the ACLU Legislative Office in Washington, D.C.

In Washington, Shenna was a leader in post-9/11 issues, developing a field program around the Patriot Act, as well as working to defeat several constitutional amendments that would have undermined the criminal justice system, freedom of speech, and LGBT rights. Prior to joining the ACLU family, Shenna served as an AmeriCorps VISTA volunteer in the position of Program Associate at Community IMPACT! in Nashville, TN, launching neighborhood-based, youth-centered programming in economically and racially diverse neighborhoods. She also served in the Peace Corps in La Arena de Chitre, Panama, where she facilitated the development and execution of a micro-credit lending program for artisan groups. From 1997 – 1999 Bellows worked as a researcher and recruiter for Economists Incorporated, a privately held economic consulting firm specializing in microeconomic analysis in antitrust, regulatory and legal contexts in Washington, DC.

Shenna is active in the Maine Immigrants Rights Coalition, the Maine Choice Coalition, and the Maine Freedom to Marry Coalition.

She graduated magna cum laude from Middlebury College in Vermont with a degree in International Politics and Economics.

### **Keynote Address: Social and Economic Justice**



**Kim Strom-Gottfried, PhD, LISW**

Kim Strom-Gottfried received her BSW from the University of Maine, her MSW from Adelphi University and her Ph.D. from Case Western Reserve University. She is the [Smith P. Theimann Jr.](#) Distinguished Professor of Ethics and Professional Practice at the University of North Carolina, Chapel Hill, where she teaches in the areas of direct practice, communities and organizations, and human resource management. Dr. Strom-Gottfried is an active scholar, trainer, and consultant in the field of ethics. She has written numerous articles, monographs and chapters on the ethics of practice. She is the author of *Straight Talk about Professional Ethics and The Ethics of Practice with Minors: High Stakes and Hard Choices*. Dr. Strom-Gottfried is also the co-author of the texts *Direct Social Work Practice and Teaching Social Work Values and Ethics: A Curriculum Resource*. Dr. Strom-Gottfried currently holds an appointment as the UNC Institute for Arts & Humanities Associate Director for the Academic Leadership Program, which helps prepare and support the next generation of academic leaders.

### **Keynote Address: Moral Courage**

From baseball fields to board rooms, the daily news is filled with examples of lapses in ethical conduct. Many of today's scandals were years in the making. How did they get this far without anyone standing up to say, "This is wrong"? Could well-intentioned people, acting with moral courage, have affected the course of events before they got out of hand?

In all walks of life, ethical challenges arise not in *knowing* the right thing to do, but in *doing* the right thing under adverse circumstances in a corrupt organizational climate or amid a risk to one's livelihood. Yet without the courage to stand for those standards we value, what meaning do the standards have?

From baseball fields to board rooms, the news is filled with examples of lapses in ethical conduct. Many of today's scandals were years in the making. How did they get this far without anyone standing up to say, "This is wrong"? Could well-intentioned people, acting with moral courage, have affected the course of events before they got out of hand?

This program is intended to assist participants in becoming change agents in behalf of ethical principles. Participants will learn about moral courage and exemplars in ethical action drawn from a variety of fields. After a review of concepts and opportunities for ethical action, participants will discuss complex case dilemmas to determine options for addressing vexing ethics challenges and how to employ tools for effective "ethical activism."

**\*\*So You Want To Be A Guardian Ad Litem?  
Ethical Conundrums For The Social Worker**

Increased rates of family dislocation have generated more complex child custody litigation. When parents are in conflict, guardians ad litem (GALs) are often appointed by a judge to provide assessment and recommendations concerning parental rights and responsibilities and the "best interest of the child." Over the past decade, many more Maine social workers have taken the certification course necessary to perform that role within the judicial system. The NASW Code of Ethics, as adopted by Maine's Social Work Licensing Board, are often quite different in practice and duty from the GAL Rules adopted by the Maine Supreme Judicial Court. This seminar is intended to explore traps and best practices when licensed social workers are appointed to act as GALs in child custody litigation.
