PARCEL I:

Together with all the right, title and interest that Herbert W. Ellis had at his death in and to the abandoned portions of Norwood Avenue, Pierce Avenue, Manolla Avenue and Second Avenue adjacent to the above-noted lots of land.

O'Loughlin et ux one hundred (100) feet, more or less, to land now or formerly of Bella Pelletier; thence northerly bounding easterly on said Pelletier land to the Pawtuxet River; thence westerly bounding northerly on said Pawtuxet River to said "The Norwood Station Plat"; thence southerly bounding westerly on said "The Norwood Station Plat" to the point and place of beginning.

"RESIDENTIAL" A.P. 286, Lots 215 & 216

Those certain lots or tracts of land with any and all of the buildings and improvements thereon located on the northerly side of Second Avenue, situated in the City of Warwick, County of Kent, State of Rhode Island, laid out and designated as lots number 471 and 472 on that plat entitled, "The Norwood Station Plat Situated in Warwick, R.I. Surveyed and Platted by N.B. Schubarth & Co. June 1874" which said plat is recorded in the Office of the City Clerk in said City of Warwick Plat Book 1 at Page 79 and on Plat Card 52, Together with a 25 foot strip of land (formerly a portion of the abandoned Manolla Avenue, formerly known as Maple Avenue) running adjacent to and parallel with the western line of said lots 471 and 472.
