

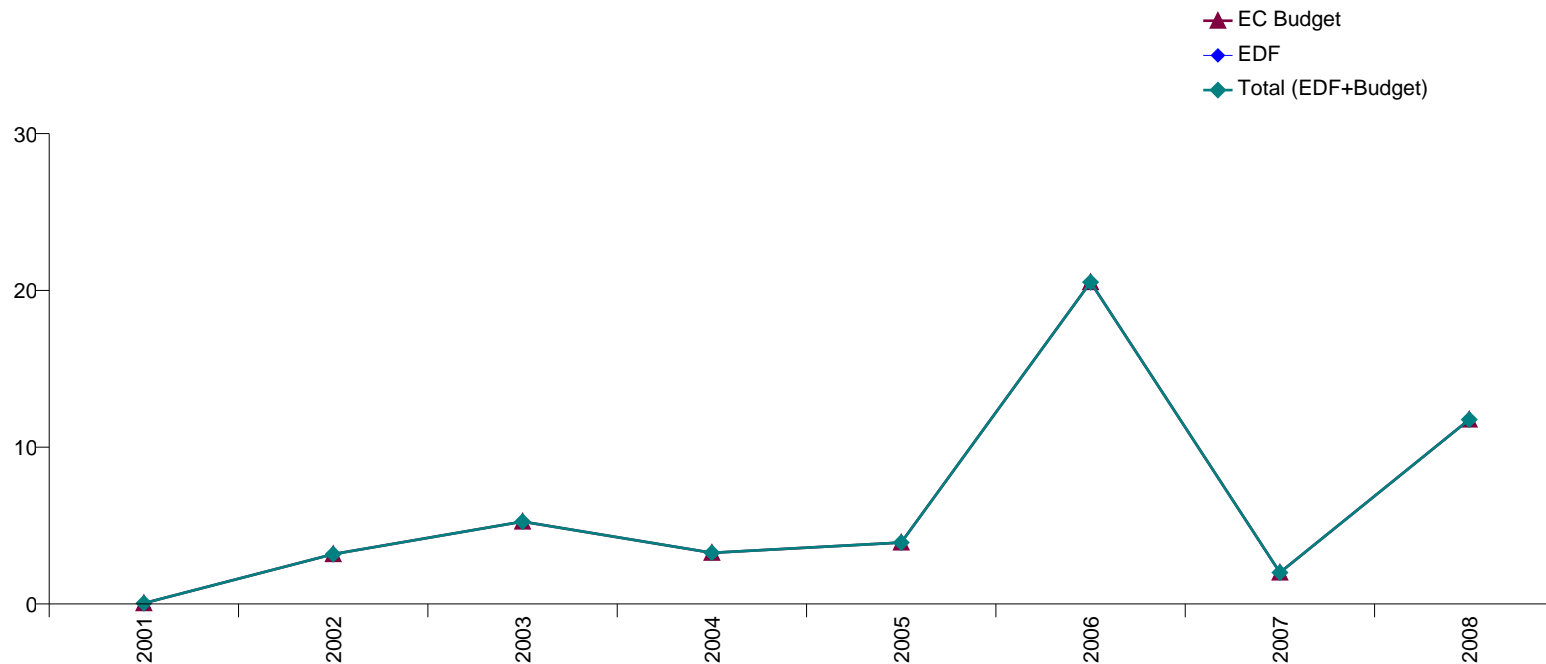

Annually contracted amounts 2000-2008

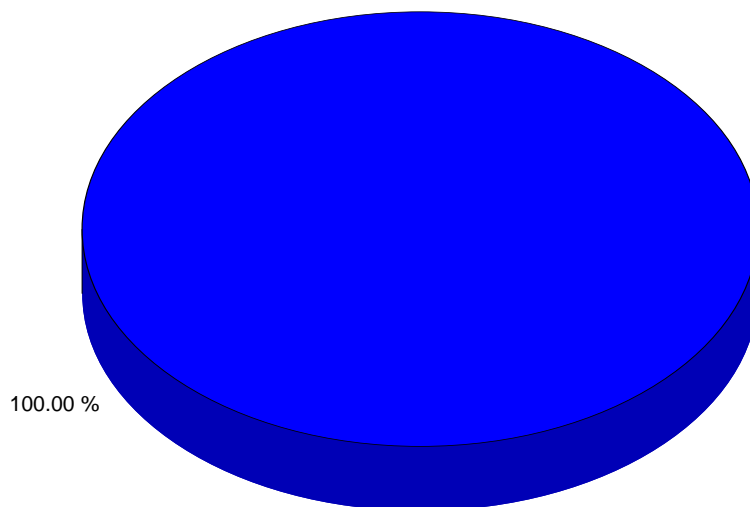

## Budget/EDF breakdown - 2008

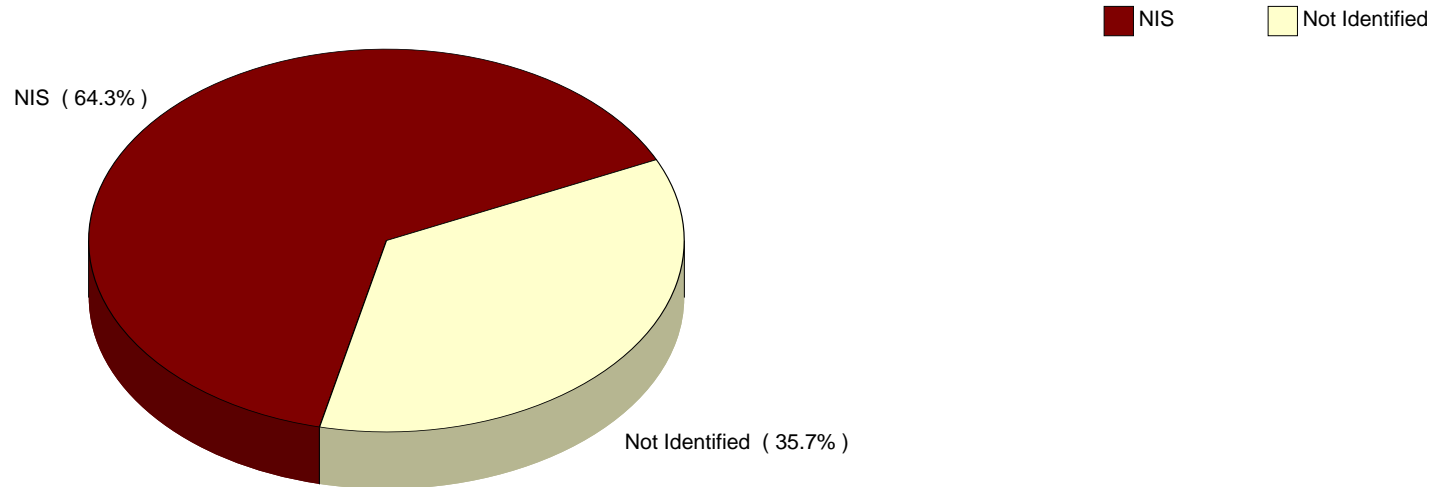

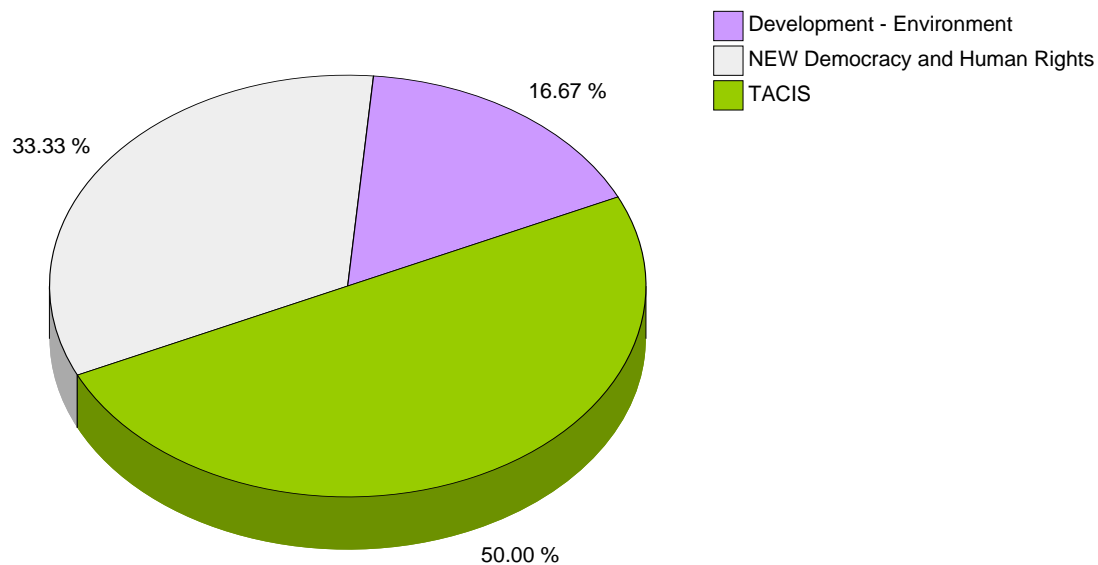
Contracts per geographical region (2008)
