### President's Report

### A Word about Mentorship

Throughout our professional lives we regularly pay lip service to the concept of mentorship. All too often we fail to follow up with actions or concrete advice. In this, my second to final President's Report, I thought it fitting to print some very wise tips from a friend of mine, CW5 Chris Volkert. In no particular order, he provides us all with excellent points to not only pass on to our subordinate Warrant Officers, but which even senior Warrant Officers should revisit from time to time. In the words of CW5 Volkert:

Find and latch on to a senior Warrant Officer mentor, even if he or she is not in your unit or MOS. In most cases there is usually at least one nearby.

Find out early on what your boss knows about your duties and responsibilities. If he or she doesn't seem to know, provide him or her with a job description (the Warrant Officer recruiting page has a general description of duties for each MOS). Take the time to explain what you bring to the table, and how you can benefit the command. Highlight any skills or qualifications you may have that make you the Subject Matter Expert (SME) in your area.

Cultivate trust – give the boss a reason to stay out of your business by doing your job well, never letting him or her down, and never leaving him or her uninformed.

Be the best at what you do, and make your unit successful in your area of expertise – try to create programs or set standards that other units want to emulate. When the boss sees that, he or she will clearly see why he or she needs you in your slot, rather than somewhere else doing something that is not your specialty.

Be ready to take on the occasional additional, nontraditional responsibility if the boss needs you to do so. Most times, if you are being asked to do something extra, it's because it's a no-fail situation and this indicates absolute confidence that you can handle it.

As "small-potatoes" as it may sound, don't be "that

guy" who shies away from social functions all the time. Be a team player and show the boss you are 100% a part of his unit. Also, on the "don't be that guy" note – don't reinforce the legend of the old Chief who has a sloppy uniform, doesn't do PT or formations, and doesn't get involved with Soldier issues. Accept the fact that you will be looked upon as a leader, to some degree or another. How much will depend on your MOS and the commander who is looking. In general, lead within your area of expertise. Enforce standards, both in your technical area and the general military standards all Soldiers must meet. Take charge and take responsibility. Realize you might be the platoon leader if there are no Lieutenants around. Accept it, and do it well. Step away from NCO business. Enable your NCOs without smothering them. Announce your goals and standards to them, teach and advise them how to get there, coach and mentor as required, but stay out of their way. Be a mentor to junior officers and NCOs - teach them what they need to know about your area. Conduct OPDs and NCOPDs.

Read, read, and read some more about anything and everything that pertains to your MOS. Learn so you can teach others. Again, the boss will see this and clearly understand why he or she needs you in your area of expertise, and may be less likely to pull you away from it to do other stuff that someone else could do.

Never forget that most of us – when you boil all the fancy stuff down to the essentials – are first and foremost teachers. We provide continuity of knowledge, skills, and expertise by passing them on to others. There is a reason the Army needs Warrant Officers – we provide stability and continuity that regular line officers just can't provide. And finally, the reason is proven and supported by the results seen in a successful unit.

### Executive Director's Report

### Focus On Association Revenues

One of my goals is to develop strategies to save and generate existing and new sources of Association revenues, respectively. One area where we have been successful is in the sale of memorabilia. The release of the USAWOA 40th Anniversary Coin was a tremendous success, generating several thousand dollars in sales. In a vacuum, sales of this item were an unqualified success. Having said this, the traffic it generated in the online store spurred the sale of other items, generating even more revenues. As a result of this, I requested and was granted authorization by the US-AWOA Executive Committee (EXCOM) to purchase the first in what I hope to be a series of new products for sale in the online store. These will be low-cost, quality items that will hopefully generate ongoing traffic in the online store. As these products are introduced, they will be announced to the Members via email notification. Our goal is not only to generate a reliable additional source of revenue, but to provide Members and other customers with useful items with which they can proudly express their support of your Association.

In September an unexpected increase in cost forced us to seek-out a new printer to help us produce the NEWS-LINER. At the same time, I was developing a new category of corporate sponsorship. The sale of these proposed sponsorships would necessitate expansion of color pages in our publication, in units of 4 pages, to accommodate the increase in advertising. When I negotiated the deal with our new printer, it included prices for these additional pages. I was then able to obtain approval from the EXCOM decreasing the price of a full-page color advertisement and offering the following two new categories of sponsorship:

• \$10,000/year Corporate Partner Sponsorship: This provides the same benefits afforded our regular \$1,600 Corporate Sponsors with two differences. Instead of authorizing them a quarter-page color ad on a quarterly basis, they would receive a full-page color ad every month. Also, it offers them up to 15 associate memberships for their officers and employees.

• \$8,000/year Corporate Partner Sponsorship: This provides the same benefits afforded our regular \$1,200 Corporate Sponsors with two differences. Instead of authorizing them a quarter-page black & white ad on a quarterly basis, they would receive a full-page black & white ad every month. Also, it offers them up to 15 associate memberships for their officers and employees. We hope our new sponsorships will be successful in generating support from corporations interested in reaching our targeted audience of the U.S. Army's trusted technical experts. We encourage Members to introduce this opportunity to interested corporate leaders in their communities.

The bread and butter source of revenue for your Association is membership dues. The good news is that we have ironed-out most of the challenges posed with the shift to electronic notifications utilized with our still relatively new USAWOA Portal site. Also, we have seen an increase in Life Membership commitments. The bad news is that we have experienced a slight drop in overall membership. In June I began sending email messages to Members who did not renew their memberships, updating them on USAWOA accomplishments and current events, and urging them to consider rejoining. This was successful in bringing back a few Members, but was not nearly as successful as a separate effort conducted by CW5 (Ret) Russell Brewer in the Western Region, over which he serves as Regional Director. Together with his Deputy Regional Director and Chapter Presidents, CW5 (Ret) Brewer engaged in an effort to personally contact and speak with every "dropped" Member in the Western Region and he achieved great success. CW5 (Ret) Jim White (our National Vice President) and I have both asked CW5 (Ret) Brewer to share the secrets of this success at this year's AMM, particularly with our incoming Board of Directors. We have avoided raising our Member Dues for 10 years and if our incoming Regional Directors replicate his success across all six regions we will avoid having to consider this option in the foreseeable future.

#### **Legislative Update**

The Military Coalition (TMC) is busy developing priorities for 2013, and focusing on a few last minute issues, prior to congressional debate on the 2013 Defense Bill during the "lame-duck" session of Congress, following the fall elections. A few days prior to the AMM I will "Storm the Hill" with executive directors from other TMC memberassociations. We will be meeting with key Senators and enlisting their support in legislating a cap on TRICARE pharmacy co-pays, mirroring similar language in the House version of the bill. We are also enlisting their support in opposition to a proposed "BRAC-like" commission for changing the military retirement system.

### Why Warrant Officers Should Teach

Warrant Officer (WO) training and educational institutions are seeking qualified, highly motivated instructors to support the development of WOs capable of conducting full-spectrum operations in the expeditionary Army. The Army has implemented dramatic changes to the Officer Education System for Warrant Officers (OES-W) to meet the needs of the transforming Army and the realities of the operational environment. However, despite these improvements, many WOs remain reluctant to request an instructor assignment due to unsubstantiated perceptions that an instructor assignment will require more military and civilian education than they possess, WO instructors lose their technical expertise, and that a TRADOC assignment will negatively impact their careers.

#### **OES-W**

There are five levels of Warrant Officer education: the Basic Officer Leader Course (BOLC) A (candidate school) and B (WO Basic Course), WO Advanced Courses, the WO Intermediate Level Education (WOILE, commonly referred to as the WO Staff Course), and the WO Senior Service Education (WOSSE, known as the WO Senior Staff Course). Each of these levels requires WO instructors with relevant and current operational experiences and the right interpersonal and communication skills to teach, train, and mentor WO students.

In addition, many schools have increased their internal assignment prerequisites for new instructors to include civilian education degrees. This effort supports the current initiatives by the Army to improve each cohort's overall education system. Integrating more credentialed WOs into the OES-W is sustainable, as increasing numbers of WOs are achieving undergraduate and graduate-level degrees. In fact, the demographic of WOILE students indicates that approximately 25% of the students hold less than an Associate's Degree. There is a collective emphasis by officers and the Army on continuing education for WOs, and that trend is creating a greater pool of qualified, degree-holding WO instructors.

#### THE EVOLVING OES-W

The emphasis on education by the Army for all of its Soldiers is the result of lessons learned over more than

a decade of sustained conflict. Evolved, contemporary Warrant Officers are expected to be more than equipment experts, especially as they progress through the ranks, as evidenced by this excerpt from Army Doctrine Reference Publication (ADRP) 6-22, 2-11 (August 2012):

"While warrant positions are usually functionally oriented, they lead and direct Soldiers the same as other leaders and staff officers ... Warrant officers functioning at higher levels become systems experts rather than equipment experts. As such, they must have a firm grasp of the environment and know how to integrate the systems they manage into complex operational environments (OE)."

Warrant Officers should teach because it is a demanding and rewarding way to ensure that future generations receive important lessons from those who are still serving. In addition, it is essential for WOs to be responsible for their own education. If WOs do not value the education and training available within the OES-W and serve as instructors, then who will?

The OES-W is evolving to ensure that the future WO is capable of better understanding their role in the OE. Instructor assignments are career enhancing and should be considered by top-performing officers.

# Biography of General Frank J. Grass

### Chief, National Guard Bureau

General Frank J. Grass serves as the 27th Chief, National Guard Bureau and as a member of the Joint Chiefs of Staff. In this capacity, he serves as a military adviser to the President, Secretary of Defense, National Security Council and is the Department of Defense's official channel of communication to the Governors and State Adjutants General on all matters pertaining to the National Guard. He is responsible for ensuring that the more than 470,000 Army and Air National Guard personnel are accessible, capable and ready to protect the homeland and to provide combat resources to the Army and Air Force.

Prior to his current assignment, General Grass served as Deputy Commander, United States Northern Command and Vice Commander, United States Element, North American Aerospace Defense Command (USELEM-NORAD) at Peterson Air Force Base, Colorado. As Deputy Commander, United States Northern Command, General Grass helped lead the command to anticipate, prepare and respond to threats and aggression aimed at the United States, its territories and interests within the assigned area of responsibility and as directed by the President or Secretary of Defense, provide Defense Support of Civil Authorities, including consequence management operations.

General Grass enlisted in the Missouri Army National Guard in October 1969. He attended the Missouri Army National Guard Military Academy Officer Candidate School and was commissioned in the Engineer Corps in 1981. He has served in a variety of command and staff positions as a traditional National Guard Soldier, in the Active Guard and Reserve program, and on active duty. In his first general officer assignment, he served as Deputy Director of the Army National Guard in Arlington, Virginia.

Upon learning of his appointment, then-LTG Grass summed up the awesome responsibility he has undertaken: "I am thrilled and humbled by the opportunity, if I am confirmed, to lead the best National Guard in our nation's history - a force of more than 460,000 men and women proven on the battlefield and during domestic crises."

### Warrant Officer Inducted in the Delaware Army National Guard Hall of Fame

Editor's note: On 6 May 2012 the first Warrant Officers were inducted into the Delaware Army National Guard Hall of Fame. The award was presented to CW4 (Ret) Nick Di Girolamo and CW4 (Ret) Edward Willis at the Bethany Beach Training Site, Bethany Beach, DE. Both are members of the First State Chapter in Delaware. This article features CW4 (Ret) Willis. In the July 2012 issue we featured an article on CW4 (Ret) Di Girolamo. We wish to restate our congratulations to both for their induction in this prestigious Hall of Fame.

CW4 (Retired) Edward Willis began his military service as a private on June 11, 1953 during the summer between his junior and senior year in high school as a member of the Delaware Army National Guard.

On October 14, 1954, he reported to Fort Monmouth, NJ to attend a 33-week Radar Repair Course. On March 1, 1956, he was hired as an Electronic Fire Control Technician with the 193rd AAA BN (75mm Sky sweeper). Upon the reorganization to the M42 Duster's, his duties were changed to a Wheel and Track Mechanic where he progressed through the enlisted ranks of E7.

On 1 December 1968 he was appointed as a Warrant Officer 1 and assigned duties of General Mechanic Foreman and Shop Foreman of OMS #1 at the Greater Wilmington

Airport. His duty assignment in the Delaware National Guard was the Battalion Maintenance Officer of the 1st AW Bn. Of course this all changed when the Delaware Army National Guard was changed over to Signal. Chief Willis' first assignment was the Crypto TTY Repair Technician for Co B, 198 Signal Battalion at Middletown, DE. He was also transferred as the OMS Foreman when the shops were realigned. While working at Middletown OMS, the Unit was changed from Signal to a Maintenance Detachment and then to the 736th Supply and Service Battalion. Of course this brought along with it many changes to the military assignments. CW4 Willis served as a unit Telecommunications Technician, Armament Technician, Supply Technician, and finally back with the 736th Supply and Service Battalion as the Battalion Maintenance Officer. He also served as COMSEC Custodian and was a Delaware Defensive Driving Instructor for the Guard.

During his 35½ years in the Guard, with 33 years in a dual status, he attended many Service Schools and Civil Service Training Seminars. In furthering the goals of the Battalion Maintenance Officer, CW4 Willis has served in numerous positions of responsibility, culminating as a Life Member of the National Guard Association and an active member of the First State Chapter of the Warrant Officers Association. CW4 Willis is a Life member of the Dover Elks Lodge #1903 and has been with the organization for 45 years. He served as the State President of MD-DE-DC Elks Association in 2006-2007 and was selected as the State Association Elk of the Year in 2005.

CW4 Willis' decorations include Army Achievement Medal (2), Armed Forces Reserve Medal with 'M' device and 2 Silver Hourglass, Reserve Component Overseas Service Ribbon, Delaware Army National Guard Aid to Civil Authority w/numeral 6, The Delaware National Guard medal for Military Merit w/numeral 3 and State of Delaware Conspicuous Service Cross w/star.

CW4 Willis's longstanding record of solid performance, dedication to duty, service, and achievement reflect great credit upon himself, the Delaware National Guard, the United States Army and the Warrant Officer Corps. All of his remarkable accomplishments highlighted his worthiness for inclusion in the Delaware National Guard Hall of Fame. CW4 Edward Willis is truly one of the Delaware National Guard's superior Warrant Officers.



Tuesday will be the kickoff of






