Florida Population: Census Summary 2010

Florida continues to be one of the most rapidly growing states in the nation. According to the 2010 Census, Florida's population was 18,801,310 on April 1, 2010, an increase of 2,818,486 since April 1, 2000. The 2000-2010 period was the fourth consecutive decade in which the Florida population grew by more than 2.8 million residents. Florida's numeric population increase during the past decade was the third largest of any state, trailing only Texas and California. Its percent increase (17.6%) was the eighth largest in the nation.

State and regional trends

The 2010 Census confirmed the continuing population shift from the Midwest and Northeast to the South and West regions of the United States. The U.S. population was 308,745,538 on April 1, 2010, an increase of 27.3 million (9.7%) since 2000. Most of this increase occurred in the South and West. The South grew by 14.3 million (14.3%) and the West by 8.7 million (13.8%), while the Midwest grew by 2.5 million (3.9%) and Northeast by only 1.7 million (3.2%). The South remains the most populous region of the country, with 114,555,744 residents in 2010, followed by the West with 71,945,553, the Midwest with 66,927,001, and the Northeast with 55,317,240.

Texas had the largest numeric population increase of any state between 2000 and 2010, growing by nearly 4.3 million residents. California and Florida also had large increases of 3.4 million and 2.8 million, respectively. Five states grew by more than 20% during the decade: Nevada (35.1%), Arizona (24.6%), Utah (23.8%), Idaho (21.1%), and Texas (20.6%). Of the fifteen states with the highest growth rates, nine were in the West and six in the South. All six of the states that increased by more than one million residents were located in the South and West. At the other end of the spectrum, Michigan lost population during the decade while Rhode Island gained only 4,248 residents and the District of Columbia and Vermont gained less than 30,000 each.

County trends

Every county in Florida experienced an increase in population between 2000 and 2010 except Monroe

and Pinellas, which declined by 6,499 and 4,953, respectively. Twenty-four of the state's 67 counties grew by more than 20% and 52 grew by more than the national growth rate of 9.7%. Four counties grew by more than 50% (Flagler, Sumter, Osceola, and St. Johns), while another eight grew by 30-50% (St. Lucie, Lake, Lee, Walton, Clay, Pasco, Wakulla, and Hernando). These rapidly growing counties are found throughout the state, on both coasts and in the interior. Only six counties grew by less than 5% since 2000: Hardee, Gadsden, Madison, Escambia, Monroe, and Pinellas. These counties are also scattered throughout the state, from the Panhandle to the Keys.

In terms of numeric population growth, the largest increases occurred in counties located in central and south Florida. Orange, Miami-Dade, Hillsborough, Palm Beach, and Lee each grew by more than 150,000 residents during the decade. Three other counties (Broward, Pasco, and Polk) grew by more than 100,000. More than half of the state's population growth occurred in these eight counties. In contrast, thirty counties had changes of less than 10,000 residents during the decade; most of these are in north central Florida and the Panhandle.

City trends

Florida is a highly urbanized state. More than 94% of Florida's population lived in metropolitan areas in 2010, and many others lived in small and medium sized towns in non-metropolitan counties. Only a small fraction of Florida's population may be truly classified as rural.

Florida's population growth from 2000 to 2010 was slightly faster in incorporated than in unincorporated places. The populations of incorporated cities and towns grew by 1,549,245 (19.6%), while the populations of unincorporated areas grew by 1,269,241 (15.7%). Approximately 55% of Florida's residents currently live in incorporated cities and towns, compared to just under 50% in 2000.

Cities and towns show much more variation in population growth rates than counties do. Of the 411

incorporated places in Florida, 16 more than doubled in size between 2000 and 2010; 24 grew by 50-100%; 63 grew by 25-50%; 165 grew by less than 25%; four had no population change; and 130 lost population. Nine new cities and towns were established during the decade and one (Cedar Grove) lost its official status as an incorporated place.

Cities and towns also vary a great deal in terms of population size, ranging from ten residents in Lake Buena Vista to 821,784 in Jacksonville. Eighteen incorporated places had more than 100,000 residents in 2010; 33 had 50,000-100,000; 111 had 10,000-49,999; 105 had 2,500-9,999; 60 had 1,000-2,499; and 84 had less than 1,000. Although large cities account for the majority of the population living in incorporated places in Florida, small towns account for the majority of such places.

Components of growth

There are only four components of population growth: births, deaths, in-migration, and out-migration. Births and in-migration raise the size of a population, whereas deaths and out-migration lower it. The overall growth (or decline) of the population of a given area is thus determined by the numbers of births, deaths, in-migrants, and out-migrants.

Florida had more than 2.2 million births and almost 1.7 million deaths between 2000 and 2010. The difference between births and deaths is called “natural increase.” During the past decade, natural increase was 518,766 and accounted for 18.4% of Florida’s total population growth. The remainder of the state’s growth was caused by net migration (i.e., the excess of in-migrants over out-migrants). Net migration into Florida was almost 2.3 million between 2000 and 2010, accounting for 81.6% of the state’s growth. This stands in sharp contrast to the experience in many states, where net migration is small or even negative.

Components of growth vary a great deal from county to county. Net migration was positive in all but six counties during the past decade (Escambia, Gadsden, Hardee, Hendry, Monroe, and Okaloosa) and was greater than 100,000 in five counties: Palm Beach (175,540), Lee (170,373), Orange (159,613), Hillsborough (156,958), and Pasco (127,901). Net migration was between 10,000 and 99,999 in 31 counties and positive but less than 10,000 in 25 counties.

Natural increase also varied substantially from county to county, ranging from 145,082 in Miami-Dade to -26,888 in Pinellas. Forty-five counties had positive natural increase (i.e., more births than deaths) while 22 had negative natural increase (i.e., more deaths than births). Counties with negative natural increase tend to have relatively large proportions of older residents; consequently, they have relatively high death rates and low birth rates.

Population growth (or decline) can also be caused by changes in geographic boundaries. Although boundaries for Florida and its counties have not changed significantly since 1930, boundaries for many cities, towns, and unincorporated areas have changed because of annexations, de-annexations, new incorporations, and the dissolution of previously incorporated places. For this reason, some of the changes in population size observed for cities, towns, and unincorporated areas between 2000 and 2010 were caused by shifts in geographic boundaries rather than by natural increase and net migration.

Summary of contents

Table 1 of this report shows the populations of each county and incorporated city in Florida in 2000 and 2010, along with numeric and percent changes during the decade. Table 2 shows the population of the nation, each state (including the District of Columbia), and the four geographic regions. Table 3 shows the components of growth (births, deaths, and net migration) for each county and the state between 2000 and 2010. Tables 4-6 show populations in 1980, 1990, 2000, and 2010 and decade growth rates for counties, Metropolitan Statistical Areas, and planning districts, respectively. Figures 1 and 2 are maps showing numeric and percent changes in total population for each county between 2000 and 2010.

Table 7 shows county populations ranked by population size in 2010 and each county’s share of the state population in 1980, 1990, 2000, and 2010. Tables 8 and 9 show counties ranked according to numeric and percent changes in total population between 2000 and 2010.

The next three tables show the top 100 cities in Florida ranked by 2010 population size (Table 10), numeric increase between 2000 and 2010 (Table 11), and percent increase between 2000 and 2010 (Table 12).




Figure 4. Black Population as a Percent of Total Population, 2010

Table 13 shows the 2010 population by race and Hispanic origin for the state and each county. Figures 3 and 4 are maps showing the Hispanic and African-American populations, respectively, as a percent of total population for each county. Table 14 shows counties ranked by population density (persons per square mile) in 1990, 2000, and 2010. Figure 5 is a map showing the population density of each county in 2010.

The appendix provides an alphabetical list of each incorporated city and town in Florida and the county in which each is located.

A note about the data

Most of the data shown in this report were derived from population counts conducted every 10 years by the U.S. Census Bureau. The decennial census is the most comprehensive and accurate source of population data in the United States and is used by public and private sector decision makers for a wide variety of purposes (e.g., budgeting, planning, site location, marketing, and revenue sharing). However, the census is not error-free. Errors can be caused by missed households, refusal to respond, recording errors, sampling errors, geographic assignment errors, duplication errors, coding and data-processing errors, and the incorrect imputation of missing data. Census errors often balance each other out, especially at higher levels of geography.

The accuracy of census counts has improved over the years. The net national undercount was estimated as 5.4% in 1940, the first year formal undercount estimates were calculated. The net undercount declined to 4.1% in 1950, 3.1% in 1960, 2.7% in 1970, and 1.2% in 1980; rose to 1.7% in 1990; and declined to 0.1% in 2000. In Florida, the net undercount was estimated as 1.2% in 2000, down from 2.0% in 1990. Estimates of the net undercount in 2010 are not yet available.

Errors in total population counts are small in most cities and counties, but are sometimes quite large. For example, the 2000 Census initially counted 11,057 residents in Franklin County and 13,332 in Gulf County. However, it was subsequently discovered that a prison located in Gulf County was mistakenly counted in Franklin County. When this error was corrected, it reduced Franklin County's population to 9,829 and

raised Gulf County's population to 14,560. Although errors of this magnitude are infrequent, smaller errors occur frequently. The numbers for 1980, 1990, and 2000 shown in this report incorporate all post-censal corrections issued by the Census Bureau; consequently, some numbers differ from those published previously.

The 2010 Census data shown in this report were based on the redistricting data released by the U.S. Census Bureau during the spring of 2011 (P.L. 94-171). They have not been adjusted to account for undercount (or overcount). In addition, they have not yet incorporated the results of the post-censal count resolution program. Some of these numbers will be corrected during the coming months and years, but most of these corrections will be fairly small.

The population data shown in this report refer solely to permanent residents. According to Census Bureau guidelines, a person is counted as an inhabitant of his or her usual place of residence, or the place where that person lives and sleeps most of the time. Temporary residents such as tourists and snowbirds are thus excluded from the Florida data, being counted as residents of other states or countries. If they reside in Florida on a permanent basis, however, persons from foreign countries (except those representing foreign governments) are counted as Florida residents regardless of their legal status. College students, military personnel, and inmates in penal institutions are counted as residents of the cities and counties where they live while in college, the military, or prison, not as residents of their "hometowns."

The data on births and deaths in Florida and its counties were provided by the Florida Department of Health, Office of Vital Statistics. The Bureau of Economic and Business Research at the University of Florida developed estimates of net migration by subtracting natural increase from total population change during the decade. All the other data shown in this report were provided by the U.S. Census Bureau.



Figure 2. Percent Change in Population, 2000 to 2010



Figure 3. Hispanic Population as a Percent of Total Population, 2010





