**Subject: Retirement and Removal of Verizon Broadway 4ESS Tandem (NYCMNYBW21T)**

As was announced in Verizon New York Inc.'s ("Verizon") November 9, 2009 "Public Notice of Network Change under Rule 51.329(a)" (the "Notice," copy attached), the Verizon Broadway 4ESS tandem (NYCMNYBW21T), located at 33 Thomas Street, NY, NY 10007, will be retired and removed after all traffic served by this tandem is migrated to the alternative tandem described below. Traffic switched by the Broadway 4ESS tandem will be migrated to the Second Avenue 5ESS tandem (NYCMNY1306T) located at 204 Second Avenue, NY, NY 10003. Traffic to be migrated to the Second Avenue 5ESS tandem includes Inter-LATA access, including Feature Group B and D, CLEC, IXC, IEC, wireless and Verizon end office switch traffic.

CLEC, IXC, IEC, wireless and paging carriers will need to secure new trunk groups built to the Second Avenue 5ESS tandem or have existing trunk groups to that tandem augmented. Carriers that are code holders for access connectivity in the Broadway 4ESS tandem switch will be required to reposition the codes to the Second Avenue 5ESS tandem.

Verizon will accept Access Service Requests (ASRs) from the mentioned carriers to build new or augment existing trunk groups on the Second Avenue 5ESS tandem beginning **December 1, 2009**. All ASRs for the 5ESS tandem must be received no later than **June 1, 2010** in order to provide sufficient time to migrate the traffic described above. All traffic must be moved by **August 31, 2010**. All ASRs for the Second Avenue 5ESS tandem must carry the project code of **NYCMNYBW21T**.

This letter is intended to provide information necessary for customers to submit ASRs in a timely fashion.

**General Information:**

**Exchange (NXX) Codes in Numbering Plan Areas (NPA) 212, 646 and 917 supporting Access/FG-B/FG-D via NYCMNYBW21T will be accommodated by NYCMNY1306T serving as a combined Access/FG-B/FG-D and Local/IntraLATA tandem.**

The time frame for ASRs to be submitted is:

- **IEC, CLEC IXC, Wireless and Paging trunk augmentation or new build** starting **December 1, 2009**.
- **CLEC IXC, Wireless and Paging NXX Code moves** starting **April 1, 2010** ending **August 1, 2010**.

**All connect/disconnect ASRs should carry the Project Number of NYCMNYBW21T.**

### **Network Changes and Trunk Rearrangements:**

The **Second Avenue 5ESS** tandem (NYCMNY1306T) will be the recipient tandem of the traffic being migrated off of the Broadway 4ESS tandem (NYCMNYBW21T).

Inter-LATA (ACCESS/FG-B-D/CLEC IXC), Wireless, and Paging trunks will be moved from the Broadway 4ESS tandem (NYCMNYBW21T) to the Second Avenue 5ESS tandem (NYCMNY1306T).

Beginning **December 1, 2009**, Verizon will accept Access Service Requests (ASRs) from CLEC IXC, IEC, Wireless and Paging carriers to build new or augment existing trunk groups on the Second Avenue 5ESS tandem (NYCMNY1306T). All ASRs for the Second Avenue 5ESS tandem (NYCMNY1306T) must be received no later than **June 1, 2010**. All traffic will be required to be moved by **August 31, 2010**.

With the many carriers involved, it is critical that all carriers submit their ASRs/translation questionnaires and be prepared to turn up their trunk groups on schedule. All ASRs for the Second Avenue 5ESS tandem (NYCMNY1306T) must carry the project code of **NYCMNYBW21T**. The orders will be processed on a first-come, first-served basis. Specific trunk testing dates will be negotiated as orders are received.

Disconnect ASRs for the Broadway 4ESS tandem (NYCMNYBW21T) are also required and should be submitted to Verizon immediately after the re-homing of traffic is completed.

After all traffic is migrated off of the Broadway 4ESS tandem (NYCMNYBW21T), it will be retired and removed from the network.

Please adhere to industry standards using normal procedures that pertain to updates and changes to the Local Exchange Routing Guide (LERG) for all NXX codes subject to the retirement of the Broadway 4ESS tandem (NYCMNYBW21T).

It is incumbent upon carriers to update the LERG in a timely manner for the NXX codes that are assigned to their switching equipment.
