The Danish owned DLG Group intensifies its activities in vitamins and minerals now launching a new brand in the field – VILOFOSS.

The DLG Group is the largest cooperative farm supplier in Denmark with a turnover of more than € 5.51 billion in 2010. DLG supplies grain, feedstuffs, fertilizers, chemicals, etc. for farm management and employs more than 5,000 people.

In 2011 the 13 premix-plants in Europe, i.e. Deutsche Vilomix in Germany and Russia, Vitfoss in Denmark and Poland, Fodermix in Sweden and Calcialiment in France achieved a total production volume of 257,000 tons and a turnover of approx. € 352 million.

The Deutsche Vilomix Tierernährung GmbH was founded in 1972. Relocating the company to Neuenkirchen in Oldenburg took place in 1974, and serves today as the headquarters of Deutsche Vilomix. This region, known as Oldenburger Münsterland, is the centre of the German food processing industry. The primary duty and objective from the beginning was to provide expert advising to feed mix manufacturers, feed dealers and agriculturalists on all matters concerning livestock feeding and feed manufacturing in the spirit of partnership. In 1993 a second production location was established for Deutsche Vilomix Tierernährung GmbH via the takeover of company Cimbrina in Hessisch Oldendorf.

In 2006 a new, independent premix plant was opened in Orenburg (Russia), approx. 1200 km southeast from Moscow in order to serve the Russian and Eastern European feed markets.

Another milestone for the future and direction of Deutsche Vilomix was laid in 2011 when it opened a new plant and started production in Haldensleben near Magdeburg, Germany. It is Europe's most modern premix and mineral feed plant in Europe. The increasing number of East German customers and growing demand from foreign markets warranted the choice of this location. Today Deutsche Vilomix Tierernährung GmbH is one of the leading premix and mineral feed manufacturers in Germany.
