## **START OF A NEW SEASON AFTER WORKING HOLIDAYS**

FIRA AER's European dimension implies an original operating process taking into account every party's own criteria. Instead of having relaxing holidays, we had a working summer giving way to a heavy new season. The best proof may be our Chairman's summer itinerary, which will be used throughout this Flash Info.

What have we done since the "Romanian" GM? Portugal became our first Seven's European Champions in Heidelberg, Germany after 5 tournaments. We held Experts Courses in Sofia with 9 Russian-speaking nations and in Portugal, with 22 nations) that were as useful as important. Our initial meeting in July with the IRB was delayed due to Vernon Pugh's illness, and the European rugby family would like to send its best wishes of recovery to our dear friend but we kept in touch for the next U19 World Championship and the European Seven's circuit.

We also presented our sporting and financial projects in Dublin during the Regional Associations Meeting to be examined by the Council next November.

In the meantime, the European Regions Cup quarterfinals are due to be played while Italy, Ireland, Romania and Georgia qualified for RWC2003 and Spain and Russia will have to go through repechage. Moldavia, Czech Rep., Belgium and Latvia will compete in the U18 to qualify for the U19 World Championship.

A Commissioners Training was held in Toulouse with 21 commissioners from 16 nations and an Anti-Doping Seminar was held in the Maison du Rugby with Arpaillange, Fabre and Dr Mombet. Did I say working holidays?

# **INSURANCE – MEDICAL MATTERS**

Players safety was largely discussed during the Commissioners Meeting in Toulouse.

Players safety starts from venue equipment, to refereeing, selection based on the appropriate positions, training conditions, player's individual equipment (gum shield, padding gear, studs etc.0

But Player's safety also depends on the medical monitoring of competitions and courses.

It is compulsory to have a doctor and an ambulance in attendance and competitions and courses shall only start once there is compliance with this obligation.

If, exceptionally, a doctor cannot attend, or should the appointed doctor fail to attend, the organiser shall appoint, under its responsibility, a qualified person vouched by the organiser.
