



The Secretariat is an organisation of local government councils which was established in 1983 in response to increasing community interest in peace and disarmament, and the rapid growth of local government nuclear free zones following the first declaration by the City of Collingwood (Melbourne) in 1977.

Since then its interest has expanded to environmental issues such as the storage and transport of radioactive waste and other toxic and hazardous materials, uranium mining, and upgrading of the Lucas Heights nuclear reactor.

With the increase in activity in the nuclear industry in the past year, local councils across Australia are mobilising against the nuclear threat. We have proposed nuclear waste dumps in South Australia and Broken Hill, proposed uranium mines across South Australia, Western Australia and the Northern Territory. There is also the Federal Government's proposal for a new reactor at Lucas Heights in Sydney.

Now is a very important time to take action. In the past few months, many new councils have declared themselves Nuclear Free, passed anti-nuclear motion and have joined the secretariat. The challenge for us is to organise the local government response to the nuclear threat.
