Chaplain Ted Pearson of the Columbus Rescue Mission; Skip Plock and other interested individuals came before the Board to inform them of the plans to place a rescue mission in the City of York. Their purpose is to preach the Gospel and meet the physical and emotional needs through the provision of shelter, clothing, food, Biblical counseling and structured programs for the poor, needy and those who may be bound and bruised by addictive lifestyles. It is supported 100% by voluntary contributions-no government funds are used.

This was for informational purposes only. No action was taken by the Board.

A public hearing was held at 10:04 a.m. as published on August 27, 2009, to consider a special exception application submitted by Werner Construction Inc. of Hastings. This request is to allow a temporary concrete plant site in the SE ¼ of 32-11-3. Those present at the hearing were: County Commissioners Eugene Bergen, Patricia Bredenkamp, Kurt Bulgrin and Steve Neujahr; Orval Stahr, Zoning Administrator along with Deb Nelsen, Zoning Assistant; Sheriff Dale Radcliff, Steve Moseley and Bo Blackman.

The primary use of the plant is to provide paving materials for the Nebraska Department of Roads project S-L93E Charleston Link.

No one was present from the public to speak to the issue.

The public hearing was closed at 10:13 a.m.

Moved by Bulgrin, seconded by Bredenkamp to approve the Special Exception request for Werner Construction Inc., with the following added conditions:

- 1. That driveways be removed if it is determined by the Road Highway Superintendent that they should be
- 2. That the roads that they are using must be returned to the same condition as they were prior to the start of the project
  - 3. That this exception be good through December 31, 2010
  - 4. That the property be returned to its original condition prior to the start of the project

Bulgrin moved and Bredenkamp seconded to amend the motion to add a condition that the roads be returned to the same condition as prior to the project with the approval of the York County Highway Superintendent; roll call on the amended motion: yeas, Bulgrin, Bredenkamp, Neujahr and Bergen; nays, none; Brown absent; motion carried.

When preparing for the installation of time clocks for county offices, it was found that another county within the state credited their employees with a portion of paid vacation from their start date. Under York County's policies, an employee earns six (6) days of paid vacation after one year of employment and is not entitled to a prorated payout of vacation if they should terminate employment prior to completing one year of service. After researching the matter, it was found that completion of one year of employment is a condition precedent to acquiring the six days of vacation. After that condition is satisfied, the vacation becomes vested in the employee. Until such time that the condition has been satisfied, no such vesting takes place, therefore, no action need be taken at this time.

A public hearing was held at 10:31 a.m. as advertised to hear support, criticism, suggestions or observations relating to the proposed York County Budget for 2009-2010. Present at the hearing were: Commissioners Eugene Bergen, Steve Neujahr, Patricia Bredenkamp and Kurt Bulgrin; Mike Teeter, Stan Schulz, Steve Moseley and Bo Blackman.

During the public hearing, Mike Teeter and Stan Schulz with Kilgore Memorial Library came before the Board to present them with a written memo of thanks; "In uncertain economic times like these, it is well to scrutinize public expenditures to insure that public funds are spent effectively and that essentials are maintained. On behalf of all who benefit directly or indirectly from the services of Kilgore Memorial Library, thank you for your continued support of the library's services, to insure their availability to all our community's residents."

There were no other public comments during the hearing.

The public hearing was closed at 10:37 a.m.

The Commissioners thanked those who worked on the budget and also the Elected Officials/Department Heads for their cooperation and assistance.

Moved by Neujahr, seconded by Bredenkamp to adopt Resolution #09-69 to accept the 2009-2010 budget as presented; roll call: yeas, Neujahr, Bredenkamp, Bulgrin and Bergen; nays, none; Brown absent; motion carried.

Highway Superintendent, Don Robb reviewed the bids and recommended that the Board go with the 2006 Cat 563 packer for \$71,500.

It was felt that the bids received were based on the bid specs which were for a non-cab unit, however, two of the bids and also the recommendation of the Highway Superintendent was for a cabbed unit, it was therefore felt that the bids should be rejected.

Moved by Neujahr, seconded by Bulgrin to reject all bids; roll call: yeas, Neujahr, Bulgrin, Bredenkamp and Bergen; nays, none; Brown absent; motion carried.

The bids will be readdressed at a future meeting.

County Sheriff Radcliff, Bob Hose and Gail Nordlund came before the Board to discuss the State Statutes which apply to the Commercial Dog and Cat Operator Inspection Act which was amended by LB241 during the 2009 legislative session and became operative August 30, 2009. The statute reads as follows:

Statute 54-626(1) was amended to expand the definition of an animal control facility to include those nongovernmental facilities which are conducting animal control duties for the state or a political subdivision. As amended, §54-626(1) reads:

Animal control facility means a facility operated by, <u>or under contract with</u>, the state or any political subdivision of the state, for the purpose of impounding or harboring seized, stray, homeless, abandoned, or unwanted animals.

Additionally, §54-627(6) was amended to allow for an exemption to the licensing requirements for the state or a political subdivision, itself, if the state or political subdivision contracts with another licensed animal control facility or a licensed animal shelter to conduct its animal control duties. As amended, §54-627(6) reads:

The state or any political subdivision of the state which contracts out its animal control duties to a facility not operated by the state, or any political subdivision of the state, may be exempted from the licensing requirements of this section, if such facility is licensed as an animal control facility or animal shelter for the full term of the contract with the state or its political subdivision.

It was noted that if a political subdivision utilizes a private veterinary clinic for housing its impounded animals, either the political subdivision or the veterinary clinic would need to obtain an animal control facility license. At the present time, Adopt-A-Pet is housing animals for the county. Hose advised that they are a licensed facility. They are being partially funded through the 2009-2010 budget in the amount of \$4,000.00. The amount of funding was questioned by Mr. Hose. He advised that he would have to contact the Adopt-A-Pet board to see if they would be able to continue the service they are now providing if the amount of funding by the county would only be \$4,000.00.

The matter was tabled until a future date.

Committee reports were given.

County Clerk, Cynthia D. Heine and Clerk of the District Court, Sharilyn Ramsey submitted their August fee reports in the respective amounts of \$9,142.93 and \$2,025.56. The reports were reviewed and placed on file.
