WHEREAS, the salaries for elected officials are set prior to the beginning of the term, and

WHEREAS, in Resolution #57 adopted on December 20th, 2005 stated the elected officials shall receive an annual increase for the years 2008, 2009 and 2010, based on the Consumer Price Index as established by the Bureau of Labor Statistics, U.S. Department of Labor except when the CPI falls below 2.5% in any year in which case the annual adjustment will be no less than 2.5% and except when the CPI raises above 3% in any year in which case the annual adjustment will be no more than 3%. Because the CPI is at a negative %, the increase will be set at 2.5% as per resolution.

NOW THEREFORE BE IT RESOLVED, that the salary for the Assessor, Clerk, Clerk of the District Court, Treasurer and Public Defender be set at \$50,319.68; the salary for the County Sheriff be set at \$60,145.55 and the salary for the County Attorney be set at \$64,046.68 for the year 2010 to take effect January 1, 2010.

The Board then addressed setting the salaries for elected officials for the term 2011 through 2014.

Moved by Bulgrin, seconded by Bredenkamp that the Board adopt a resolution that the salaries for 2010 carry over to 2011 and after that their would be an annual increase based on the Consumer Price Index not to exceed 3% and not to go below "0" (Assessor, Clerk, Clerk of the District Court, Treasurer and Public Defender receive \$50,319.68; Sheriff \$60,145.55 and Attorney \$64,046.68). After discussion, Bulgrin and Bredenkamp rescinded their motion as it was found that added wording needed to be included regarding benefits for these officials. The matter was tabled until later in the meeting.

Craig Vincent and Corey Fuehrer of Nebraska Public Power District presented information on an Energy Efficiency and Conservation Block Grant and Energy Wise Incentive Programs/Grants. These programs are for replacing 1. Lighting 2. High-Efficiency HVAC – Air Conditioners, Heat Pumps – air source and geothermal 3. Premium Efficiency Motors 4. Variable frequency Drives 5. Irrigation Systems 6. Custom Incentives.

The Board will look into the program further. No action is taken at this time.

Bob Hose of York County Adopt-A-Pet came before the Board regarding funding for the program. Legislative Bill 241 which addresses changes to the Commercial Dog and Cat Operator Inspection Act was a topic of the discussion along with the budgeted amount of \$4,000.00 which was adopted by the Board for Fiscal Year 2009-2010.

The matter will again be discussed at the next regularly scheduled meeting to be held on December 29th.

Rex Heiden, York County Surveyor, spoke with the Board regarding several issues. The Board responded as noted in the parenthesis.

1. Do you want to approve and/or be notified, of the work I do before I start a job or someone? (*The Board advised that he could continue as he had in the past*).

2. Is it possible to put in our County Zoning that no utility shall be installed underground within 2' of a property corner or controlling monument unless the utility company has a license surveyor reference the monuments position and remonument it after construction. There currently exists State Laws that may cover this (34-201-202) but it states the notification go to the County Surveyor. I think if it involves a Government subdivision corner it should go to the County Surveyor but not all property corners. Also, can a fine be established for non-compliance? Government Corners have a fine for them by U.S. Code, Title 18, part 1, Chapter 91, Section 1858 but it no longer specifies the fine amount. \$250 was set as the fine in the 1800's. The City and Villages are also destroying property corners. (*The Board will have the County Attorney look into the matter*)

3. Access to the survey Records, the County Clerk asked for and received my key to that office "due to the increased security procedures adopted for the courthouse". (*The Board agreed that it was a security issue and that he would have to access the office during business hours, work toward making copies for him*)

4. Bench Marks in the County, some are being destroyed or lost, would you like me to find and protect (wood post, etc.) the existing ones. They are needed for people who live in or near flood zones for insurance and zoning purposes. The Federal Government is no longer going to maintain there old monument system. (*The Board needs more information on cost prior to making a decision*)

5. Do you have any thoughts on what you would like improved or changed in regards to the county Surveyor or the survey records, other then what is proscribed by law? He was questioning the issue of digitizing records (*The Board had nothing more to add*)

Gary Zoubek, York County Extension Agent came before the Board to give the Annual Report and also to request the appointment of Carrie Kadavy to replace Judy DeBuhr along with the reappointment of Kim Siebert to the Extension Board.

Moved by Bulgrin, seconded by Bredenkamp to adopt Resolution #09-86 to reappoint Kim Siebert and appoint Carrie Kadavy to a three (3) year term on the Extension Board; roll call: yeas, Bulgrin, Bredenkamp, Bergen, Neujahr and Brown; nays, none; motion carried.

Annual adjustments for 2012, 2013 and 2014 will be based on the Midwest Consumer Price Index as established by the Bureau of Labor Statistics, U.S. Department of Labor except when the CPI falls below "0" in any year, in which case the annual adjustment will be no less than "0" and except when the CPI raises above 3% in any year, in which case the annual adjustment will be no more than 3%.

In addition to and in consideration of the above salaries, the following will also apply:

- 1. The County Attorney position shall remain a full-time position with no private practice allowed.
- 2. The Public Defender position shall remain full-time.
- 3. The Deputy Public Defender position shall remain discontinued.

4. The County on an annual basis during the term of this Resolution reserves the right to contract out or enter into an agreement with an Elected Official or officials who are qualified to serve as a budget-making authority as may be approved by the Board. It is the intent of the York County Board that if an agreement is made with an Elected Official, that such agreement shall not constitute an increase in the herein adopted salary but shall be and is a part of the agreement. If the Board contracts with an Elected Official to serve as the budget making authority, that official shall be allowed an additional amount not to exceed \$1,500.00 for performing those duties.
