Evening Post 20 Mar 1908 Local and General

An option for the purchase of a certain section of land was the centre of dispute in a case taken in civil jurisdiction by Mr Riddell, S.M., yesterday afternoon. The plaintiff in the case, Daroux, photographer, Wellington, sued Alexander Anderson, sawmiller, for the sum of £44, being the amount alleged to have been promised by the defendant to the plaintiff in consideration of the latter's foregoing the option on a section of property at Akatarawa. Breach of contract was alleged against the defendant. The evidence showed that the defendant gave the plaintiff an option on this section, and the latter sold the place. For the defence it was contended that the place was actually sold with the option still on it. Judgment for the plaintiff for the full amount, and costs £4 2s, was given by his Worship. Mr Dix appeared for the plaintiff, Mr Blair for defendant.

Evening Post 09 Feb 1910

A complicated claim for £51 2s damages held the attention of Mr Haselden, S.M., in the Magistrate's Court this morning. The plaintiff was Louis Daroux, of Wellington, photographer, and the defendant Charles Harper, of Wellington, commission agent. The action arose out of an order made by one E. P. Pointon, of Petone, authorizing the defendant to pay the plaintiff, £49 out of moneys received by the defendant from a mortgage on the security of a house in Queen's-road, Lower Hutt. It was alleged that the defendant had declined to make such payment. The main point of the case was in the wording of the order, which mentioned that payment of the money was due as soon as it was in the power of the defendant to pay. After hearing evidence and argument by counsel, his Worship reserved judgment. Mr Dix appeared for the plaintiff, and Mr Young for the defendant.
