## Obama Martial Law Nearing?



### Obama NO authority to use military against citizens !

However, a disturbing **POLICY** has been discovered in a 2010 Pentagon directive on military support to civilian authorities: In times of civil unrest, the Obama administration is authorized to use military force against citizens.

The directive is dated less than a YEAR after the most anti-citizen, anti-elder, pro-illegal immigrant, pro-blanket amnesty, anti-veteran and military president and administration in American History.!. It shows what millions of us consider to be his true intent for the installation by force of a socialist state with only the meaningless framework of the Constitution he so disdains, though he is sworn to defend and uphold same against all enemies ;foreign and domestic.

The troubling aspect of the directive outlines presidential authority for the use of military arms and forces, including unarmed drones, in operations against domestic unrest.

"This appears to be the latest step in Obama's decision to use force within the United States against its citizens," said a defense official opposed to the directive.

Directive No. 3025.18, "Defense Support of Civil Authorities," was issued Dec. 29, 2010, and states that U.S. commanders "are provided emergency authority under this directive."

"Federal military forces shall not be used to quell civil disturbances unless specifically authorized by the president in accordance with applicable law or permitted under emergency authority," the directive states.

"In these circumstances, those federal military commanders have the authority, in extraordinary emergency circumstances where prior authorization by the president is impossible and duly constituted local authorities are unable to control the situation, to engage temporarily in activities that are necessary to quell large-scale, unexpected civil disturbances" under two conditions.

The conditions include military support needed "to prevent significant loss of life or wanton destruction of property and are necessary to restore governmental function and public order." A second use is when federal, state and local authorities "are unable or decline to provide adequate protection for federal property or federal governmental functions."

"Federal action, including the use of federal military forces, is authorized when necessary to protect the federal property or functions," the directive states.

Military assistance can include loans of arms, ammunition, vessels and aircraft. The directive states clearly that it is for engaging U.S. civilians.

While the directive bans the use of missile-firing unmanned aircraft against citizens, it permits the use of unarmed drones.

This revelation comes during a strange trend of non-security-related federal agencies building up SWAT teams. Why in the world does the Department of Agriculture need a Special Weapons and Tactics Unit?

Obviously, illegal alien Usurper Barack Obama preparing for war against the American Citizens. Every member of the military and LEO must acknowledge the fact that Barack H. ### Bill of Impeachment

But fifty other countries, including Switzerland, are bending over backwards to comply with Obama's new IRS one world economy law.

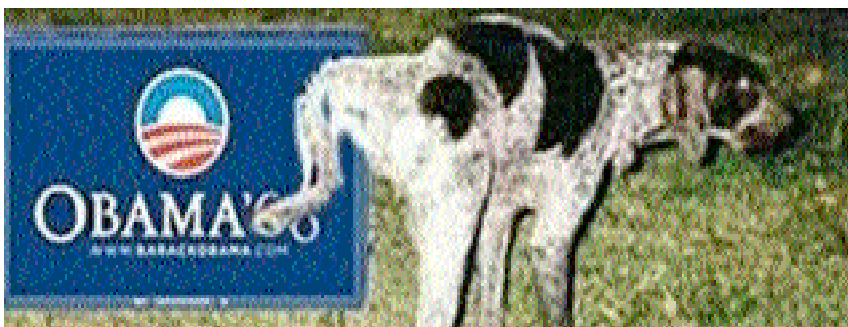

He added his bakery has been so overwhelmed by supporters eager to buy cookies and brownies that he does not currently make wedding cakes.

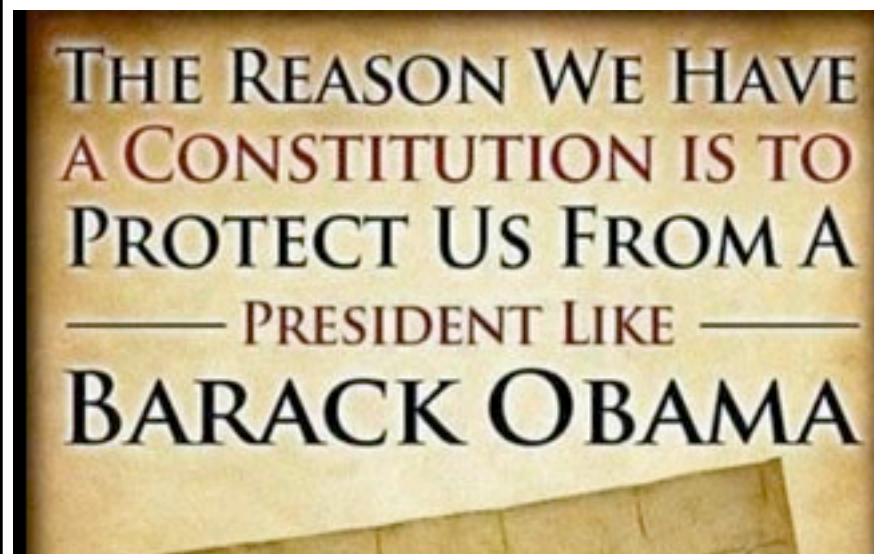
The homosexuals who sued Phillips, were pleased that the judge rejected Phillips' religious rights arguments. "We're just thrilled by that," Mullins said.

## GOOD News! Obama Banking Extortion of Gun Shops Is Defunded by U.S. House!

Obama's 'Operation Choke Point' intended to kill gun shop businesses.

Operation Choke Point has caught the attention of lawmakers in Congress, who have called for investigative hearings and potential legislation if the operation isn't stopped. Operation Choke Point was found to be cutting off legitimate businesses from banking line.

The House of Representatives passed an amendment Thursday to stop all federal funding to be used for the Department of Justice's Operation Choke Point, an anti-fraud operation that was found to be cutting off legitimate gun shop businesses from their banking credit lines. The extraordinary breadth of Obama's DOJ Operation Choke Point is not to cut off actual fraudsters' access to the financial system but rather to eliminate legal financial services to gun shops, the congressmen said in their letter.

"This is a major victory for consumers, law-abiding businesses, and anyone who believes in due process and restraint of government encroachment," said the Community Financial Services Association of America, a trade group opposed to the operation, in a statement Friday. "Additionally, our banking system benefits as it will not be put in the position to police customers or make judgments about the political popularity of businesses and industries."

The amendment was brought to the floor by Rep. Blane Luetkemeyer, a Republican from Missouri, who is a member of the House Financial Services Committee and is vice chairman of the House Small Business Committee. The amendment was sponsored by three democrats and two more republicans.

The voice vote came as part of the debate on the annual spending bill for the Justice Department and needs Senate approval to become law.

A House panel Thursday said the Obama Administration has been using Operation Choke Point to target and "choke out" businesses it finds objectionable, especially gun dealers.

In a scathing letter to Attorney General Eric Holder in January, Republican Reps. Darrell Issa of California and Jim Jordan of Ohio requested all federal documents related to Operation Choke Point. Mr. Issa heads the House Committee on Oversight and Government Reform, and Mr. Jordan is a member of Mr. Issa's panel and the House Committee on the Judiciary.

"[Obama/Holder DOJ] has very clearly told the banking industry which customers they feel represent 'reputational risk' to do business with," said attorney Peter Weinstock: Any companies that engage in any margin of risk as defined by [Obama/Holder] are being dropped."

Gun retailers say their businesses are being targeted by Obama's DOJ:

- T.R. Liberti, owner and operator of Top Gun Firearms Training & Supply in Miami, has felt the sting firsthand. Last month, his local bank, BankUnited N.A., dumped his online business from its service.

An explanatory email from the bank said: "This letter in no way reflects any derogatory reasons for such action on your behalf. But rather one of industry. Unfortunately your company's line of business is not commensurate with the industries we work with." Obviously, Obama/Holder made it happen.

# Obama's DHS Says Medicare Must Pay for Sex Change Surgery, not false teeth?

America is becoming Obamafied!!! Homosexualized ! Tax Slaves !

SexChanged or transgender people enrolled in the U.S. health program for the elderly and disabled can no longer be automatically denied coverage for sex reassignment surgeries, a Department of Health and Services review board ruled Friday. The groundbreaking decision recognizes the procedures as a medically necessary and effective treatment for individuals who do not identify with their biological sex.

Ruling in favor of a 74-year-old Army veteran whose request to have Medicare pay for her genital reconstruction was denied two years ago, the agency's Departmental Appeals Board ruled that a three-decade-old rule excluding such surgeries from the procedures covered by the program was unjustified.

"Sometimes I am asked aren't I too old to have surgery. My answer is how old is too old?" the veteran, Denee Mallon, said in an email interview before the board issued its decision. "When people ask if I am too old, it feels like they are implying that it's a 'waste of money' to operate at my age. But I could have an active life ahead of me for another 20 years. And I want to spend those years in congruence and not distress."

Jennifer Levi, a lawyer who directs the Transgender Rights Project of Gay & Lesbian Advocates and Defenders in Boston, said the ruling does not mean Medicare recipients are necessarily entitled to have sex reassignment surgery paid for by the government.

Instead, the lifting of the coverage ban means they now will be able to seek authorization by submitting documentation from a doctor and mental health professionals stating that surgery is medically indicated in their individual case.

"They should either get coverage or, at a minimum, receive an individualized review of the medical need for the specific procedure they seek, just like anyone seeking coverage for any other medical treatment," Levi's organization said in a statement after the ruling was issued.

Transgender health advocates said that because private insurance companies and state-run Medicaid programs that provide health insurance for low-income individuals often take their cue from the federal government on which treatments to approve or exclude, the decision could eventually pave the way for sex-reassignment surgeries to be a routinely covered benefit.

No statistics exist on how many people might be affected by the decision. Gary Gates, a demographer with The Williams Institute, a think tank on LGBT issues based at the University of California, Los Angeles, has estimated that people who self-identify as transgender make up 0.3 percent of the U.S. adult population. Over 49 million Americans are enrolled in Medicare.
