Thank You for Making Our Victories Possible



Dear Friends,

Every time we put together our annual report, we're amazed at what we've accomplished for cats in just one year. And we're reminded that our donors make so much positive change possible for cats and kittens around the country. This year was our most successful ever. Thanks to your continued support, cats and kittens across the nation have better lives.

In 1990, when we started this critical work, we would have never thought we'd come this far, this soon. But 23 years later, we've changed how the entire nation views and treats cats. Humane policies and programs for cats are decidedly mainstream, and Trap-Neuter-Return is more accessible than ever.

But we have much more work to do.

In many communities, it is still common practice to catch and kill cats who spend time outdoors. Every year, millions of cats are killed in pounds and shelters. The shelter system continues to impound unsocialized cats, even though they are not adoptable and are almost always killed.

Alley Cat Allies has already made great strides in changing this system, and we won't stop until every cat in every community is safe. In fiscal year 2013, we extended our reach by working side by side with more communities and shelters to help them implement policies that save cats' lives.


This year, your support helped our legal team write a landmark report showing how effective and widespread TNR is—and we found that there has been a tenfold increase over the past decade in the number of counties and cities that officially endorse TNR, with more than 330 municipalities supporting this humane and effective program, as of the summer of 2013.

We've built critical momentum in the movement to protect cats—and we took advantage of that momentum this year to push for even more progress. We helped municipalities everywhere from Florida to Maryland to Texas replace decades-old animal control ordinances with policies that support TNR. We launched a proactive campaign to save Alabama's spay/neuter clinics. And our Changing Communities for Cats tour took us to Fort Lauderdale, Fla.; Dallas/ Fort Worth, Texas; and Chicago where we met with compassionate supporters to discuss how we can work together to create sustainable change. As a result, the lives of countless cats were saved.



This year we also helped Florida reach an unprecedented legal milestone for animals in shelters. Thanks to your support, all public shelters in Florida must now report the number of animals they adopt, transfer to rescue groups, TNR, and kill. The new law also confirms that TNR is legal in Florida!

Throughout the year, we made sure that compassion triumphs over cruelty. Your support allowed us to be there, on the ground, when two communities—East Feliciana Parish, La. and North Ridgeville, Ohio—needed our support after horrific incidents of animal cruelty involving cats. We were also there providing aid and support when cats needed us after the tornados in Oklahoma and after Superstorm Sandy in New Jersey.



Alley Cat Allies supporters' voices were heard when we delivered a petition signed by more than 55,000 people to the Smithsonian Institution to protest a controversial study that falsely blames cats for declining bird populations. Your support helped us launch a bold new website, CommonSenseforCats.com, which explains the massive failure of catching and killing cats and debunks misinformation about outdoor cats.

Thanks to the Alley Cat Allies network that you helped build, we've been able to expand our education efforts to make sure veterinarians,

shelter staff, local officials, and everyone else knows that TNR is the only humane and effective approach to outdoor cats. In this fical year, we had our most successful National Feral Cat Day[®] yet with 450 events. We spread the message of humane care for cats to even more people through our new webinar, Helping Cats in Your Community, which teaches the basics of TNR, and hundreds of people have taken advantage of this free resource to learn how to care for feral cats humanely.

This year, we protected more cats' lives, supported more caregivers and advocates, helped more communities, and brought more Americans to the national movement supporting the humane care of cats. None of this work happens without your generous support.

Thank you so much for your support in 2013 and the years to come. No doubt, we will always face some challenges and hurdles, but with compassionate, committed donors like you on our side, we will always persevere. We look forward to continuing to work together, and we look forward to reporting back in next year's letter on how far we've come in our work to protect the lives of all cats.



Sources of Income and Expenses

In fiscal year 2013, our generous supporters provided the resources that Alley Cat Allies needed to continue our work to transform and develop communities to protect and improve the lives of cats. In total, Alley Cat Allies received more than \$7 million in support between Aug. 1, 2012 and July 31, 2013.

Alley Cat Allies relies on individuals for support. We received no government or corporate grants and less than \$15,000 from foundations. In fiscal year 2013, more than 100,000 individuals contributed.

These contributions were put to efficient use this year advocating for our nation's cats. Alley Cat Allies spent more than \$6 million on programs. Of the total expenses, 83% was for programs, 6% went to management and general administration, and 11% was spent raising funds.
