# **2013 HUMANOID SIGHTING REPORTS**





1. Location. Keswick, Ontario, Canada Date: 2013 Time: 03:00 a.m.

The witness was in bed sleeping when at approximately 3 a.m. he was awoken after feeling something touch his forehead. He opened his eyes and saw that his bedroom was flooded in a sort of red glow or color. He was lying on his back and he looked up the wall above his headboard and was shocked to see a "doorway" (portal?) coming out of the wall. There were two men side by side, and he could see a stairway going up into total darkness. The men appeared to be wearing leather jackets. They appeared to him as human and both had thick wavy black hair. One of them pointed what he thought was a gun at his forehead and for a second, he really thought he was going to be shot in the head.

He was partially paralyzed, but was able to raise his right arm enough to actually get a hold of the man holding the "gun" wrist. He then saw what looked like tiny blue lights where the open end of a gun's barrel would be. There was a red dull white light slightly larger than the tiny blue lights which went around the tip of the "gun" in a circle. He then realized that it was not a gun, but it was roughly the same shape of a handgun, only a little thicker down the barrel and tapering off where the lights were. It appeared to be made of some sort of shiny plastic. They placed the tip of the gun-like instrument against his forehead and at that point both men had a "perplexed" expression on their faces. It appeared that they were confused at whatever it was they may have been expecting to see. He managed to push the man's wrist up and away from his head, with what seemed to him with very little effort. He had the feeling that the 'men' were not allowed to resist him if he attempted to push them away. That is why he reasoned, afterwards, that he managed to push his hand away so easily. Suddenly they were just gone, and the wall was normal again. It took a while for him to be able to move normally, and he was able to see that his wife had slept right through the entire episode. There was a dim red glow on his ceiling for about ten or so minutes after they had disappeared. He could see reddish traces on the tiny lumps of his stucco ceiling for quite some time as it slowly dissipated. According to the witness he did not experienced any fear, except maybe at the time when he thought he was going to be 'shot', but even then not as much fear as he would have expected. It seems to the witness that the men, whoever they were, were able to control his emotions and his body. His wife has no recollection of anything out of the ordinary, or did his three adult sons. He has not had any further incidents.


Date: January 2013 Time: 1400

The witness, who was traveling ahead of the others signaled that he had to stop in order to satisfy a physiological need. He drove his 4-wheeler next to an irrigation canal which had on the other side woods and the mountains. As he performed his necessities he heard a noise behind him and when he turned to look he was speechless to see a strange creature about 20 feet away from him, walking very slowly in his direction. It was the strangest creature he had ever seen and was completely black, about 5-feet tall and walked upright like a human but it had rather long dangling arms which reached its ankles. Its legs were short and somewhat arched which made it looked "curved" like an old man. The witness could not see any facial features. Location. South Greensburg, Pennsylvania

Date: January 1 2013 Time: 15:00

Two women and a young boy decided to take a walk through a wooded area near South Greensburg to enjoy the beautiful scenery. It was about 32 degrees and clear visibility in the area. The area had a cover of snow from a previous storm. Around 3 p.m. the three people advanced into the woods and were looking at a tree that still had leaves on it. When they were about 20-25 feet from the tree, the two women saw something that startled them. The boy was apparently looking elsewhere. They both at the same time stated, "Did you see the size of that bird?" What they observed was what appeared to be a bird unfolding its huge wings. A witness described the wingspan as being approximately 6-7 feet wide, and described how the creature unfolded it's wings and almost rolled them out, flapped them once and folded them back up as it moved along the ground behind the tree.

They immediately moved towards the area where the creature had been seen. They were only 20-25 feet away, yet when they got to the spot, the creature was nowhere to be seen. There weren't that many trees at that location, and the area was quite open. There were no bird tracks at the location, just deer tracks. They heard no sounds of flapping or other sounds when the sighting occurred. The two women were mystified as they could not explain how the winged creature seemed to suddenly disappear. As one of the women commented, "We would have seen it fly away but it didn't". The wings were described as black and gray in color. One woman said she thought she saw a blue tinge within the wings as well. The source asked one of the local bird experts for his thoughts. Both of them thought that the most likely candidate for what was observed was a Great Blue Heron which are seen around this area. The coloring would fit as well. He also speculated that if there was a crust on the snow cover, possibly the bird did not break through and leave any tracks. Another possibility is a Sandhill Crane. He said that the wingspan and coloring is quite similar to the Great Blue Heron. This man thought it was quite odd that at 25 feet distance the witnesses could not identify the bird if it was a Heron. He

also indicated the Great Blue Heron does not fly fast as it lifts off to become airborne, and thought it was unusual that the women could not see it fly away from that nearby location. This baffles the witnesses as well.

Greg Posada and Eugene Pointer called the paranormal hotline with their report of two werewolves seen near Grass Lake. They claim that these two creatures that appeared to be werewolves were definitely bi-pedal. One of the creatures had grayish hair, while the other had brownish hair. Both creatures had snouts. The witness was outside in the backyard when the object was first seen. "I heard something humming behind me," the witness stated. "Looked behind me to find a giant, black triangle-shaped craft hovering above the power lines behind my house." The object was first visible in a reflection. "I first noticed the object through a reflection on my screen door so I turned around and the craft just hovered above the power lines behind my house. It had a few windows around it and a small beam of light had shot down from the middle below the craft." The witness described the object as black in color and shaped as a triangle, with about four giant circular lights below the craft all completely white in color, and then the middle light shot down this large beam of yellow light down onto the power lines which affected the witness' cellphone.

It had maybe about five windows on the front side but he saw absolutely no one onboard until the craft changed directions and then he saw about 10 small, 4-feet

tall figures aboard the craft looking down at either the controls inside the craft, down at the power lines or down at the witness. The witness felt completely shocked and once it started leaving he followed it until the fence cut him off in his yard and then just continued staring at it until it left at fast speed.

Date: January 14 2013 Time: 19:43

The witness (involved in a previous encounter) would normally head outside his backyard around 7:00 pm to get some fresh air. He stepped outside for around thirty minutes and continued standing in the middle of the yard just looking around in the sky with his binoculars. Around 7:43 pm something caught his attention, he happened to glance out to his left to see something that looked like a huge chunk of metal hovering in the air slowly. He removed the binoculars and stared at the unknown object for around ten minutes. The object stayed in one single place in the sky and never moved for about an hour. He could easily see the object with the naked eye. It was completely dull in color, the shape of a disk and it rotated for around an hour. He estimated to have been the size of a football field and as long as two eighteen wheelers. On the bottom of the craft which was silver in color was what appeared to be burnt marks. Either burnt marks or rust he couldn't tell.

Around 8:01 pm the object hovered closer to his house right over the center of the yard. Its shadow completely covering the yard, he couldn't see much underneath the craft until it stopped rotating. He could count about thirty fiver windows around it, none of which were lit except for two. Strangely enough the craft suddenly emitted a loud humming sound which made the witness to briefly lose consciousness. He awoke several minutes later staring up at some kind of blinding ceiling, the room was wide with some controls and tables and strange looking tools. Out of the corner of his right eye he spotted a figure which looked to be about five feet tall. Behind it was another figure and then another. He counted three in total as they walked towards him and looked down at him. One of the beings began to mumble something in a strange language he couldn't

understand. The being placed its arm behind him as he stood up on the table while the being gave him a strange looking book. He didn't see anything lettering on its cover but inside he saw images or pictures of the human species both male and female. He was made to understand that the human species had overpopulated the earth. The being added that they had been given 'the right' to abduct humans by order of the government and our leaders. The alien claimed that their species was becoming extinct and it was known as the "Vetrolment". The others were standing, looking at her, seemingly as scared of her as she was of them. They had slim, humanoid bodies, proportional heads and bodies, with no more than 10-20% body fat. Their faces were flat, he couldn't see their noses and mouths, and he couldn't see any genitals. They had the darkest bushiest eyebrows/eyes and were composed of only 2 colors, with their bodies a dark gray, and their eyes, the darkest charcoal gray. "They looked like Spiderman's enemy, Venom, only smaller versions." The witness got up and yelled, "Oh my God, oh my God!!" ran past them (because the bedroom door was behind them) into her daughter's room. When she came back about 2 minutes later, they were gone.

Time: various

Recently in this area there have been sightings of an entity with simian characteristics, an elongated muzzle and considerable agility apparently related to attacks on farm animals. On this night, at around 23:30 the Hernandez family was in the back of their property involved in an appetizing cookout when suddenly Mercedes Hernandez, who was concerning herself with the meat roasting on the grill, felt "someone" tossing cherries at her. Her first thought was that a family member was playing tricks on her, but faced with the shower of cherries that were falling around her she managed to determine that the action emerged from a nearby tree. The tree was no more than 10 meters distant from the place where the meat was roasting, and she approached it. Her initial impression was to feel that someone was chewing, making noises as they ate something. But upon coming closer, she noticed a pair of shiny, reddish eyes looking at her from the middle of the tree. The being---or whatever it was---rested in a seating position, settling between two branches in a "T" shape. Given the strangeness of what she was seeing,

she immediately called her husband, who also saw the being and thought to grab a water hose to scare it away with a well-aimed stream. While this action was taking place, the strange entity leaped from the tree with tremendous strength, jumping over a wall or partition adjoining a neighboring property, containing pens with geese and ducks. Being that it was a splendid moonlit evening; Mercedes was able to make out the details of the being's physical characteristics.

Mercedes oral description disclosed characteristics similar to other sightings made elsewhere in the world, although here, according to the witness, there was a larger corporal mass, which she noticed when the strange being leaped from the tree to the nearby partition. This sudden action caused several tree limbs to shatter right to the top, even giving the impression that the tree had split in two. Furthermore, Mercedes added: "The leap and the creature's dropping to the other side of the wall was very forceful, and the sound was perfectly audible." 

Rangers patrolling the Way Kambas National Park (TNWK) in Lampung claim to have sighted dozens of pygmies in a number of areas across the park. According to them, the pygmies sport dreadlocks, measure no more than 50 centimeters tall and do not wear any clothing. "A number of rangers claim the pygmies grow their dreadlocks down to their waist. The first sighting by the rangers was on March 17 at 6:40 p.m. local time," said TNWK spokesman Sukatmoko. He added that several rangers patrolling the park claimed the pygmies were seen moving to the PT Nusantara Tropical Fruit (NTF) plantation. They were seen running from the TNWK forest to the plantation.

"Apparently, many fruit trees, such as banana, guava and dragon fruit, are grown in the NTF plantation area. If the pygmies like fruit, they might have entered the plantation for food," said Sukatmoko. Forest rangers have secured a number of points at the border between TNWK and PT NTF, concerned that the safety of the pygmies is at stake due to the presence of many workers at the plantation. "We will try to anticipate the situation with the help of local residents and PT NTF employees. If they come across the pygmies, they should not harm them," he said. Sukatmoko said that based on information conveyed by forest rangers, the group of pygmies consisted of around 15 individuals. When the rangers spotted them, they pygmies, believed to be an isolated group of people, were walking through a swamp. "The rangers monitored their presence for around 15 minutes from a distance of around 35 meters. When the rangers were about to approach them, they immediately hid behind trees and vanished. They ran very fast," said Sukatmoko.

He added that on March 20, patrolling rangers sighted the pygmies again in the same place, but this time they observed from further away and for a shorter time. Sukatmoko said his office was unsure whether the pygmies had always lived in TNWK, or whether they were newcomers from other islands. To record their presence, the TNWK center has installed surveillance cameras in the forest.

"We can record pictures of the pygmies at night. After its proven they exist, we will immediately inform the Forestry Ministry, or even the President," he said. Sukatmoko promised his office would protect the pygmies and not disturb them. "We believe they really exist in TNWK. We're making strenuous efforts to find them. In the event that we do, we hope the government protects them. Our rangers have seen them with their own eyes, but have yet to take pictures of them," he said, adding the center had allowed academics and researchers to trace and study the group. Indonesian Forum for the Environment (Walhi) Lampung chapter campaign director Mukri Friatna said the pygmies had been sighted in a number of forests in Indonesia, such as in Kerinci Seblat (West Sumatra), Liang Bua (Flores) and Bone (South Sulawesi). "In Kerinci Seblat, hey are known as the Orang Pendek (short people), in Flores as homo floresiensis, and in Bone as members of the Oni tribe. In Mount Kerinci, the creature is depicted as having inverted legs but is very agile among the dense foliage," said Mukri.

Mr. Fernando Diaz, a local resident was headed to work as usual Mr. Diaz was driving along PR-3, one of the island's main thoroughfares. They sky was light at that time of the morning, although the sun was not fully out yet. Mr. Diaz was driving his blue 2001 Hyundai Brio at an approximate speed of 35 miles per hour, heading from the town of Guayama to the town of Salinas. As he approached kilometer 3.0, right in front of the facilities of the Division de Transito y Vehiculos Hurtados (Traffic and Stolen Vehicles Division) of the Guayama State Police, he noticed that the vehicle ahead of him began zigzagging, as if trying to avoid something. When he looked he could see something strange coming over the vehicle---something he had never seen before. It was an enormous dark-winged figure that appeared to have collided against the vehicle in front of him, and was trying to stand up in an effort to take flight. His first impression was that it was a gigantic bird. The creature never had enough time to get up off the ground and struck the grille of Mr. Diaz's car head-on. With the same momentum, it continued sliding along the vehicle's hood until it struck the windshield, continuing to slide off the hood. Mr. Diaz stepped on the brake, terrified at the sight, and brought his vehicle to a sudden halt. Luckily there were no cars behind him. After stopping, he looked through the rear-view mirror to see exactly what he had hit, but was unable to see anything. Although the event lasted only seconds, Mr. Diaz was able to take in considerable details of the creature that hit his car. According to his description, the creature had a broad face like a Pit-bull Terrier. It had as short snout and nose resembling that of a dog. Its eyes were small, human-sized, but completely dark and glossy. It had something like ears on either side of its head. It had no feathers; its skin was like a bat's and although he thinks it may have had hair, it was short and smooth along the body. The creature was black or dark brown in color, and seemed to have arms aside from wings---that is to say, it had six extremities: two legs, two arms and two wings. Its feet appeared to have multiple toes with claws, and its extended wings resembled those of a bat. Mr. Diaz noted that the wings appeared to stretch out from two to three feet on either side of his vehicle. Mr. Diaz admitted to us that the first thing that came to his mind was that he had seen the 'Devil'.

Despite his fear, he could see that the vehicle ahead of him was pulling into a Gulf station some 400 meters ahead on the right side of the road. Once there, he saw the driver of the other vehicle---a white Toyota Corolla---stepping out. Excitedly, Mr. Diaz asked him: "Did you see that?!" Both drivers spent a few minutes discussing the awful experience, but since they had to reach their respective workplaces, decided to continue their journeys. They decided not to make a formal complaint to the police, since they were certain no one was going to believe them and would probably consider it a joke, and mock them. Mr. Diaz told his co-workers about the event and one of them accompanied him back to the site at around 10:00 a.m. to see if they could find the thing that hit his vehicle, but there were no traces to be found.

that "it" brought "them" there to appreciate this cultural event. He also relayed a very similar occurrence that his family experienced driving home early in the morning on a minor highway in North Carolina. He said that he along with some of his family members noticed a deer and a special type of wolf appearing side by side with them, together besides the highway as they drove by. That was a very unusual event. And 13 weeks to the date prior to the incident the witness and his wife along with two other witnesses spotted a craft flying overhead that was completely silent, as it turned down from the treetops toward and over their heads right above their apartment. The craft was diamond-shaped (four connected objects with a colored light).



The trip was rather longer than she usually drive and after supper in Stockbridge she was getting into the last stretch of the drive on Massachusetts Route 20 looking in vain for the road to the Baird Tavern Bed and Breakfast they had booked for that night. It was just getting toward twilight. They had passed through Lee and were in the area of Becket when she noticed first one and then two cars following her close behind. Both of these cars looked rather identical in the rearview mirror. They were both shiny late model mini-Suv type vehicles and both had their parking lights on but not their headlights. The one directly behind her had tinted windows but she could not tell about the rear vehicle. The parking lights of both vehicles looked absolutely identical and that struck her as slightly odd. She mentioned to her companion that she was about to pull over so these cars could pass her and she could call the B & B for further instructions and then she pulled off to the side of the road at the Becker Fire Station. To her great surprise the cars that were right behind her did not pass her because they had absolutely disappeared. 


Figure 3. Amerindian depiction of the mythic Thunderbird carrying of a whale.

The witness was driving west on New Kent Highway just before route 106, driving under the speed limit of 45 and he came around a bend and slowed down more because about 30 yards ahead of the car a 'huge bird' was in the center of the road, straddling the dotted line with its back to the witness. New Kent is basically a swamp with islands of high ground. Because of the terrain, housing properties are kind of jammed together on "high ground" with lots and lots of alternating hill/steep ravine wooded land of the swampy kind between. They have all kinds of big bird in the area, like Bald Eagles, ospreys, herons, turkey vultures, etc., so seeing a bird on the road was no real surprise.

What made him stop the car 12 ft. away from it was the fact that the 'dang thing's head was taller than his hood!" The witness could feel himself starting to grin, that grin we do get when we just cannot believe what we are seeing and suspect a joke. It then it opened its wings and the witness knew that it was all too serious. He was on a 2 lane country road with gravel shoulders. The thing's wingtips were touching gravel on both sides. With two slow motion swoops (his window was down and his radio was off so he actually heard its wings pushing the air) it was up and blotting out everything else in his windshield, banked left on a wingtip and glided into the woods between the trees. He remembers craning his head over the steering wheel and up to see all of it as it banked.

He has no idea how long he sat there in the middle of the road with his mouth open, totally blank, mentally feeling like he had been slapped silly. The only word that surface was "Thunderbird". When he finally cruised past where it had cut through the woods, he was looking for it, but did not see it. It was dark colored, looked like a dark charcoal color while on the road, but its feathers were a rust red brown when it launched into the sunlight. 



The witness (involved in previous incidents) is suddenly completely aware of being in a very lucid dream in which he found himself in a room that's setup exactly like a "classroom". There are desks and chairs setup in rows. The tiles on the floor are large concrete tiles, not unlike something you'd find in a traditional classroom. To the left, he sees that two floor tiles are missing and there is some kind of device on the opposite wall. Immediately he knows what is going on, so he remains totally calm and becomes highly observant. He is looking at everything he can as fast as he can because he knew "something" was going to happen.

He turns around and looks toward the entrance to the classroom. Beyond the entranceway (he doesn't recall seeing a door) there is a hallway that extends about 30-40 feet ahead. The hallway is very plain and not much to look at. He notices that the lighting is mostly reddish, leaving everything red and black so he couldn't get much detail. He was able to see that the hallway straight ahead came to a "T" intersection. From his perspective he is able to tell there is a hallway immediately to the right outside of the entrance way; he is not quite sure if anything is immediately out of the door to the left. It could have been a wall or another hallway, he really couldn't tell. As soon as he was able to get as much information as he could visually,

He felt like the leader was saying there were two classifications of everything within the universe (and beyond): consciousness and everything else (matter). Consciousness can control its environment, if the consciousness is strong enough. He asked the leader if he was referring to our soul. He replied by saying something along the lines of, "Not in the way you define the word soul." The witness was led to believe that consciousness was everything---the most powerful. Everything was a result of consciousness. He asked if he could try again, and the group obliged. He wanted to think of something random just to test the limits, so he concentrated hard on a bag of "Doritos". A bag of Cool-Ranch Doritos appeared within the hologram and "willed" a smaller bag because he didn't want to eat a full bag (in front of the aliens). The bag manifested in the air and he pulled it down into his hands. He broke the bag opened and ate a Doritos chip---it was perfect, just like the real thing. He was fascinated, so he ate a few chips. One of the crewmembers then said, "I am fascinated by his primitiveness." Apparently the witness took offense to the remark and told the aliens that "they lacked a sense of humor". This led to a sort of a back and forth argument between the witness and the apparent leader. The leader then said that the witness remind him of himself when he was at the witness' stage of development. At this time the leader telepathically "connected" with the witness and created an illusion which both experienced. He found himself in a two room living quarters. Several residents of Vicuña and vicinity have reported the collision of a hitherto unidentified flying object in a hill near Vicuña, in the interior of Valle del Elqui. According to eyewitnesses, who took the photograph attached to this story, the event occurred around 16:00 hours on Sunday when an object---flying at considerable altitude---zig-zagged for a few minutes before plummeting into a hill in the sector known as La Compañia. A worker at a Vicuña hostel (who requested confidentiality) stated that "the object made several turns in the sky until it

began to lose altitude and fall on top of a hill. People began climbing the hill just to see it, but it's rather far away. It's almost the size of a railcar."

The photograph shows an object that shines in the sunlight, suggesting that it could be a metallic object or some sort of weather balloon. It should be noted that this is not the first time that Valle de Elqui has reported UFO sightings. The most spectacular case was the alleged crash of a UFO in Paihuano, which has been studied by a number of Ufologists, although there is no record of the object in question.

(9<sup>th</sup> Region), never imagined she would manage to photograph the above bizarre image. Her intention was to take a photo of the Moon and planet Venus, which shone in the heavens on that date. Mrs. Janette was in the back yard of her home and used her 16.7 pixel Samsung digital camera for this purpose. There was nothing particularly unusual about her surroundings. She even remarked to researcher Raul Guajardo Leopold that there is neither public nor private lighting in this part of her house. She did, however, noticed a sort of spark or noise in the flash at the moment the photo was taken, which we mention for purposes of subsequent analyses. The distance separating her from the shrubs appearing in the photo is some four meters, and their height is also close to four meters. Upon seeing the image recovered from the device, she was rightly astonished to see a transparent entity with light sources in its body over to the right hand side of the photograph. There was no doubt about it: the silhouette of a person with a very clearly defined outline (arms, head and back) could be seen at first sight. All indications are that the being had its back toward the camera and in a diagonal direction (45 degrees).




Figure 8. Image of strange giant figure.
