Upon arrival I contacted the resident,

who stated her husband was at the house retrieving a carpet when they became involved in a verbal dispute over their current marital problems.

MRS. SHEPARD said because of the argument she wanted her husband out of her house. She began to order him to leave when he became angry, and proceeded to grab her right arm and push her.

SHEPARD said she was not injured and requested no medical attention.

who stated he called his wife earlier today and requested to come over and pick-up a carpet for his home. He said she told him it was fine and to come over early in the evening.

MR. SHEPARD said when he arrived his wife immediately began to argue with him and told him to leave the house. He said while he was attempting to load the carpet MRS. SHEPARD began pushing him trying to get him out of the house.
