



November 14th – 17th, 2011 the Department was reviewed for its first reaccreditation by CALEA assessors. The assessors inspected the Department's equipment, policies, procedures, and reviewed 479 files for proof of compliance with CALEA standards. The Department was found to be in compliance with all applicable standards.

GRANT FUNDING

2009 AMERICAN RECOVERY AND RECONSTRUCTION ACT

The Department is in its last year of the Community Oriented Policing (COPS) Grant which was awarded on July 28, 2009 for \$361,464.00. The grant is fully funded by the Federal government which covers the salary of two full time officers that are assigned to the Neighborhood Services Unit. As of the end of 2011 the grant has paid \$247,925.00 towards this program.



NEW FACILITY IN 2011!

New Facility

On April 28, 2011 the Bluffton Police Department held the grand opening of it's state of the art new police facility. This 20,000 square foot building was specially designed to support law enforcement operations.

The \$6.2 million building was designed for lower energy consumption, includes new holding cells, new technology spaces and a crime processing area.

The Town issued general obligation bonds in fiscal year 2011 in order to build the facility as approved by council. The Town obtained its first bond rating in relations to this issue receiving a Aa2 rating from Moody's and a AA from Standard and Poors.

Internal Affairs

The Internal Affairs Section reports directly to the Chief of Police. The section is charged with administering the investigative and disciplinary processes for the Bluffton Police Department. The primary mission is to assure that the police officers and staff servicing the citizens of Bluffton meets the highest standards of integrity and ethical performance. In 2011 there was only one (1) internal affairs investigation involving one (1) officer. This investigation was sustained and resulted in resignation in lieu of termination.

Public Information Office

The Public Information Office is responsible for establishing positive and productive relationships with the public and news media outlets. This office is responsible for releasing information to the public as directed by the Chief of Police. This office is also responsible for developing and implementing programs that serve to publicize the positive aspects of the Police Department's efforts in serving the public interest.

In 2011 the Department released 59 press releases and the website had 14,331 visitors.


Neighborhood Services Unit—NSU

In 2011 NSU worked on a number of activities employing the S.A.R.A. Model. During this year they assisted 14 communities with assessing their traffic concerns, addressed 10 non-related traffic concerns, attended 31 community meetings and participated in 41 community activities (parades, educational events, etc). They are also members of the Town of Bluffton Development Review Committee (DRC) which reviews development plans. They implement use of Crime Prevention Through Environmental Design (CPTED). CPTED is a multi-disciplinary approach to deterring criminal behavior through plan environmental design. **Neighborhood Services Unit (NSU)** is staffed by two full-time granted funded officers whose primary mission is to work with community leaders, organizations, businesses, and citizens on resolving long term problems.

In order to establish an effective long-term solution, the cause(s) of a problem and the underlying factor(s) must be accurately identified. The NSU uses a problem solving framework known as the S.A.R.A. Model. S.A.R.A. Model stands for:

- 1. Scanning Identifying the Problem.
- 2. Analysis Learning the problem's causes, scope, and effects.
- 3. Response Acting to alleviate the problem.
- 4. Assessment Determining whether the response worked.

In using this approach, a problem is defined as: A group of incidents occurring in a community that are similar in one or more ways, and are of concern to the police and the public.

OPERATION DIVISION

OPERATION DIVISION

The Operation Division is the largest and most visible division in the Bluffton Police Department and is commanded by Captain Bryan J. Norberg.

The Operation Division consists of Uniform Patrol, Marine Patrol, and the Traffic Unit which provides the primary response to all calls for service.

The Operation Division also enforces all criminal and traffic laws.


Committed to the philosophy of community policing, and working in partnership with the community, the Operation Division strives to deliver quality service with professionalism and integrity.



Patrol Division


The patrol officers are the primary response to citizen complaints and calls for service. They enforce state laws, local ordinances and traffic laws. They are also responsible for proactive patrol functions within the 54 square miles of the Town. We responded to 29,177 calls for service which is a **32.8%** increase from 2010. With the increase call volume there was a decrease of **5%** in overall criminal activity.

Traffic Enforcement

In 2011 there were 511 traffic collisions investigated by the Bluffton Police Department. This is a decrease of 5% from 2010 (539 collisions investigated). Of the 511 traffic collisions investigated, 371 were on state maintained roadways and 140 were on private property.

To reduce traffic collisions, the Department stringently enforces all traffic laws. In 2011 5303 traffic citations and 5920 written warnings were issued.


The Support Division is commanded by Captain Angel Tubbs. Support Division consists of the following units: Investigation Unit, Crime Analysis Unit, School Resource Officers, Victim Advocate, Records Management, Evidence Section, Human Resource/Training, Crossing Guards and Volunteers.

Criminal Investigations

The Criminal Investigations consists of a group of highly trained investigators that are skilled in all areas. They are responsible for the follow up investigation of incident reports received from the Uniform Patrol Division. This division has attended many schools and seminars each year to keep abreast on the latest investigative techniques and everything from lifting fingerprints to collecting specimens for DNA analysis.

In 2011, the aggressive approach of the Criminal Investigation Division helped decrease the overall criminal incidents by 8% compared to 2010.

Unfounded: False or mistaken report, or occurred in another reporting jurisdiction



School Resource Officer

The Bluffton Police Department currently has three **School Resource Officers (SRO)**. One SRO is assigned to each of the Bluffton area middle and high schools: Bluffton Middle School, H.E. McCracken Middle School, and Bluffton High School.

An SRO has a diverse roll in the school community and has many duties and responsibilities, and performs three major roles: (1) a law enforcement officer; (2) a lawrelated counselor; (3) a lawrelated educator. As a law enforcement officer, the school becomes the officer's area of responsibility. SROs are responsible for investigation violations of criminal law and when appropriate make arrests. An SRO's sworn duty to enforce the law does not contradict the need for the SRO to be a positive role model; it in fact supports it.



South Carolina SRO of the Year

Congratulations to Cpl. Michael Creason on being named South Carolina's School Resource Officer (SRO) of the Year. He has been the SRO at H.E. McCracken for three years, working with students, parents, school administrators and neighboring law enforcement agencies to create a safer environment at the school and surrounding community.

"Cpl. Creason is not only a police figure to the students of H.E. McCracken, he is also a mentor," Police Chief David McAllister said.

The Bluffton Police Department currently employee six (6) Crossing Guards that work at area schools assisting students crossing the roads.


Victim Advocate


The role of the Victim Advocate is an essential part of the service we provide to the citizens of Bluffton. This position serves to provide crucial support to individuals that have been harmed, and need help in the Criminal Justice System. The Criminal Justice System can be a confusing process to understand. The Victim Advocate guides victims through the criminal justice maze and assists victims in obtaining services and benefits when they have no means of their own.

The majority of the Victim Advocate's work is with criminal domestic violence victims and domestic related calls. The Victim Advocate follows up on all these incidents to ensure the victim is aware of their rights, the court date and time, and other protections granted under the law. The Victim Advocate provides transportation to and from court for victims. Also, if necessary, will find a safe location for the victim to reside until other arrangements can be made.



Property and Evidence Section

The Property and Evidence Section inventories and secures all items impounded by police personnel, including recovered stolen property, evidence from criminal investigations, and seized weapons/narcotics. This area is strictly secured and no unauthorized personnel outside of this section are allowed entry, to prevent contamination of evidence and adherence to chain of custody legal requirements.

In 2011 842 individual items of evidence in 343 investigations were processed.




Crime Analysis Unit

Federal, state and local laws can change rapidly and law enforcement must be well informed on a timely basis. The Crime Analysis disperses intelligence Unit bulletins as the information is disseminated. In, 2011 the unit issued 23 intelligence bulletins which included Officer Awareness, Officer News, Officer Safety, and Officer Training bulletins.

In addition to these responsibilities, the unit analyzes all crime data to assist command staff on the allocation of patrol units and crime trends. Also, this unit provides valuable intelligence on suspects which provides investigators with leads to follow.

Training and Human Resource Unit

The Training and Human Resource Unit is responsible the training of all officers and civilian staff. In 2011 the Department began an intensive in-house training program. This effort was designed to reduce cost, yet still provide a high level of training to the officers to maintain critical skills and develop new ones.



Multi-Jurisdictional Drug Task Force

The Bluffton Police Department has been a member of the **Multi-Jurisdictional Drug Task Force** operated by the Beaufort County Sheriff's

Office since 2010. The Drug Task Force is made up of five agencies; Beaufort County Sheriff's Office, Beaufort City Police Department, Jasper County Sheriff's Office, Naval Investigative Service and the Bluffton Police Department.



The Department has one (1) full time sworn officer assigned to this detail. They conduct investigations

into drug activities throughout Beaufort and Jasper Counties.
