OMX and Swedish Institute for Financial Research, SIFR, institute the "Olof Stenhammar professorship in financial entrepreneurship". The possessor of the professorship will conduct research in financial entrepreneurship and promote research and higher education in financial economics and also promote debate about the financial sector.

The professorship is formed in cooperation with a Nordic university or institute of higher education and the research will be held at SIFR. The creation of the professorship is a part of a broader long term cooperation between OMX and SIFR, where the first part runs for five years.
