KAVALI MUNICIPALITY

Kavali Municipality was established in the year 1967 as 3rd Grade Municipality and upgraded as 2nd grade Municipality. As per 2011 census the Population of this Municipality is 82142. This Municipality is having 37 Election wards with 17 notified and 8 Non-notified slums. This Municipality around extent is 22.95 Sq KM the N.H.5 runs through the castern outer limits of the town. The Railway line which is the longest roote in India i.e. from Chennai to Howrah also runs through the heart of the town. The town is an educational center, and having the Textile Business with familiar to adjacent areas. To upgrade this Municipality as Grade - I category the proposals were submitted to the Commissioner and Directorate of Municipal Department Andhra Pradesh, Hyderabad through the Collector and District Magistrate vide Roc.No.D3/7291/2002.Dated 18-12-2002. The proposals are pending with Government. The following scheme works are ongoing in this Municipality.

WATER SUPPLY:-

The Drinking water supplies through the 6 O.H.S.R.S to the distribution line in addition to the S.S tank water. There are nine pumping station with open wells. The water supply is directly connected to the Two hundred public taps in the town and 2952 house service connections are available in Kavali Town. There are 550 bore wells are in the town. Out of 550 bore wells 520 bore wells are suitable for drinking water purpose, remaining are Utilised for other purpose. The Government have sanctioned an amount Rs.20.00 crores under U.I.D.S.S.M.T Scheme for additional 4. O.H.R.S and remodeling of pumping mains and distribution lines. The works are being executed by the Public Health Engineering Department and the same are under progress.

UIDSSMT: Water Supply improvement scheme:-

The Scheme Project report with an amount of Rs. 200.00 Lakhs are proposals are submitted to the Government. The same were approved by the SLSC and the works were executing by the Public Health Department. 90% works were completed and remaining is under progress.

ASC GRANT:- Under ASC Grant 2010-11 Rs. 30.00 lakhs were released to this Municipality. With an amount of Rs. 30.25 lakhs. A Generator was purchased for continuous water supply to the town. The work is completed in the Year 2011-2012. Rs 5.00 lakhs were released for flushing of bore wells and Supply of IM-II Bore well materials. The Work order has been issued for Completion of the work.

OFFICE BUILDING :-

An amount of 50.00 Lakhs is released to this Municipality, for construction of new office building and the office building work is completed. The building was inaugurated on 24/08/2008 by the Hon'ble Member of Parliament [Lok-Sabha], Member of Legislative Assembly, and an additional amount of Rs.30.00 lakhs is released to this Municipality to provide the facilities like furniture to Council hall, Electrification, Water supply, Sanitation, Painting, Skirting with tiles. The work is completed.

I.H.S.D.P : -

Under this programme phase-I and phase-II proposals are approved by the State Government with a sanctioned amount of Rs. 171.71 Lakhs under Phase-I, and Rs. 498.73 Lakhs under Phase –II, to provide the basic amenities to the Urban poor people settled in Pullareddy Nagar and Budumgunta. Out of which Rs.139.35 Lakhs is released under phase-I and Rs.359.15 Lakhs is released under Phase-II. Out of the Sanctioned works 95% of works are completed. with an amount of Rs. 498.50 Lakhs and an amount of Rs.496.54 Lakhs paid to the contractors for the executed works. A letter was addressed to the A.P.U.F.I.D.C for Sanction of Rs.50.00 lakhs to complete the remaining on going works.

An 4. amount of Rs.1, 20,000/- was sanctioned and released to this Municipality to produced the training to qualified SHGs in Training Centers. Nearly 500 members were trained in Tailoring, Computer, Saree Rolling, Design etc., under this component.

The Revolving fund amount were released to eligible Podupu Member is Rs. 1,000/- paid to 396 members among 29 Podupu Groups.
- 6. **INFRASTRUCTURE:** No Grant was released till today under this component.
- 7. **COMMUNITY STRUCTURE:** No Grant was released till to day under this component previously Rs.5.30 Lakhs were leased and kept in separate account, Orders are awaited from the Commissioner and Director of Municipal Administration, Andhra Pradesh, Hyderabad to utilize the said amount for construction of community hall proposals pending in office of the Commissioner and Director of Municipal Administration, Andhra Pradesh, Hyderabad.

SPECIAL COMPONENT PLAN:-

5 works were with an estimated cost of Rs.7.25 Lakhs for providing pipeline to Schedule Caste localities taken by the Public Health Department. 5 works were completed 1 work with an estimate cost of Rs.2.32 Lakhs is proposed and it is under process.

TRIBAL SUB PLAN :-

Towards providing Pipelines in Schedule Tribe localities with an estimate cost of Rs.6.75 Lakhs are taken up and completed by the Public Health Department. Recently an amount of Rs.6.32 Lakhs were released to P.H. Department to Complete the work under water supply pipelines.

RAJEEV VIDYA MISSION GRANT :-

The Project Officer Rajeev Vidya Mission (S.S.A) Nellore has sanction the fourteen (14) toilets to Municipal Schools with an estimated cost of Rs.4.20 Lakhs and released Rs.4.20 Lakhs 13 works were completed. Remaining 1 work is under progress.

UPADHI :-

An amount of Rs.1.00 lakhs an utilized for providing basic amenities Dr. Reddy's Foundation lab Hyderabad were taken up the training programme in Municipal Elementary School located in Tummalapenta Bus Stand to produced the Training to eligible Group Members 200 members are trained up in the said Computer Training Programme with the Collaboration of Kavali Municipality.
