19) What attracted you to a judicial career?

I have never been one of those individuals who always aspired to be a judge. In my professional career I have always endeavored to be the best at what I was performing. From my first job as a lawyer I was honored to work among lawyers and judges who fostered a mentoring, collegial atmosphere that taught me the art of being an excellent attorney. I have endeavored to do the same.

Several years ago I was asked by a broadly experienced group of lawyers to consider submitting my name for a judicial position. I was honored and humbled by that request. Since that time I have considered that opportunity as part of professional growth. After extensive experience in trying the most complex factual and legal issues as a lawyer, I was selected and appointed a Circuit Court Judge Pro Tem/Juvenile Referee. My experience in that position has added to the experience that I gained as a trial attorney; giving me the kind of background that will be of the greatest benefit to the legal community and society in general.

I have brought to the bench the same work ethic that I have applied to my caseload. With the growing burden of increasing number of cases, a judge must have that work ethic. There is a great need to find a skilled, practiced lawyer to serve as a judge. I have those qualifications and am suited for that position.

Citizens should expect that kind of broad, lengthy, and practical experience in the courtroom from someone who is elected as a judge.

20) Briefly describe your philosophy of the judicial role, the qualities that are most important for the role, and the greatest challenges to the role.

The judge's role is to decide legal or factual issues put before him or her by the parties to a case. It is not the role of a judge to insert issues into a case that the parties have not submitted to the court. At the same time the judge is responsible to ensure that the rights of the parties are protected and the law is upheld. A judge should be interpreting the law as adopted by the people or the legislature. A judge should not be substituting his or her political judgment for that of the people or the legislature. A judge must have a great depth of knowledge of the law and experience in handling cases in court. It is only through that repetitive exposure to the most complex legal and factual issues over an extended professional experience that judges are able to render the judgments that litigants and society deserve. In addition to that level of knowledge and experience, a good judge must have common sense, humility in dealing with people, ability to communicate in writing and orally, and, most of all, a good sense of humor.

21) Briefly describe a case, or a legal issue on which you worked, of which you are particularly proud, or which is reflective of your legal ability, work ethic, judicial philosophy, or temperament.

Among the many complex cases that I tried in over twenty five years it is difficult to choose one case or issue over the rest. However, one of the greatest compliments that can be given to a trial attorney is that the attorney handled a hard case vigorously and with professionalism towards others. During the successful trial of such a murder case, an editorial writer for the Oregonian observed:

"The adversaries, Deputy District Attorney Bill Marshall and defense attorney Nick Nylander, managed in dealing with each other to avoid the strained relations that often entangle lawyers trying major cases in Portland. This civility speeded the trial by eliminating time spent on side issues and lawyer squabbles."

That could only be accomplished by having great ability in the law, great preparation, a great work ethic, and temperament to avoid the personal issues that tend to antagonize. I am honored by the citation.

While serving as a judge for the past three years, I have endeavored to deal with the parties to cases before me in the same way.

22) Briefly describe an issue, related to Oregon's justice system, that is of particular interest or concern to you, or that you have interest in working toward improving.

The caseload for Oregon judges, and especially Douglas County judges, is growing rapidly. In order to appropriately administer justice in that situation judges and administrators must work together to find alternatives to litigating every issue, dealing with underlying issues, and eliminate repetitive hearings or cases. Douglas County judges and lawyers have made great efforts in dealing with some of these issues by creating family court, drug court, domestic violence court, and other alternatives to the traditional

courts. More can be done to improve the service to the community and parties to cases.

23) Briefly describe a legal figure, personal, fictional or historical, whom you admire and why.

I greatly admire Abraham Lincoln not merely for the great political accomplishment he achieved for the country, but more for his ability as a lawyer to deal with judges, other lawyers, and parties to a case with compassion and a sense of humor. In reading numerous biographies of Lincoln it is clear that he was well versed in the law; had the ability to humanize a legal issue; and thus make it more understandable.
