GENERAL COUNCIL Evangelical Methodist Church Indianapolis, Indiana September 8-10, 2011

#### MINUTES

The General Council of the Evangelical Methodist Church met at the Wyndham Indianapolis West, Indianapolis, Indiana, September 8-10, 2011. Members present: Dr. Edward Williamson, International General Superintendent; Rev. Albert Budiaki Mbenza, Conference Superintendent, Canada; Rev. Debra Miller, Christian Education; Rev. Jimmy Burks, Ministerial Relations; Rev. Jeffrey Williamson, Discipline Revision; Rev. Brian Hammond, Conference Superintendent, USA; Mrs. Tammy Hammond, EMW President; Rev. Ike Cowell, Conference Superintendent, USA; Rev. Max Edwards, Ministerial Education; Mr. Stanley Morris, Finance; Rev. Brian Gordon, Youth Activities; Dr. Jim Halbert, Evangelism; Rev. Jose Macias, General Superintendent, Mexico; Rev. Kenneth Swearingen, World Missions; Dr. Harold Thompson, Conference Superintendent, USA; Rev. James Coulston, General Secretary-Treasurer. Absent: Rev. Lalsawivela, General Superintendent, Myanmar; Mr. Bryan Moss, Trustees.

- 1) Call to Order. Dr. Williamson called the General Council to order at 3:05 p.m., September 8, 2011.
- 2) Adoption of the Agenda. The agenda was reviewed. Dr. Halbert moved, seconded by Dr. Thompson, to adopt the agenda.
- **3) Devotional.** Dr. Williamson gave the opening devotion for the Council, reading from I Samuel 7:3-14. Dr. Williamson related the events of scripture and how Israel had a renewed their trust in God. The event was marked by Samuel raising the Ebenezer, the "stone of help." Dr. Williamson led the Council in prayer.
- 4) International General Superintendent Report. Dr. Williamson relinquished the chair to Dr. Thompson. The report of the International General Superintendent was given (see *Reports*). Rev. Perkins submitted his resignation as the head of the Department of Multicultural Ministries to Dr. Williamson, effective December 31, 2011, following nearly 50 years of ministry in the EMC (see *Reports*). Appreciation was expressed to Rev. Perkins for his service. The resignation of Rev. Jack Conner was announced and his letter of resignation was distributed, effective December 31, 2011. Appreciation was expressed to Rev. Conner for his years of service (see *Reports*). The report was received by unanimous vote.
- **5) Cabinet of Superintendents Report.** The chair was relinquished to Dr. Williamson. The report of the Cabinet of Superintendents was given by Dr. Thompson, Dean of the Cabinet (see *Reports*). The Cabinet recommended Rev. Jack Conner the status of Conference Superintendent *Emeritus* was moved by Dr. Thompson, seconded by Rev. Swearingen. Approved unanimously. The Council unanimously received the report.
- 6) Executive Session. The Council went into Executive Session to fill vacancies.
- 7) Called to Order. Dr. Williamson called the Council back into regular session at 4:45 p.m.
- 8) Board of Christian Education. The chair called for the report of the General Board of Christian Education. Rev. Miller gave the report of the GBCE. Rev. Miller asked that the new Catechism be introduced at the 2012 Journeys. Rev. Miller emphasized the vision of the GBCE as stated in the report. Per the request of the GBCE, the Council unanimously directed that the GBCE introduce the

new catechism at the 2012 Journeys (see *Reports*). The report of the GBCE was received unanimously with appreciation.

- **9)** Evangelical Methodist Women. The chair called for the report of the President of the Evangelical Methodist Women. Mrs. Tammy Hammond gave the report of the EMW. The report of the EMW was received unanimously with appreciation (see *Reports*).
- 10) Adjourned for the Evening Meal. The Council adjourned for the evening meal.

#### FRIDAY, SEPTEMBER 9, 2011

- **11) Call to Order.** Dr. Williamson called the Council to order at 8:35 a.m. Dr. Halbert led in prayer, praying for the Board of Christian Education. Rev. Edwards prayed for the Evangelical Methodist Women's organization.
- **12) Announcements.** Dr. Williamson made announcements for the day. Dr. Williamson announced the first \$10,000 has been given for a bus to be purchased and sent to the DRC.
- **13) Board of Evangelism.** The chair called for the report of the Board of Evangelism. Dr. Halbert gave the report of the GBE (see *Reports*). The report was received unanimously. Rev. Jeff Williamson prayed for the GBE.
- 14) Board of Ministerial Education. Dr. Williamson called for the report of the General Board of Ministerial Education (see *Reports*). The Rev. Edwards moved that the proposed reorganizing of the Course of Study structure be adopted (the content is not changed, but the manner of completing the course would be restructured). Seconded by Dr. Thompson. Following discussion the Council approved unanimously the motion. The Council received the report of the GBME. Prayer was offered for the GBME by Rev. Cowell.
- 15) Recess. The Council recessed for a brief break.
- **16) Call to Order.** Dr. Williamson called the Council to order at 10:00 a.m. Dr. Williamson announced that word had been received that the son of Rev. Carl and Linda Kemp, Scio, NY, had died from cancer a few minutes earlier. Rev. Hammond led the Council in prayer on behalf of the Kemp family.
- **17) Prayer for the Harvest.** The Board of Evangelism has set 10:02 daily as the time of praying for the harvest of the lost. Dr. Halbert led the Council in prayer for the harvest.
- **18) Board of Ministerial Relations.** The chair called for the report of Board of Ministerial Relations. Dr. Williamson asked the General Council express to the Shamrock EMC, Burlington, NC, for allowing their pastor, Rev. Jimmy Burks, for all the time necessary to serve in this capacity. Approved unanimously. Rev. Burks gave the report of the GBMR. Rev. Burks moved to Table the report, seconded by Dr. Thompson. Approved unanimously.
- **19) Board of Finance and Treasurer's Report.** Dr. Williamson called for the report of the Treasurer and Board of Finance. Rev. Coulston gave the General Treasurer's report. Stanley Morris reported. Rev. Conner moved that pending the auditor' report and the other Cabinet business, any action regarding the 2012 budget be Tabled until later. Seconded by Rev. Miller. Approved.
- 20) Recess for Lunch. The Council recessed for lunch.
- **21) Call to Order.** Dr. Williamson called the Council to order at 1 p.m. Dr. Williamson opened with prayer.

- **22)** Audit Report. Dr. Williamson introduced Mr. Richard Lindley, Senior Audit Manager with Capin Crouse LLP, to give the audit report. Mr. Lindley gave the draft Financial Statement for FY 2010. The Council received the audit report with appreciation.
- 23) Take from the Table Board of Finance. It was moved that the report of the Board of Finance be taken from the Table. Moved by Rev. Edwards. Seconded by Rev. Hammond. Approved. Mr. Morris made the following motion: The General Council directs the General Board of Finance that the goal is for a balanced budget for 2012, with a maximum of a \$50,000 overrun allowance without General Council approval, with the General Council being informed of the first \$10,000 in overruns. Seconded by Rev. Hammond. Following discussion, the motion was approved unanimously.
- 24) Executive Session. The Council went into Executive Session at 2 p.m.
- **25) Call to Order.** The chair called the Council to order at 3:45 p.m.
- **26)** Take from the Table Board of Ministerial Relations. Mrs. Miller moved that the report of the Board of Ministerial Relations be removed from the Table. Dr. Thompson seconded the motion. Approved unanimously. Rev. Burks completed the report. The Council received the report of the Board of Ministerial Relations (see *Reports*).
- **27) Board of World Missions.** Dr. Williamson called for the report of the Board of World Missions. Rev. Kenneth Swearingen gave the report of the GBWM (see *Reports*). The report was received unanimously. The Council received word that Rev. Wes Sperl has been moved from a hospice to his home. Rev. Jack Conner prayed for Rev. Wes and Janet Sperl. Rev. Gordon prayed the Board of Finance and Mr. Morris and his physical health. Rev. Miller offered prayer for the Board of World Missions. Dr. Thompson prayed for the Board of Ministerial Relations.
- **28) Board of Youth Activities.** The Board of Youth Activities report was called for by the chair. Rev. Gordon gave the report. Rev. Gordon accepted the Substitute Motion: *We recommend that all local churches and pastors to attend and/or promote a Board of Youth Activities approved camp of their choice.* Approved by the Council. The report of the Board of Youth Activities report was received unanimously (the edits to the General Council Operations Manual were accepted with the report). See *Reports.*
- **29) Department of Multicultural Ministries.** Dr. Williamson called for the report of the Department of Multicultural Ministries (see *Reports*). Rev. Perkins asked that Rev. John Kunkle be sent greetings from the General Council. The Council received the report of the Department of Multicultural Ministries unanimously.
- **30) Establishing Churches Inter-Conference.** Rev. Perkins recommended the following two Propositions:

#### Proposition #1-

Any conference of the Evangelical Methodist Church has freedom to evangelize and plant new churches around the world. When the effort is within the boundaries of another conference, arrangements between the respective superintendents will determine the administrative procedure when the newly planted church is ready to affiliate.

#### Proposition #2 -

Cooperative ministries to church plants initiated by another conference within the boundaries of the USA District will be coordinated through the General Superintendent for either the Department of Multicultural Ministries or other appropriate Board prior to affiliation. A representative from the USA entity together with the respective General

Superintendent or his representative will develop the cooperative ministry program, taking into account governmental regulations and limitations as affecting the church plant effort (such as lay leadership, ministerial responsibilities, insurance, finances, etc.).

31) Receive Submitted Reports. The following reports were received as submitted:

- **32)** General Conference 2014. Rev. Burks moved that April 4-7, 2014, in Indianapolis, Indiana, be set of as the date and location of the 2014 General Conference. Seconded by Rev. Jeff Williamson. Approved unanimously.
- **33) Operations Handbook.** It was moved by Rev. Burks, seconded by Dr. Thompson, that the recommended edits of the Operations Manual for the Board of Youth Activities and Board of Ministerial Relations be adopted. Approved unanimously.
- **34) Operations Manual.** Rev. Burks moved the adoption of the General Council Operations Manual be approved. Seconded by Rev. Gordon. Approved unanimously.
- **35)** Adjournment. Rev. Coulston moved that the General Council be adjourned *sine die*, with the General Council to reconvene no later than December 31, 2011, by electronic means. Seconded by Rev. Swearingen. Approved unanimously.
- 36) Call to Order. The General Council conducted an email vote, December 16, 2011.
- **37) Disaffiliation.** The Cabinet of Superintendents recommends that the following churches be disaffiliated per **1**609 of the *Discipline of the Evangelical Methodist Church*: Rockdale EMC, Conyers, GA; EMC, Covington, TN; Grand Prairie EMC, Stuttgart, AR. Approved unanimously.
- **38)** Adjournment. It was moved that following the vote of disaffiliation the General Council be adjourned. Approved unanimously.



# General Council Report of the International General Superintendent/Bishop September 8, 2011



This is the Lord's denomination, founded by Godly men moved by the Spirit to have courage and faith in the face of impossibilities. Knowing the origins and the early history of the founding of the EMC brings a certainty of denominational ownership. We, the elected leadership, are not the owners; God is the owner and the Protector for His purposes and plans for the EMC. Therein I find rest.

I share the following observations for the historical record in the minutes of this General Council. There have been attempts throughout our history to remake the EMC into an association of churches, stripping it of the hierarchical historic connectional aspects of Methodism (1952, Breckville; 1986 General Conference, 2007 Moody, Hudson, Fleming). At present the former district superintendents of our Southern District who opposed the organizational changes and formed their own association continue encouraging EMC local churches and pastors to join them. This began months before any legislation was passed at the 2008 General Conference which created the North America Conference. It was unethical of these men and brought confusion to our people in their active involvement with our Duvall EMC in the conciliation and arbitration process. The General Council will convene in Executive Session under lawyer client privilege to receive information that is legally censored at this time with a commitment to confidentially. We will have full disclosure of information within the limits of confidentially when permitted to our pastors and churches.

The heart of the issue is the ministry from the pulpit having a properly credentialed clergy and the responsibilities of the Conference Superintendents in carrying out their duties as outlined in the Discipline. This is the issue at Duvall where a man who publicly refuses ordination in the EMC, opposes our doctrines of Wesleyan Arminian theology and understanding of 'perfect love' in holy living was allowed a pastoral vote by the congregation. Their request for withdrawal is directly tied to this man who the Cabinet has removed, but the church leadership and the pastor refuse to acknowledge. This issue strikes at the heart of our historical Methodist connectional structure. The denial of our responsibility for clergy and the pulpit ministry of the local church would turn upside down 65 years of our EMC history and over 200 years of historic Methodism. When an analysis is made of the Discipline the text is 95% connectional and 5% congregational. Dr. Hamblen and the founders intentionally adopted Methodist Episcopal Book of Discipline as the foundation of the EMC Discipline. Their edits were three, local church ownership and local churches having the final vote for an approved and credential pastoral candidate and election of the General Conference Superintendents every four years. I encourage everyone to listen to the media clip of Dr. Hamblen's statement on the EMC being connectional with historic Methodism on the website.

There is a keen awareness of our founders' struggles with the same issue we face today. How can we have a Methodist Holiness denomination that allows the churches to retain their property if the EMC ever becomes liberal in theology and practice, while at the same time protecting the local church members' investments from being influenced to withdraw by self serving pastors wishing to build their own kingdoms? The solution to this tension for some of our holiness denominations, Free Methodists for example, was to retain the property ownership of their local churches by the General Conference. The EMC chooses to navigate through this tension because local church property ownership is one of our core values. Personally, I want the church in WV I founded not to lose their property and years of investment if the EMC ever became liberal in theology and they had to withdraw.

There will be *Discipline* revisions offered at the 2014 General Conference that will be in line with the results of our arbitration. It is worthy to note if the EMC ever moves into liberalism it would be a result of General Conference action in changing the Articles of Religion and/or electing theological liberal persons to the Superintendency and General Boards. The 'firewalls' against this are the percentage of lay delegates is greater than the clergy and there are no elections for life. If a person revealed a liberal theology in their leadership they would not be elected to a second term. There will be changes proposed for the *Discipline* and the *Handbook*.

I pray you will not be reading any of the above comments in the 2012 report to the General Council. We have much to rejoice about and to keep our focus on the acts of God throughout the ministries of the EMC.

The four men elected to the Cabinet as USA Conference Superintendents have become a team who are dependent upon the Lord for the ministry. The General Conference created four Conference Superintendent positions for this quadrennium. By 2014 we may need five such positions with our continued growth! Their report speaks for itself. In the USA District I have conducted the majority of administrative duties to allow these brother superintendents to be in the local churches and in our Regions.

The Canada District under our Conference Superintendent Bishop Albert Budiaki has been busy organizing the district. Our African brothers bring to the international EMC fresh emphasis on prayer and outreach. The report speaks for itself.

Our North America Conference includes our Mission Conference in Mexico (MEM). Rev. José Macías has been leading the Conference in restructuring for ministry, fresh goals and visionary leadership for the Conference. The report speaks for itself.

Our Myanmar Mission Conference completes the International Cabinet of Superintendents with Rev. Lalsawivela as their General Superintendent. The Conference has partnered with One Mission Society (OMS) in the Every Community for Christ (ECC) church planting strategies and training. Our conference provided translation of church planting materials in Mizo and soon into Burmese. There have been an expansion of water wells in villages with evangelism and church planting included in the strategy. The report speaks for itself.

The General Boards have worked throughout the year as they learn to function as boards for the North America Conference. The denomination owes a depth of appreciation to these board members and their chair. Their reports will speak for themselves.

The Departments have reported on their activities and challenges. Our Department of Multicultural Ministries is facing the challenges of the growth of the EMC in our cultural USA mosaic that God has brought to the USA. Revs. Vernon and Ruth Perkins have served as the directors. They will step down as directors, but Vernon will continue in an assistant advisory capacity. I nominate Rev. Bill and Lisa Walker to replace the Perkins as our new directors 'elect' effective January 1, 2012.

The Department of Prayer continues to emphasize the studies on prayer and the theme that the EMC become a 'house of prayer for the nations'. The devil is fighting this knowing it is the most powerful weapon the church engages in spiritual warfare.

Rev. Coulston has performed outstanding ministry in his role as the General Treasurer and General Secretary. The completion of his accounting/business degree has satisfied the auditing standards and enabled him to navigate the finances of six districts into one General Fund. His statistical report reflects the hard work of maintaining the tools the Superintendents require for planning and strategies.

The Conference Superintendents will be holding the Annual Church Conferences by regions. There is a specific focus of assisting pastors and churches to fulfill their specific mission and calling in their locations. Our Pastors Profile is in its second year that provides a tool for the lay people and the pastor to evaluate the ministry and set action goals. The Conference Superintendents will be sharing with each church a graph of their personal statistics for worship, membership, and conversions.

The sun never sets on the Evangelical Methodist Church. We could not say that a decade ago. Every five minutes someone comes to Christ through the Evangelical Methodist Church around the world.

I share a note of deep appreciation to Rev. Jack Conner for his service to the Evangelical Methodist Church as a missionary, pastor, and Conference Superintendent. Our brother will be retiring from the superintendency, but will still be serving in the denomination for the Lord and Kingdom ministry.

## CABINET OF SUPERINTENDENTS Report to General Council September 2011

Since last Council meeting it has been a very challenging and event filled year for the Superintendents. We have made contact with all churches either in person, by regional meetings, emails or phone calls. Some have been contacted and/or visited more than once for various reasons.

The Cabinet of Superintendents models, for the most part, the greater body of Christ. We are diverse in our ages and backgrounds, our experiences and points of view, and our gifts, talents and abilities. But although we are diverse, we are unified in purpose and mission. We are first and foremost servants of our Lord and workers together in His greater kingdom. We all have a deep commitment, like our Lord, to "be about our Father's business." We are also unified in doing all we can to strengthen the EMC and its ministry as part of that greater kingdom. We each have a strong desire to see the EMC become all that God intends it to be. Christ prayed for unity in John 17. The EMC Cabinet of Superintendents is doing its best to model His prayer and may the entire EMC as well.

The greater number of churches are healthy and are actively engaged in growth programs or have plans for future growth. There are a few that may not survive. Some have not been willing or have not been able to keep up with changes, (I refer to changes in ministry styles and opportunities and not changes to the Gospel or the message). For various reasons they have failed to reproduce themselves and are living on what the medical profession would term "life support."

There have been some bumps along the way regarding those churches that prematurely reacted negatively to the organizational changes even before they became effective, deciding that the EMC was taking a dangerous turn from, (what one could only perceive from their thinking and actions) the original purpose of the EMC as well as from the Bible itself. We can't share much information on these churches due to the continuing conflict. Our legal council will reveal to you what can be shared.

There has been minimal regional alignment, mainly to accommodate churches that were already involved in fellowship with one another and also to accommodate future growth in the regions. It is apparent to us that to some extent the regions will always be fluid. Conference Superintendents' Report Page 2

We continue to work with the various ministerial related boards to streamline the ministerial track and to actively recruit and present to the GBMR those who may eventually become ministers and pastors in the EMC. We monitor and participate in present and future plans for qualitative and quantitative growth in the local churches. We anticipate that these four years would produce some <u>Discipline</u> adjustments as we learn from experience how important it is for everything to be clearly spelled out. We cannot overstress the importance of adequate communication.

The Cabinet is unable this year to verify those churches that may be delinquent in Conference Support as required by the <u>Discipline</u>, par. 206-207. However, the General Conference Secretary/Treasurer has provided a report of conference support that will include this information. Our report next year will be specific with a full year as the North America Conference.

We estimate the Superintendents traveled a total of approximately 298K +/\_ miles since last Council meeting. This mileage represents a combination of air and ground travel. That is equivalent to eleven trips around the world. We would covet your prayers as we travel, for safety as well as productive visits with the pastors and congregations of the EMC.

The Cabinet would also like at this time to recommend Rev. Jack Conner for the status of "Conference Superintendent Emeritus." Jack has served the EMC for nearly twenty years as a District/Conference Superintendent and has been a very valuable and faithful servant to God and a very loyal servant to the EMC. We wish him well and the very best God can provide for him and his family.

- Small group and home studies
- Catechism for new members
- Systematic discipleship for adults and children

To provide a list of resources and contacts for congregations interested in Christian homeschooling or structured Christian schools and to sponsor and encourage training workshops at local, regional, and conference meetings.

This year the board has focused on rewriting the catechism for future use in the churches. Our goal was to finish and print the new catechism by the end of 2011. Our desire is to have it ready for the "2012 Journey" when we would like to introduce and provide training for our churches. The catechism will help develop membership classes in all of our congregations. Our board has conducted a majority of our business through phone conferencing. At the "Journey 2011" meeting we were able to meet as a committee to coordinate our work. Since our meeting all of our work has been on the CCB website where it can be reviewed by anyone who has access to the Board of Christian Education group.

We were also privileged to be able to present classes at each of the "Journey" meetings in 2011. These classes were designed to help our fellow congregations develop and increase attendance in their Sunday school classes.

Our greatest and continuous challenge is to develop a practical approach to supporting local congregations in training their members to think biblically, learn eagerly, and live obediently under the Lordship of Christ. This challenge is one that is extremely important to the future of our churches. Financing this education in our regions will be challenging, but vitally important to creating strong congregations with workers that are prepared to lead in their areas of ministry. We need to begin presenting classes in our regions that will encourage the workers, especially volunteers (who make up most of our teachers).

The Board of Christian Education's vision is for our regions and churches to be able to have training for every aspect of Christian education; trained workers and teachers

confidently leading adults and children into the word of God in our churches. All of these materials and resources would be found on the EMC website for accessibility and ordering.

We are asking the General Council to approve our motion:

The Board of Christian Education makes a motion asking for permission to introduce at Journey 2012, our catechism and provide training for our churches, which will help develop membership classes in all of our congregations.

#### **Report:**

We've met once twice as a group, once in Nampa, Idaho and then at Headquarters in Indianapolis. We divided our task into church planting and church revitalization. Jim Halbert presented the strategy for planting and Rus Hooper presented the strategy for revitalization.

With planting we are using Refuge Theology as a basic framework for designing the plant combined with personality, spiritual gift and strength and weakness testing.

For the revitalization process we have adopted Natural Church Development as our model. This model also plays a part in the planting of churches as well. Rus has modified it to be used by the church, with the guidance of this board.

#### **Projects:**

- 1. We have funded the Warehouse Church in MO and are working with Wes Mackey as he continues to build this new work. This church continues to grow by commitments of faith. Baptisms are becoming commonplace here. Please read the article about them in the latest edition of the Communicator.
- 2. We are just getting under way with the new church in Moscow, Idaho under the direction of Barry and Anna McGarrah. They officially launch public services soon but already have over 40 core team members meeting weekly and have grown out of their first facility.
- 3. We have made a stopgap decision to help Pastor Moba in Toronto for the church he planted, and that was already underway when we last met. Soon Rus Hooper and one of the Superintendents will fly up there to assess their need for further financial and structural assistance.

With the basic framework now set for both responsibilities of this board and with the funds that have been made available to us, we hope to see the addition of new works both here in the United States and Canada as well. We've asked that any new church plant candidates come to the board as a recommendation from the Superintendents. From that point we meet with them and then based on our decision have them take the tests, assess them and come up with a plan of attack to plant the new church. It sounds simple, but as you know it can get a little more complicated than this. But we're excited to be a part of growing God's church.

## 2011 General Council Report

The Board of Ministerial Education met all of its obligations and responsibilities over the last year. Of particular interest is our progress in converting entirely to electronic communication. This includes the participant's initial mailing, submission of work, and progress reporting for the purposes of the Board of Ministerial Relations.

We are in continuing efforts to organize responsibilities in a way that makes sense regionally, but very little progress has made due to time constraints and the current condition of the board. I will elaborate on that verbally, but I will be asking for two-to-three members to be replaced at the request of the individual members themselves.

Our function remains constant and is primarily two-fold: first to ensure that candidates for ministry in the EMC meet a minimum standard of educational preparedness, either in approved institutional education, or through the completion of a set course of study; and second to provide or approve acceptable opportunities for our ordained ministry to acquire continuing education units that will inspire and challenge them.

**Course of Study** The board is scheduled to meet on September 1<sup>st</sup> to continue the consideration of a wholesale conversion of the Course of Study. It is currently arranged as a tier-specific book list **(Attachment #'s 1-2)**. We are finalizing a proposal that would organize the Course of Study into 24 "courses," **(Attachment #'s 3-6)** eight for each of the three tiers of ministerial preparation. I informed you of this possibility last year, noting "We are considering a large-scale overhaul that would consolidate the 64 individual items into approximately 24 "courses."

<u>Continuing Education Events</u> As a reminder of what we reported last year, we are not planning a full EMC Pastor's School for the 2010-2014 quadrennium, but instead have assembled a list of pre-approved events around the country that pastors may attend in order to satisfy the CEU requirement. Pastors may seek BOME approval to attend an event not on the pre-approved list as well. The list is attached, and is available from the CCB website to all of our ministers. (Attachment **#7**)

We are again planning to arrange for 2.5 hours of educational workshops at each of the 2012 North American Conference "Journey" events. They were a success in 2011, and I believe that the more relaxed and inspirational schedule contributed toward a positive and productive meeting environment.

**Scholarship Distribution** In accordance with our mandate, the board approved the distribution of financial assistance in the way of student loan to approved seminary and college students to be repaid by years of service in EMC ministry. The exact number of students approved for 2012 will not be known until the time of the Council Meeting, and I will be happy to provide that number verbally.

## GENERAL BOARD OF WORLD MISSIONS Report to the General Council September 7-8, 2011 Indianapolis, IN

Our mission work is moving forward in Mexico and Myanmar. New General Superintendents were elected in both mission fields in 2010 and the Board of World Mission feels that both superintendents are well qualified and capable leaders.

#### **MEXICO**

Rev. Jose Macias was elected to the leadership position of General Superintendent in July 2010. Rev. Macias is a qualified leader by virtue of his educational and ministerial experience. His educational training began in the Bible Institute in Mexico and from there, Vennard College in Iowa then to Wesley Biblical Seminary in Jackson, Mississippi. He has pastored in Mexico and in the US.

Brother Jose has made and received endorsements by the conference of a number of pastoral and procedural changes for the MEM. Dr. Williamson and I have been privileged to attend the conferences and we support these proposals. We feel, under Rev. Macias' leadership the MEM will be revitalized and the churches will become stronger.

A strong program has been initiated for the Bible Institute and expectations are that this will have a great impact in training and providing candidates for pastoral and missionary work throughout the conference.

Classes have begun for the Fall semester with 14 full-time students. The Bible Institute has played a significant role in the conference for many years. Many of the present pastors are graduates of the Institute. Mexico needs our continued prayer and financial support for the MEM and the Bible Institute. At the present time, there are 23 churches with a total membership of 1,116.

#### TARAHAMARA INDIANS

The Tarahumara Indian ministry is doing better now than it has in a number of years. It is administered through the church in Cuauhtémoc in the State of Chihuahua. This work needs continuing financial support. Presently, there are two indigenous pastors working with this group. The monthly support for this work is \$600. This amount needs to be increased, however, the funds for this work are limited. The Cuauhtémoc Church, which is in a building program, supplements the work from time to time.

The Board of World Mission sees many opportunities and challenges as we partner with the MEM in accomplishing the goals established. Our hope for Mexico is that we move beyond these goals to truly see an evangelistic movement throughout Mexico and beyond. There are present possibilities outside Mexico that the MEM is investigating and has asked the Board to assist them with these considerations.

Brother Jose will give us more details in his report to the General Council.

#### MYANMAR

Rev. LalSawiVela was elected General Superintendent in 2010. His election is somewhat of a challenge for us in that he does not understand or speak English, however, the General Conference Secretary does the translation of our correspondence so we are able to function without great difficulty. His leadership is proving to be effective.

The work in Yangon is going well. They have reached out beyond the local Yangon church and the Nargis area and established new works. A new half-ton Kia truck was purchased and is a tremendous help in service for the Yangon and outlying churches and preaching points. It will serve as transportation around Yangon when delegations from the US arrive.

Three fresh, clean water wells have been drilled in the area. "Thanks" goes to OMS for their help in the drilling of these wells. We trust we will be able to get into Kalemyo and Chin State to drill for our people in those areas.

OMS continues to partner with us in providing training for the leadership of the conference. We presently have one pastor at the Philippines Christian University for continuing education. We have provided him with a scholarship.

The leadership and pastors are committed and the work is going forward with new people being saved. There are seventy churches/mission stations, with a membership of 4,976 and an average attendance of 3,000 in worship.

A goal of the BOWM is to establish an Endowment Fund for Myanmar. We now have one small fund. Endowments are of great need for underwriting the continued future ministry of this mission conference. We solicit the Council's support in encouraging our people to consider this as an opportunity to underwrite this work.

There is a need for a used heavy-duty truck for the Conference in Kalemyo, site of the Headquarters. To rent vehicles for all their conference needs is quite expensive. It would also serve as a 'people hauler', as well.

We are encouraging the Adopt-A-Church Program in Mexico and in Myanmar. Scholarship funds are needed for Myanmar and Mexico.

November is Annual Mission Offering month. Our goal is, as has always been, \$10 per member/attendee across the EMC.

## Board of Youth Activities Report to the General Council September 8-10, 2011

The Board of Youth Activities exists to equip youth and youth leaders to impact our world for Christ. We fulfill our purpose through the implementation of four core values: Unity, Equipping/Mentoring, Evangelism, and Missions.

The BOYA met via "Go to Meeting" in January, communicated often through email or CCB, and held a face-to-face meeting at Indian Cave Youth Camp in August. While virtual meetings have been extremely beneficial and cost effective, we still find that one face-to-face meeting each year allows us the time needed to adequately pray, plan and struggle through the enormous task of insuring the continued success of youth work in the Evangelical Methodist Church.

This year the Board of Youth Activities adopted "Epic" as the theme for EMC camps. We worked together to produce t-shirt art, seminars, sample message outlines, follow-up Sunday School lessons, field guides that could be adapted for use at each camp, and promotional materials. Each camp team was encouraged to use the materials we provided and adapt them to fit the needs of their specific camp. It was a blessing to hear each camp team share reports of changed lives as a result of the ministry that takes place at our EMC camps. We are more convinced than ever that when we invest in camp we are investing in changed lives. The attendance figures for the BOYA sponsored Epic and Children's camps are as follows:

In addition to summer camp the BOYA planned and presented youth worker and children's worker seminars at both Journey East and Journey West. Several youth rallies were sponsored throughout the year, and a very successful Home Missions Trip was sponsored by Kingdom EMC in Westover, WV.

Indian Cave Youth Camp, our denominationally owned camp, hosted or will host a total of 9 EMC events with a total attendance of more than 630. In addition to EMC activities Indian Cave has hosted 8 other events so far this year with a total attendance of more than 600.

While the Board of Youth Activities has made great strides in fulfilling our four core values many challenges yet remain. One of the biggest challenges is the encouragement of pastors and churches to support EMC Camps and youth activities. Another challenge is the challenge of training for youth workers. Most of our churches do not have paid staff working with youth and children. Many volunteers feel inadequate or under qualified. It is our desire to be able to provide support and assistance to those who feel called to work with youth and children in the local church. In order to fulfill our purposes as a Board adequate funding is necessary. Funding is necessary to grow our camps, develop new camp ministries, train youth workers, plan missions trips, etc. Investment in our youth programs is an investment in future church leaders, Sunday School teachers, Board members, pastors, and missionaries.

The Board of Youth Activities is unified in its belief that Indian Cave Youth Camp is a vital ministry of the Evangelical Methodist Church that deserves adequate funding. The Camp Committee and Rickie Garner (camp director) are making great strides, and the camp has great potential for future growth and development. The completion of the new dining hall will enable the camp to remain open year-round for winter retreats, board retreats, and conferences. We believe short term investment in Indian Cave will insure long term success. The Camp Committee is currently working with Wayne Eldredge from the Board of Finance to develop a Business Plan.

Our goal as a Board is to see the day when the majority of our churches participate in an EMC camp. Our goal is not necessarily large numbers at our camps, but quality camps that are changing lives and promoting unity in our churches. We long to be able to provide resources and funding to churches that want to train their leaders but may lack the resources and funding to do so on their own. The Board will be meeting via phone conference in October or early November to complete a budget request to submit to the Board of Finance.

In closing, we are looking forward to greater things in 2012. The unified camp theme for senior camps next year is "Radical." A subcommittee will be working with the leaders of our children's camps in the development of a unified theme for those camps as well. In addition to the camp themes, we will be providing t-shirt art, seminar outlines and other resources. We will be working with headquarters to develop online registration options. We will also be working with others to target other areas of the country where additional camps could be held.

## **Board of Youth Activities Manual of Operations**

## Section 1: The Board of Youth Activities

## Article 1: Name

The name of this Board shall be the General Conference Board of Youth Activities, hereinafter called the Board. The Board shall be under the direction and control of the General Conference of the Evangelical Methodist Church, operating under the guidelines of the <u>Discipline of the Evangelical Methodist Church</u>.

## Article 2: Mission

The mission of the General Board of Youth Activities is to equip youth and youth leaders to impact our world for Christ.

## Article 3: Vision

The vision of the General Board of Youth Activities is to equip youth and youth leaders to impact our world for Christ through the fulfillment of our four core values. Our core values are Unity, Equipping/Mentoring, Evangelism, and Missions

## Article 4: Core Values

<u>Unity</u>

- We are committed to unified leadership that works to maintain a strong connection between the general and local levels.
- We strive for a unified focus for youth ministry denomination wide.

Equipping/Mentoring

- We are committed to the development and implementation of effective strategies for the equipping and training of youth leaders.
- We are committed to training youth leaders to mentor the next generation of EM Youth for present and future leadership.

## Evangelism

- We believe in the power of God to radically change lives.
- We are committed to provide opportunities and resources to affect change and impact lives for Jesus Christ.

**Missions** 

- We are committed to raising awareness of the Biblical command to take the message of the Gospel to all the world.
- We are committed to creating opportunities for youth to experience missions both at home and abroad.

## **Article 5: Officers and Committees**

The Chairperson of the Board shall be designated in accordance with the <u>Discipline</u>. The Board shall elect a Vice Chairperson, and a secretary. Each member shall be assigned duties as needed to fulfill the mission, vision, and core values of the Board. Duties include, but are not limited to the following:

- Camps & Retreats
- Training
- Missions at home and abroad

- Publications/Promotions
- Website

Each Board Member will also be assigned a region or regions as a liaison of the Board of Youth Activities.

## Article 6: Meetings

The Board shall meet in person *at least once each year, with at least two additional conference calls.* Meeting dates and times will be set by the Chairperson in consultation with the General Superintendent.

## Article 7: Budget

The Board shall prepare a yearly budget to present to the General Conference in accordance to the operational procedures of the EMC.

## Article 8: The National Youth Director

## Section 2: Indian Cave Youth Camp & Retreat Center

## Article 1: Name

Indian Cave Youth Camp and Retreat Center is a denominational camp of the Evangelical Methodist Church.

## Article 2: Mission & Vision

The Mission of Indian Cave Youth Camp is to be a place set apart. We seek to encourage and build the body of Christ by offering quality facilities for camps, retreats, conferences, and other activities.

## Article 3: Indian Cave Youth Camp Committee

The Indian Cave Youth Camp Committee (ICYC Committee) is appointed by the General Board of Youth Activities (GBOYA) with recommendations from the ICYC Committee. The ICYC Committee will recommend a Camp Director, who will be appointed by the GBOYA. The Camp Director shall be accountable to the ICYC Committee and the GBOYA for the ministry of the camp and the operational functions. The GBOYA shall, with consultation from the ICYC Committee, set the policies and procedures for Indian Cave Youth Camp and Retreat Center.

## Policies & Procedures

- 1. The ICYC Camp Committee shall elect a chairman, secretary, and treasurer yearly, to be ratified by the GBOYA.
  - a. The chairman directs all meetings.
  - b. The secretary records the minutes of each meeting and distributes the minutes to each member of the ICYC Committee and GBOYA.
  - c. The treasurer receives funds from Headquarters, camp tuition, camp rentals, donations, and gifts. Receiving of funds is to be handled by two individuals. These funds are deposited into the proper bank accounts, the deposit being prepared by two individuals. The treasurer disburses the funds for bills, taxes, wages, salaries, and other approved purposes. The treasurer provides a quarterly financial report to the members of the ICYC Committee, GBOYA, chairman of the General Board of Finance, and the General Conference Treasurer. The treasurer's books are to be reviewed annually by the General Conference Treasurer.

## 2. The Camp Director

- a. <u>The Camp Director has authority to utilize the budget to maintain the grounds, make and/or</u> <u>arrange for needed repairs, and has authority over day-to-day decisions, referring major</u> <u>decisions to the ICYC Committee and GBOYA.</u>
- b. The Camp Director, with the approval of the Chair of the GBOYA, is authorized to spend up to \$10,000 for immediate needs, emergencies, and shortages for the operation of the camp and the care of the facilities.
- c. The Camp Director will have the authority to hire appropriate staff for camp operations as per the budget.
- d. The Camp Director shall maintain a schedule of groups wishing to use, or who have used, the camp facilities.
- 3. The Indian Cave Youth Camp Committee
  - a. The ICYC Committee shall meet approximately once each quarter.
    - i. To review finances
    - ii. To discuss challenges and address current needs
    - iii. To plan for the future
    - iv. To provide support, offer suggestions, and provide assistance to the Camp Director
    - v. To prepare a report of camp progress to send to the GBOYA
  - b. The ICYC Committee shall prepare a recommended annual budget for the camp ministry to be approved by the GBOYA and included in their Conference budget.
  - c. *The ICYC Committee has the authority to allocate any budget surplus for any camp needs.*
  - d. The ICYC Committee shall prepare an annual updated business plan and future goals for the camp ministries to be presented to the GBOYA and approved by the General Council.

Define: Purpose Statement: The Department of Multicultural Ministries helps local churches in their outreach to all peoples in the North American Conference by assisting in evangelizing the unsaved, discipling new believers and establishing healthy, multicultural/multiethnic churches. 2. Describe: Ministry Activity: (1) The Director filled the pastoral vacancy of the bilingual Grace EMC in Phoenix, AZ for six months while a pastor was being secured. (2) Bill Walker was added to the staff as Assistant to the Director and represents the denomination as a member of the Ethnic America Network. (3) Visits to ethnic congregations were made and financial support was approved for the Elizabeth City "La Gran Comisión" EMC. (4) We are using CCB occasionally. ## **Cooperation of Conferences in Church Planting**

Presented by Jose Macias and Vernon Perkins

#### **Proposition #1-**

Any conference of the Evangelical Methodist Church has freedom to evangelize and plant new churches around the world. When the effort is within the boundaries of another conference, arrangements between the respective superintendents will determine the administrative procedure when the newly planted church is ready to affiliate.

#### **Proposition #2** –

Cooperative ministries to church plants initiated by another conference within the boundaries of the USA District will be coordinated through either the Department of Multicultural Ministries or other appropriate Board prior to affiliation. A representative from the USA entity together with the respective General Superintendent or his representative will develop the cooperative ministry program, taking into account governmental regulations and limitations as affecting the church plant effort (such as lay leadership, ministerial responsibilities, insurance, finances, etc.).

Toronto is one of the world's most <u>multicultural</u> cities. In 2004, the <u>United Nations Development</u> <u>Programme</u> (UNDP) ranked Toronto second, behind <u>Miami</u>, <u>Florida</u>, in its list of the world's cities with the largest percentage of foreign-born population. Miami's foreign-born population is dominated by those of Cuban and Latin American descent, unlike Toronto's foreign-born population, which is not dominated by any particular ethnic group.

The 2006 census indicates 46.9% of Toronto's population is composed of <u>visible minorities</u>; 1,162,630 non-<u>Whites</u>, or 23% of Canada's visible minority population, live in Toronto; of this, approximately 70% are of Asian ancestry. Annually, almost half of all immigrants to Canada settle in the <u>Greater Toronto Area</u>. In March 2005, <u>Statistics Canada</u> projected that the combined visible minority proportion will comprise a majority in both Toronto and <u>Vancouver</u> by 2012.

<u>Roman Catholics</u> accounted for 33.4% of the population of the City of Toronto in 2001, followed by <u>Protestants</u> with 21.2%. The city also has <u>Islam</u> (6.7%), <u>Christian Orthodox</u> (4.9%), <u>Hindu</u> (4.1%), <u>Jewish</u> (3.5%), <u>Buddhist</u> (2.1%), <u>Sikh</u> (1%), and other communities; 16.6% reported no religious affiliation.<sup>[6]</sup>

According to the Canadian government, Toronto has the highest per capita <u>immigration</u> rate in the world,<sup>[8]</sup> and 43% of new immigrants settle in the <u>Greater Toronto Area</u>.
