## The Bradford (Parishes) Order 2004

Made - - - - 8<sup>th</sup> March 2004*Coming into force in accordance with article 1(2)*

The Secretary of State, in exercise of the powers conferred upon him by sections 14 and 23 of the Local Government and Rating Act 1997(a), and of all other powers enabling him in that behalf, hereby makes the following Order, which gives effect (with modifications) to a petition sent to him under section 11 of that Act, for the constitution as parishes of areas within the Metropolitan District of Bradford of which no parts are within a parish, and for the establishment of parish councils for those areas:

**Citation, commencement and interpretation**

1.—(1) This Order may be cited as the Bradford (Parishes) Order 2004.

(2) It shall come into force —

- (a) for the purposes of this article and proceedings preliminary or relating to elections of parish councillors to be held on the ordinary day of election in 2004, on the day after that on which it is made;
- (b) for all other purposes, on 1st April 2004.

(3) In this Order —

“the new parishes” means the parishes constituted by articles 2, 3, 4 and 5; and

“the map” means the map prepared by the Office of the Deputy Prime Minister, marked “Map of the Bradford (Parishes) Order 2004” and deposited in accordance with regulation 6(1) of the Local Government (Parishes and Parish Councils) Regulations 1999(b).

### **Constitution of a new parish of Sandy Lane**

2. —(1) A new parish comprising the area numbered 1 and outlined with a blue line on map 1 shall be constituted within the Metropolitan District of Bradford.

(2) The name of the new parish shall be Sandy Lane.

### **Constitution of a new parish of Wilsden**

3. —(1) A new parish comprising the area numbered 2 and outlined with a blue line on map 1 shall be constituted within the Metropolitan District of Bradford.

(2) The name of the new parish shall be Wilsden.

### **Constitution of a new parish of Clayton**

4. —(1) A new parish comprising the area outlined with a blue line on map 2 shall be constituted within the Metropolitan District of Bradford.

(2) The name of the new parish shall be Clayton.

### **Constitution of a new parish of Wrose**

5. —(1) A new parish comprising the area outlined with a blue line on map 3 shall be constituted within the Metropolitan District of Bradford.

(2) The name of the new parish shall be Wrose.

### **Directions to establish a parish council**

6. The City of Bradford Metropolitan District Council is hereby directed to establish parish councils for the new parishes.

### **Transitional Provision**

7. — (1) Until the councillors elected to the council of the parish of Sandy Lane at the elections to be held on the ordinary day of election in 2004 come into office, the parish of Sandy Lane shall be represented by those persons who, immediately before 1<sup>st</sup> April 2004, are the elected councillors for the district ward of Heaton.

(2) Until the councillors elected to the council of the parish of Wilsden at the elections to be held on the ordinary day of election in 2004 come into office, the parish of Wilsden shall be represented by those persons who, immediately before 1<sup>st</sup> April 2004, are the elected councillors for the district ward of Bingley Rural.

(3) Until the councillors elected to the council of the parish of Clayton at the elections to be held on the ordinary day of election in 2004 come into office, the parish of Clayton shall be represented by those persons who, immediately before 1<sup>st</sup> April 2004, are the elected councillors for the district ward of Clayton.

(4) Until the councillors elected to the council of the parish of Wrose at the elections to be held on the ordinary day of election in 2004 come into office, the parish of Wrose shall be represented by those persons who, immediately before 1<sup>st</sup> April 2004, are the elected councillors for the district wards of Bolton and Shipley East Wards.

## EXPLANATORY NOTE

*(This note is not part of the Order)*

This Order gives effect (with modifications) to a petition sent to the Secretary of State for the creation as parishes of areas within Metropolitan District of Bradford and for the establishment of parish council for those areas. The modifications relate to the proposed boundary for the parish of Wrose, which the Secretary of State has decided requires a minor adjustment to accord with the revised district ward boundary. A map forming part of this note gives a general guide to the area concerned.

Article 2 creates the parish to be called Sandy Lane

Article 3 creates the parish to be called Wilsden

Article 4 creates the parish to be called Clayton

Article 5 creates the parish to be called Wrose

Article 6 directs the City of Bradford Metropolitan District Council to establish parish councils for the new parishes.

Article 7 (1) provides for the parish of Sandy Lane to be represented by the district councillors elected for the district ward of Heaton until councillors for the new parish, to be elected on the ordinary day of election in 2004, come into office.

Article 7 (2) provides for the parish of Wilsden to be represented by the district councillors elected for the district ward of Bingley Rural until councillors for the new parish, to be elected on the ordinary day of election in 2004, come into office.

Article 7 (3) provides for the parish of Clayton to be represented by the district councillors elected for the district ward of Clayton until councillors for the new parish, to be elected on the ordinary day of election in 2004, come into office.

Article 7 (4) provides for the parish of Wrose to be represented by the district councillors elected for the district wards of Bolton and Shipley East until councillors for the new parish, to be elected on the ordinary day of election in 2004, come into office.

Article 8 specifies the 1<sup>st</sup> April 2004 as the order date for the purposes of the Local Government (Parishes and Parish Councils) Regulations 1999, which make provision of general application in relation to orders such as this Order.
