PREAMBLE AND RESOLUTION OF CONSTITUTION.

WHEREAS, God, our Heavenly Father, sent His only begotten Son, the Lord Jesus Christ, into the world, Who purchased and redeemed fallen man with His own precious blood, and called out of the world and saved a people, of whom He built and established His Church (Assembly of God, Matt. 16: 18), upon the foundation of the Apostles and Prophets, Jesus Christ Himself being the Head and Chief Corner-stone (Eph. 2:20), and organized and baptized it with the Holy Spirit, with its government upon His shoulders (Isaiah 9:6-7), said: "The gates of hell shall not prevail against it" (Matt. 16:18); and

WHEREAS, He gave the Holy Inspired Scriptures, (both old and new covenants, Heb. 8 6-13) as the all-sufficient rule for faith and practice, (2 Tim. 3:16), as follows: "All Scripture is given by inspiration of God, and is profitable for doctrine, for reproof, for correction, for instruction in righteousness: That the man of God may be perfect, thoroughly furnished unto all good works," we therefore shall not add to nor take from it (Rev. 22: 18); and

WHEREAS, He commanded that there should be no schism (division, sectarianism) in His Body, the GENERAL ASSEMBLY (Church) of the first born, which are written in heaven, Heb. 12:23; and

WHEREAS, We recognize ourselves as members of said GENERAL ASSEMBLY OF GOD, (which is God's organism), and do not believe in identifying ourselves as, or establishing ourselves into, a sect that is a human organization that legislates or forms laws and articles of faith and has unscriptural jurisdiction over its members and creates unscriptural lines of fellowship and disfellowship and which separates itself from other members of the General Assembly (Church) of the first born, which is contrary to Christ's prayer in St. John 17, and Paul's teaching in Eph. 4:1-16, which we heartily endorse:

THEREFORE, BE IT RESOLVED, FIRST, That we recognize ourselves as a GENERAL COUNCIL of Pentecostal (Spirit Baptized) saints from local Churches of God in Christ, Assemblies of God, and various Apostolic Faith Missions and Churches, and Full Gospel Pentecostal Missions, and Assemblies of like faith in the United States of America, Canada and Foreign Lands, whose purpose is neither to legislate laws of government, nor usurp authority over said various Assemblies of God, nor deprive them of their Scriptural and local rights and privileges, but to recognize Scriptural methods and order for worship, unity, fellowship, work and business for God, and to disapprove of all unscriptural methods, doctrines and conduct, and approve of all Scriptural truth and conduct, endeavoring to keep the unity of the Spirit in the bonds of peace, until we all come into the unity of the faith, and of the knowledge of the Son of God, unto a perfect man, unto the measure of the stature of the fulness of Christ, and to walk accordingly, as recorded in Eph. 4:17-32.

RESOLVED, SECOND, That we recognize all the above said Assemblies of various names, and when speaking of them refer to them by the general Scriptural name "Assemblies of God;" and recommend that they all recognize themselves by the same name, that is, "Assembly of God" and adopt it as soon as practicable for the purpose of being more Scriptural and also legal in transacting business, owning property, and executing missionary work in home and foreign lands, and for general convenience, unity and fellowship.

PROCEEDINGS OF COUNCIL,

DEVOTIONAL SESSION.

The first three days of the council were turned over absolutely to spiritual work, as per the custom established at previous councils. A large hall was secured for the Council, known as Turner Hall, on the corner of Beaumont and Morgan Streets, and this hall was comfortably filled in the night services. The Pentecostal Missions of St. Louis kindly recognized the Council by closing up for the ten days, and the people gathered together en masse from all quarters of the city and neighboring towns.

The spiritual services of the first three days were very blessed. Brother D. B. Rickard of Indianapolis gave the evening addresses which were well received, and which helped to deepen the spirit of the meetings until Sunday night, when a revival broke upon us which showed that God had undertaken. The power of God fell and the saints were greatly blessed and a number of souls touched God for victory, either in salvation or the baptism in the Holy Spirit.

From then until the closing night, this revival spirit continued. It was blessed to see the brethren, who had been wrestling with the problems of faith and practice during the day, lay aside all differences and go in wholeheartedly for the salvation of souls in the evening meetings. And God met this spirit of love and fellowship, not a service passing without some souls meeting God for their particular need, for spirit, soul or body, quite a number receiving the baptism of the Holy Spirit.

It was truly demonstrated during this Council that divine blessing does not depend upon any particular truth or belief in the Scriptures, but rather on the attitude of the hearts of the people toward God.

BUSINESS SESSION.

The first business meeting was called to order on Monday morning by the secretary, J. R. Flower, in the absence of the chairman and the assistant chairman, who were unable to be present.

On motion, J. W. Welch, of Essex, Mo., was elected Temporary Chairman.

On motion the roster or Council Roll was taken up and the brethren handed in their names. It was understood that the Council Roll would be completed at the conclusion of the Council Session on Wednesday.

On, motion, the sisters attending the Council, who are mature believers and in co-operative fellowship with our testimony, were requested to register as advisory members of the General Council.

Procedure of Former Council Adopted.

The procedure of former Council was unanimously adopted for the present Council, on motion, with the provision that if it should be found necessary to change during the Council now in session, it would be possible to do so.

On motion, J. W. Welch was elected Permanent Chairman of the Council.

On motion, Wm. G. Schell was elected Assistant Chairman of the Council.

On motion, J. R. Flower and B. F. Lawrence, the present Secretary and Assistant Secretary respectively, were elected to continue in their office as Secretary and Assistant Secretary of the Council.

The Council Committee.

On motion, the chair was directed to nominate four members of the Council Committee, the remaining three to be nominated later during the Council, the appointment of which was to be confirmed or refused by the open Council, the Council Committee to appoint a Chairman from among their number when the full number was chosen.

These names were presented to the Council for acceptance, and the brethren were all unanimously elected to the Council Committee.

While the chair was deliberating on the choice of the Council Committee, the Assistant Chairman, Wm. G. Schell, was requested to speak to the Council on how to win a backslider. Brother Schell complied with the request to the satisfaction and edification of the Council.

On motion, the Council Committee was instructed to report all resolutions to the Council as soon as possible with their recommendations attached to such resolutions as in their judgment should come immediately before the Council.

On motion, the Council adjourned until 9 o'clock Tuesday morning.

TUESDAY MORNING, OCT. 5, 1915.

The Council was called to order by the Chairman at 9 a. m. and the Council went before the Lord for a season of prayer and worship.

At the conclusion of the prayer service, the Chair nominated three brethren to the Council Committee, to make up the full number of seven.

On motion, these brethren were elected to complete the Council Committee.

The Council Committee presented the following resolution: "We, your committee, recommend that a committee be appointed by the chair to receive complaints for consideration regarding any applicant to the roster."

On motion the above resolution was accepted and adopted.

The Constitution Re-affirmed.

On motion, the Secretary was directed to read the Constitution of the General Council which was formulated at Hot Springs, Ark.

It was moved that this Council make a re-affirmation of our position and standing upon the same preamble and resolution adopted at Hot Springs, with the purpose in our hearts to remain there by the grace of God. Motion was unanimously carried.

The Council Committee made recommendation that Brothers Schell, Collins, Haywood and Bell, in the order named, lead a discussion of the mode and formula of water baptism.

On motion the recommendation of the Council Committee was accepted and adopted.

On motion, a time limit of thirty minutes was declared upon each of the brethren leading the discussion.

On motion, the discussion was confined alone to the Word of God.

On motion, the word "mode" was stricken from the resolution for discussion of water baptism, the speakers being confined to the formula only.

On the withdrawal of Brother Schell from the discussion, because of restrictions placed upon the discussion, Brother Jacob Miller was selected, on motion, to take his place.

The Discussion of the Formula to be Used in Water Baptism.

On motion, the discussion was commenced, Brother Miller leading out, followed by Brothers Collins, Haywood and Bell. The balance of the day was spent in free and full discussion of the formula to be used when baptizing believers.

At the close of the discussion the Council Committee recommended that the spirit and liberality of the Hot Springs Constitution be applied to the discussion regarding the formula on baptism and that the following statement be adopted as the expression of the attitude of this Council.

On motion, the statement was read before the Council and adopted:

1. That the essential thing in Christian baptism is, in obedience to the command of the Lord Jesus, the burial in water, with Christ, in the likeness of His death and resurrection, of a person who has repented and believed in Christ; (Acts 2:38, Rom. 6:3, 4) and that its validity should not be repudiated because of some slight variation in the formula repeated over the candidate in the act: that the use in connection with baptism of any of the following passages of Scripture would be acceptable so far as this Council sees it. Matt. 28:19, Acts 2:38; 8:16; 10:48; 19:5.

2. That the Scriptures give no example of any one who has once had Christian baptism ever being re-baptized.

3. That the matter, therefore, of general re-baptizing should not be pressed upon the saints by the preacher; that the only reason for re-baptizing any person is that his former baptism, taken as a whole, is to the conscience of the candidate not Christian baptism; that in such cases of individual conscience any minister or other person should have full liberty to be baptized, so long as he stays within the Scriptures on the subject; and it is hereby understood that any minister has perfect liberty, without just censure from any one, to baptize such persons whose consciences are not satisfied that they have fully obeyed God in Christian baptism.

4. We strongly advise against all strife, harsh contention or division over the matter of a scriptural formula and against teaching that there is a New Testament law requiring any fixed and invariable formula that must be repeated over a candidate in order to have Christian baptism. Any one has a perfect right to use any Scriptural formula or statement in connection with administering the ordinance of baptism in exactly the same way each time if he sees fit, but our advice is that no such legal or fixed phrases are at all necessary in order to make it a Scriptural baptism.

5. Nothing herein said shall be construed in such a way as to hinder any minister in setting forth his personal conviction as to what words he believes it most Scriptural to use in baptizing believers, but we hold no minister on either side of this controversy should go into a congregation not under his care, or where not duly invited so to do by those properly in charge of such congregation, to preach or teach on these controverted matters. We are strongly in favor of upholding the proper Scriptural authorities in all local assemblies and strictly opposed to men not connected with the local assembly overriding these proper local rulers under God.

6. This Council refuses to attempt to bind the consciences of men on this matter, refuses to draw any line of Christian fellowship or of ministerial fellowship on either side of the question over the matter of a baptismal formula, so long as the person concerned on either side keeps in a sweet Christian spirit, is not factious, does not tear up assemblies or does not disregard

the Scriptural officers in charge of local assemblies. We extend to both sides a welcome hand of fellowship so long as they are Christian in spirit and in conduct, but if either side depart from such spirit and conduct we cannot fellowship such conduct or spirit.

On motion, the chair was directed to appoint a committee on resolutions relative to the interests of the Publishing House.

The chair appointed the following brethren: E. N. Bell, J. R. Flower, Andrew L. Fraser, Wm. G. Schell, and L. K. Morgan.

The Council Committee recommended that the officers of the General Council be no longer regarded as ex-officio members of the Executive Presbytery, and that the number of the presbyters be limited to fourteen men.

On motion the recommendation was received and adopted.

On motion, the Council proceeded with the election of the Executive Presbytery.

On motion, the chair was directed to appoint a committee of seven to nominate the first five members of the presbytery, who shall in turn form a nominating committee to nominate the balance of the members of the Executive Presbytery.

The nominating Committee was appointed by the chair, consisting of Bros. Flower, Goss, Schell, Morgan, Langston, Jamieson, who nominated the following named brethren: J. W. Welch, Essex, Mo., Andrew L. Fraser, Chicago, Ill., D. W. Kerr, Cleveland, Ohio, B. F. Lawrence, Springfield, Mo., John Gobin, Lucas, Iowa.

On motion, the above brethren were elected to the Executive Presbytery. The five newly elected Presbyters formed a nominating committee, who nominated the following persons. E. N. Bell, Springfield, Mo., A. P. Collins, Fort Worth, Tex., D. H. McDowell, Tottenville, N. Y., S. A. Jamieson, Dallas, Texas, and J. R. Flower, St. Louis, Mo.

On motion, Sunday morning, Oct. 10th, was set apart by the Council to be devoted to a hearing of the missionaries.

On motion, the Council adjourned until 9 a. m. Thursday.

THURSDAY MORNING, OCT. 7, 1915.

The Council was called to order at 9 o'clock and the brethren went to prayer for Divine Assistance in the proceedings of the day.

On motion, Bro. Wm. G. Schell was given permission to speak on the baptismal formula as given by the Apostolic Fathers. He spoke for two hours and gave a great amount of interesting information which was appreciated by all.

On motion, the Council adopted the following resolution presented by the Council Committee:

"Resolved that it is the sense of this Council that the substitution of the name of 'Jesus Christ' for the word 'Son,' (Matt. 28:19) would better harmonize Matt. 28:19 with the book of Acts (Acts 2:38; 8:16; 10:48; 19:5) and, as a formula, would be preferable to the use of any one passage to the exclusion of the other.

On motion the following names were presented to the Council for election to the presbytery, each of whom were elected by the Council: A. G. Garr, Los Angeles, Calif., Will C. Trotter, Portland, Ore., R. A. Brown, New York, N. Y.

On motion, the Presbytery was authorized to fill up the number by electing the fourteenth man from the Southeastern States, after receiving a recommendation from the brethren in that section as to who would be most acceptable to them

FRIDAY MORNING, OCT. 8, 1915.

After prayer the chair called the Council to order and the Council Committee presented the following resolution for adoption:

Resolution on Publishing House.

"Whereas ever since the Word and Witness and the Weekly Evangel became the property and official organs of the General Council of the Assemblies of God, and the need arose for establishing a permanent printing and publishing plant to take care of our publications in a satisfactory manner, the problem has been before us of placing said publishing plant on a self-supporting basis, and of making the papers truly representative of the spirit and purpose of the General Council according to its constitution formulated at Hot Springs, and

"Whereas, under its present management and business methods, the papers have been unable to meet these requirements, both as to the editorial and spiritual matter published and their successful financial operation; the problem is now before us as to whether or not we shall retrench in order to reduce the expenses of the publishing plant in some manner, or that we shall find some other means of meeting the emergency, and

"Whereas, it is a well known fact, as well as a Scriptural statement, that the children of this world are wiser than the children of light, in dealing with these problems we must take them up from a strictly business standpoint, profiting by the procedure of other publishing houses who find themselves placed in similar circumstances, and

"Whereas, steps should be taken to accomplish these desired objects, therefore we recommend that the following resolution be adopted by the Council:

"Resolved, that this Council recommend to the Executive Presbytery that it appoint for the management of the publishing plant three brethren who shall undertake to operate the plant under the supervision of the Executive Presbytery, in such a way as shall express the spirit of the constitution as adopted at Hot Springs, Ark., in April, 1914; also that such business methods be adopted as shall place the publishing interests on a sound and secure financial basis."

On motion the resolution was adopted.

The Executive Presbytery met and appointed three brethren as a managing Committee of the papers, viz. J. W. Welch, J. R. Flower and Wm. G. Schell. The managing Committee was requested to consider and formulate plans for a campaign on the field with the threefold object of securing donations, subscriptions and loans for the papers and publishing plant

The Executive Presbytery also appointed J. W. Welch as Missionary Treasurer, with headquarters at 2838 Easton Ave., St. Louis, Mo.

The Executive Presbytery also appointed a Credential Committee, consisting of J. W. Welch, J. R. Flower and H. A. Goss. All applications for credentials and clergy certificates must be sent in to the Secretary, J. R. Flower, 2838 Easton Ave., St. Louis, Mo.

Resolution on Doctrinal Matters.

The Council Committee presented the following resolution for adoption:

"Whereas no passage of Scripture dealing with the institution of the Lord's Supper has anything to say about wine, or fermented wine, (Matt. 26: 27-29; Luke 22:18-20; Mark 14:23-25) and

"Whereas the drunkenness caused by the use of fermented wine at Corinth was strongly condemned by the Apostle (1 Cor. 11), and

"Whereas the Apostle Paul declares that the drinking of this cup showed forth the Lord's death, (not His resurrection) till He comes,

"Therefore we recommend to the saints and assemblies everywhere that they do not add a private interpretation to the Scriptures, but abide in the plain truths as taught by Christ in the Gospels, and

"Whereas many of God's people are stirred by the contention now raging over the following matters;

"Therefore be it resolved that the attitude of this Council is expressed in this statement:

1. THE NEW BIRTH.

We reject, as unscriptural, the teaching that being born anew is the same as the baptism with the Holy Ghost. One may be born of the Spirit and baptized in the Spirit nearly at the same time, and we would only rejoice at such an occurrence; but one must, if only a moment before, first yield to Christ and become a child of God by faith in Jesus before he can receive the abiding gift of the Holy Spirit, for Christ taught clearly that the world cannot receive the Holy Ghost, saying, "whom the world cannot receive." John 14:17.

2. THE SPIRIT AND THE BLOOD.

The Scriptures nowhere declare that the blood of Christ is the Holy Ghost, and we most emphatically disown and reject all such statements. The blood is the blood, and the Holy Ghost is the Holy Ghost, not the blood. The Bible nowhere speaks of the spiritual blood of Jesus.

3. THE FATHER AND THE SON.

We hold that Jesus is the Son of the living God and that the living God is the Father of Jesus, and we are opposed to all such unscriptural teaching as that the Son is his own Father. In Isaiah 9:6 the Son is called the Everlasting Father. This Everlasting Father is, in the Hebrew, the Father of Eternity, not the Father of Jesus. We believe God was in Christ (2 Cor. 5:19), and that God was not merely concealed in Christ, but that he was manifested or revealed in him (1 Tim. 3:16). He is now at God's right hand as our great High Priest in heaven (Mark 16:19).

4. CHRIST AND THE HOLY GHOST.

This Council holds that it is unscriptural to teach that the word "Christ" means the Holy Ghost. Jesus stood in the Jordan at his baptism praying, and the Spirit descended in the form of a dove and abode upon him. God, the Father, spoke out of heaven, saying, "This is my beloved Son, hear ye Him." (Matt. 3:16, 17.) We believe it all just as given. God is a Spirit, or the Lord is a Spirit; but the word Christ means anointed—anointed, of course, with the Holy Ghost, and we also are anointed with the Holy Ghost, but that does not make us the Holy Ghost. Jesus was God in the flesh before the Holy Ghost fell on him in the Jordan.

On motion, the resolution was adopted.

On motion, the Council adjourned until Saturday morning at 9 a. m.

SATURDAY, OCT. 9, 1915.

After prayer the Council was opened and the following Missionary resolution was presented by the Council Committee:

"Resolved, That this Council exert all its powers to promote the evangelization of heathen lands according to New Testament methods, viz.

First. In the proper testing of those who claim to be called to foreign work. Rev. 2:2, Acts 13:1-4.

- A. As to a personal experience of full New Testament salvation.
- B. As to a definite call to foreign work.
- C. As to physical, mental and spiritual fitness for the work.
- D. As to Christian standing, being endorsed by their local assemblies or five (5) members of the Executive Presbytery.

Second. In the proper sending, supporting and supervising of those approved.

- A. Every Assembly ought to have a definite part in it, either sending and maintaining one or more missionaries of its own, or sharing the burden of one or more missionaries with one or more other assemblies.
- B. Missionaries receiving the baptism on the field ought to be brought in touch and supported by the assemblies having no missionaries of their own.
- C. Missionaries who fail on the field ought to be brought home by the assemblies concerned.
- D. Missionaries are responsible to the Assemblies supporting them for all funds entrusted to them and should give a periodical report.
- E. No missionary should return home without the approval of his or her supporting assemblies except in extreme circumstances.

Third. Missionaries home on furlough should be maintained and supervised by their assemblies the same as while on the field. Every opportunity should be afforded them to present the needs of their field and of mission work in general, not only to their own assemblies, but the assemblies of God everywhere.

On motion, the resolution was heartily adopted.

On motion, it was adopted that the reading and editing and publishing of the minutes and all other unfinished business of the Council and Presbytery be left to the publishing committee.

On motion, the Council adjourned until the next General Council is called, when occasion demands it.
