## SCHOOL DISTRICT ORGANIZATION

#### 100 LEGAL STATUS

The Constitution of Illinois requires the State to provide for an efficient system of high quality public educational institutions and services in order to achieve the educational development of all persons to the limits of their capacities.

The Constitution of Illinois places the responsibility of establishing and maintaining public schools with the General Assembly and directs the General Assembly to provide for a State Board of Education, which has general supervision over all public schools. The School Code of Illinois provides that local school districts shall be governed by a properly elected Board of School Directors, or a Board of Education, under the general supervision of the State Board of Education. Local school boards are instruments of the Illinois General Assembly and derive their authority from the Illinois Constitution and Statutes and the regulations of the State Board of Education.

The General Assembly has implemented this constitutional mandate through the creation of school districts of various types. The District is governed by the laws set forth for school districts having a population of not fewer than 1,000 and not more than 500,000.

By recognizing the law, tradition, and ethics, local school boards have responsibilities to the local citizenry they serve and to the professional personnel they employ. Recognizing this three dimensional concept of source of authority and responsibility, the School Board is the policy making body for the District No. 262's schools and serves within the framework provided by law, the will of the local citizenry, and the ethics of the professional personnel employed by the School Board.

The school district constitutes a body corporate which possess all the usual powers of a corporation for public purposes, and in that name may, sue and be sued, purchase, hold and sell personal property and real estate, and enter into such obligations as are authorized by law.

Ashland - Chandlerville Community Unit School District No. 262 was formed as a result of a consolidation of Ashland C.U.S.D. No. 212 and Chandlerville C.U.S.D. No. 62 effective July 1, 1989.

At their Adjourned Board of Education meeting of March 25, 1997, the Board changed the name to the A-C Central Community Unit School District No. 262. The names of the schools were also changed to: A-C Central Jr. High, located at Chandlerville, and A-C Central Elementary School, located at Ashland. The High School remained as A-C Central High School, located at Ashland.

## 105 PHILOSOPHY

The school, as an integral part of the student's total environment, which includes the home as well as religious and civic organizations, promotes the continual life-long educational process. The school then assumes a primary responsibility for the transmission of the cultural heritage as well as the development of an attitude of critical thinking to prepare the student to cope with, adapt to, or change the social and physical environment.

The school also has a role in the development of a positive self-concept, which enables the student to better realize his full potentialities. Thus, the school strives to attain a realistic balance between the needs of the individual and those of society.

#### 106 OBJECTIVES

#### A. Self-Realization

- 1. Teach students to express themselves knowledgeably and understandably.
- 2. Stimulate an inquiring mind and an appetite for learning.
- 3. Help students reach their potential through realization of their strengths and weaknesses.
- 4. Foster development of moral character so that students can give responsible direction to their own lives.
- 5. Promote an interest in physical as well as intellectual exercises by encouraging social activities, personal hygiene, team work, and good sportsmanship in the development of leisure time activities.

## B. Human Relationships

- 1. Teach, through example, a respect for humanity, courtesy, and proper social behavior.
- 2. Foster an appreciation of the home and family as a social institution.
- 3. Instill an awareness of oneself as an individual as well as a member of a group through the development of self-discipline and self-control interaction and association within our society.

## C. Civic Responsibility

1. Teach students respect for law and authority.

- 2. Give students a working knowledge of the past while making them aware of their obligations to the future of our society.
- 3. Help students better understand the responsibilities and rights that accompany citizenship in a democracy.
- 4. Promote and develop an interest in the current events taking place in our society and the world around us.

- A. Set up a curriculum which will most nearly meet the common (reading, writing, and arithmetic) and special needs of the student, and to continually review the curriculum to insure relevance.
- B. Provide essential factual material and opportunities for the development of independent and constructive thinking.
- C. Create an atmosphere that will perpetuate an ever growing desire for learning, the awareness and appreciation of environmental beauty, and respect for property rights of others.
- D. Encourage students to increase their skill areas of thinking rationally, expressing their thoughts more clearly, and reading and listening with better understanding.
- E. Help the students to develop their ability for self expression, an awareness for literature, and a process for inculcating better habits of neatness and accuracy.
- F. Provide experiences that will develop initiative, leadership, integrity, appreciation, and a high regard for moral values.

- G. Offer students the opportunity to discover their own vocational and/or professional interest, develop their own possibilities, and to prepare for their next step after school -- educationally and vocationally.
- H. Encourage a sense of belonging, a feeling of inner confidence based on achievement, and a feeling that he/she is needed, wanted, and is a useful member of society.
- I. Provide a comprehensive health program, consisting both of instruction in the broad areas of health and of all areas required by school law.
- J. Make available to students a means of discovering and developing interest that will add color, enthusiasm, and purpose to their lives.
- K. Instill high ethical standards and to provide counseling for all students as necessary.

## 110 NON-DISCRIMINATION
