BUILDING FEATURES

The Florida Atlantic University Stadium is / has:

- A 29,419 seat multi-purpose open air stadium
- Designed and occupied as a mixed purpose facility for events from international soccer matches, concerts, intramural sports and campus center activities to convocations, graduations and corporate meetings
- Two (2) suite levels consisting of 22 luxury Suites of twenty (20) seats each and one (1) Presidents Suite consisting of one-hundred (100) seats for a total of five-hundred and forty (540) seats.
- A Delray Acura Club which measures 89' x 57' and a ceiling height of twelve (12) feet includes 164 exterior loge box seats and an interior 4,500 sf. air-conditioned lounge with seating upwards of 162+, upscale furniture, flat screen televisions all with a spectacular view
- A 3,920 seat Delray Hyundai Deck measuring 137' x 108' with a ceiling height of ten (10) feet with access to a 16,000 sf. covered outdoor lounge with flat screen televisions and comfortable lounge furniture with seating upwards of 208
- Four (4) complete locker rooms
- Two (2) complete locker rooms for game officials
- A 4,220 sf. football recruiting / VIP room
- A 1,000 sf. 40+ person interview room,

BOOKING / INSURANCE REQUIREMENTS

BOOKING

FAU Athletics Facility Rentals, Policies and Procedures

ACCOUNTABILITY:

This policy governs the use of all athletic facilities owned or leased by the University or otherwise under the University's operating authority for both University and non-University groups and individuals.

The policy will follow Presidential Memorandum #60 (PM60) which sets priorities for facility usage and establishes authority for determining scheduling procedures and applicable charges.

PRIORITY:

The use of the athletic facilities shall be given a priority to activities that advance the mission and purpose of the University to the greatest degree. Priority for the use of athletic (University) facilities is as follows:

- A. Academics
- B. Athletics team usage (practices and competition)
- C. University affiliated units (alumni, Student Government)
- D. Revenue generating events
- E. University faculty, staff and members of the University Community (students...)

SCHEDULING:

Procedures for scheduling athletics facility space are developed and instituted by the Athletics Director, Senior Associate Athletics Director and / or the Assistant Athletics Director of the Athletic Department.

Entities who wish to book said space must convey via written communication their intent to place a *first hold* on a date available via a "first come first served" scenario. The aforementioned Athletics department personnel will ensure date availability prior to placing a *first hold* on any date. If any *first hold* is challenged, a *second hold* is placed on that date. The *first hold* will then be asked to submit a **non-refundable** deposit, at the time of execution of the Agreement, equal to the base rental fee as set forth in the Estimate of Charges well as to facilitate a binding agreement or lose the hold in its entirety. If a deposit is placed by the *first hold* and they do not comply with a binding agreement at that time of notice, the deposit will be returned in full and the *second hold* will now occupy hold position one with a deposit, signed agreement and applicable certificate of insurance to be submitted.

USER CHARGES:

A three-tiered rental rate structure has been established for Internal University users, Non-profit and Commercial users. All event related costs to include: set up, coordination, security, police, parking, housekeeping, production, first aid and processing are borne by the event user and will be charged accordingly. Fees will not be waived or reduced unless written documentation is submitted to the Facility Administrator which then must be approved by the Senior University staff or President.

GENERAL CONDITIONS FOR USE:

- A. Deposits The User will be required to submit a **non-refundable** deposit, at the time of execution of the Agreement, equal to the base rental fee as set forth in the Estimate of Charges. A second deposit equaling the balance of charges will be submitted 14 days prior to the published event date. The University shall retain its final costs (and any other amounts owed under this Agreement) from ticket revenues collected. Within _14_ days after the conclusion of the event, the University shall remit to User the ticket revenues collected that exceed 150% of the estimated charges and any other amounts retained by or owed to the University under this Agreement. The balance of the ticket revenues, less the final costs and fees owed to the University, shall be finally remitted to the User within 40 days after the conclusion of the event. The University reserves the right to retain additional ticket revenues and pay amounts owed by User to University vendors in connection with this Agreement. Any costs or other amounts due not covered by ticket revenues shall be paid by User to the University within thirty (30) days of invoice.
- B. Facility Use Agreement A University Facilities Use Agreement will be used for facilities use by all individuals or groups. The agreement must be authorized by a financial entity / partner responsible for the overall responsibility of the event and its members. The responsible party must also be the same party who is listed within the COI.

INSURANCE REQUIREMENTS

Insurance Requirements: Certificate of Insurance (COI) – A COI must be submitted WITHIN 6 months of the event's date of occurrence. The following limits and additional insured language must be followed or the COI will be returned until it has been correctly submitted:

Contemporaneously with the execution of the Agreement, the User agrees to furnish to the University proof of comprehensive general liability insurance against claims for bodily injury, death or property damage occurring in connection with User's use of the facilities (and any related parking areas), for not less than Two Million Dollars (\$2,000,000) per occurrence/aggregate, naming the *Florida Atlantic University Board of Trustees, the Florida Board of Governors, the State of Florida, the Board of Trustees of the Internal Improvement Trust Fund of the State of Florida, Boca R & D Finance 16 Parcel 6, LLC, Boca R & D Project 16, LLC, Florida Atlantic Research and Development Authority, Palm Beach State College, and their respective officers, agents, volunteers and employees* as added insurers issued in form and by a company acceptable to the University. The User shall provide the University with copies of the policies providing these coverage (or certificates of insurance in the form of ACORD 28), together with a copy of the endorsements to the commercial general liability policies naming the additional insured parties. The University reserves the right, in its sole discretion, to also require insurance coverage as set forth above from any of User's participants, contractors, vendors, invitees or other third parties participating, assisting or using the University facilities or services in connection with this Agreement.

- C. Refusal, Reassignment or Cancellation The reservation and use of University Facilities is a privilege and not a right. The University reserves the right to refuse a request for use of University Facilities or to reassign or cancel any space reserved by any person or group. The applicant will be notified in writing, as soon as practicable, of any decision refusing the request for use of space or the reassignment or cancellation of a reservation.
 - Refusal of a request for facilities use may be based upon lack of available space, resources or suitable
 facilities; lack of substantial contribution of the proposed activity to the mission and purposes of the
 University; previous misuse of property or facilities by the user; previous failure to abide by the terms
 and conditions of the facilities use by the user.
 - 2. Reassignment of a space reservation may be based upon the needs of University programs, Athletic team practices or competition, maintenance and repair requirements, inadequate staffing or other reasons related to the affairs of the University.

3.	Cancellation of a reservation may occur when the reservation has been accomplished thru an	
	inappropriate means; when the use of the facility is not in conformity with the stated use; is unlawful	
and / or deemed inappropriate by University officials or when general terms have not been		

Financial Settlement & Expenses

- At the conclusion of the event, the lessee will be responsible for settling all outstanding facility expenses. The settlement will occur in the Florida Atlantic University offices. Any questions regarding the settlement procedure should be directed to your assigned Facilities/Operations staff member.
- All event expenses with the exception of rent are due in full prior to the start date of each event unless otherwise stipulated within the contract.

BOOKING PROCEDURES

Scheduling Dates

• Rental structure is based on established rental rates and determined by the type of event and space used. Further information can be obtained from the Facilities/Operations Department.

Contract Execution

 All arrangements are considered to be tentative until a contract has been fully executed and returned by both parties

DELIVERY POLICIES

On event day, deliveries may begin at 8:00 a.m. and must conclude 5 hours prior to the start of an event. Vehicles must present a game/event specific vendor delivery pass distributed from Chartwell's in order to be allowed access in and around the stadium. CSC with the assistance of FAU PD will log all license plates and drivers' identification information for vehicles entering the stadium on game day. All vehicles will be stopped and searched with Police EOD units conducting their own search prior to entering the stadium. All delivery vehicles must park in assigned lots outside of the stadium perimeter and will not be permitted to park within the stadium proper. Ice Trucks may make deliveries up until three (3) hours prior to kick off and are the exception to the rule and will be allowed to stage once cleared by the Police Department. All other vehicles must clear the stadium 5 hours prior to the start of the event.

Vehicles may enter the stadium post game approximately 30 minutes after the game/event has concluded once all of the patrons have departed the stadium and it is safe to enter. All vehicles must enter through the North stadium access perimeter road and have a valid vendor delivery pass to enter the stadium post game.

DISABILITY ACCOMMODATIONS-SEATING

- Seating for guests with disabilities is located throughout FAU Stadium. Guests who require special assistance
 are urged to make all ticket arrangements well in advance by contacting the FAU Athletics Ticket Office at 866FAUOWLS (328-6957).
- The day of a game/special event, special seating accommodations may be made at any of the ticket office locations located at the 4 entrance plaza gate locations, Gates 1-2, Gates 3-4, Gate 5 and Gate 6.

DISABILITY ACCOMMODATIONS – PARKING

- Parking for guests with disabilities will be available with proper DMV permit on a first- available, first-served basis. The individual who was issued the permit must be in the vehicle. The designated Disability Parking area is Lot 5 (South) which is northwest of the stadium along Palm Beach Avenue and the stadium service road at the valet / passenger drop off area.
- Additional disabled parking spaces are available throughout the campus. All of these spaces are available on a
 first-available, first-served basis to any guest with a disability who displays an authorized DMV permit; however,
 no shuttle service will be available for these spaces.

ELEVATORS

The Martin and Jane Greenberg Tower has four elevators to accommodate Premium seat holders, Suite holders, disabled guests, and credentialed media and staff. Guests with disabilities will receive priority.

EVENT MANAGEMENT

From the moment your event becomes contracted, an experienced Facilities/Operations staff member will be assigned to be your primary contact with our facility. Your Facilities/Operations staff member is your principal source to information and can be your "right hand" once you have arrived on site. Your staff member will take the information provided by your team and disseminate it to the appropriate facility personnel. With as much information as you provide, we will work with our entire staff to ensure your event is a success.

PROPERTY AND EQUIPMENT DAMAGE POLICIES

- Damages of any kind should be promptly reported to the Florida Atlantic University Police Department at (561) 297-3500. The client is responsible for any damages to the building, furnishings or equipment. The client and its contractors are invited to inspect the facilities prior to move-in and following move-out accompanied by the Facilities/Operations Coordinator.
- Decorations may not be taped, nailed, tacked or otherwise fastened to ceilings, painted surfaces, columns, or fabric
 and decorative walls.
- Adhesive-backed decals and stickers may not be distributed anywhere on the premises.
- "Glitter" and confetti may not be used in carpeted areas of the building.
- Planters, furniture and other building equipment may not be removed or repositioned. Any movement of furniture for event purposes shall be handled by Florida Atlantic University personnel.
- Motorized vehicles, forklifts, gas or electric carts, bicycles, scooters, and similar equipment may not be operated on any carpeted areas of the building.
- Carpet runners, show carpet or other temporary floor coverings over permanent carpet must be approved in advance. Double-faced tape and heat tapes are prohibited for direct application to permanent carpet.
- Clients and their service contractors are responsible for the complete removal of bulk trash, crates, pallets, packing materials, lumber, etc., prior to show opening and during move-out. "Bulk trash" is defined as materials that cannot be removed with a broom.

Failure to comply with the above mentioned items will result in additional financial obligations on the part of the client.

RE-ADMITTANCE POLICY

Once you are admitted (ticket scanned) into FAU Stadium, you may not exit the stadium and re-enter using the same ticket. If you have an emergency and must depart the stadium, visit the Fan Services locations near sections 114 and 125 where a Fan Services Representative will address your needs.

REQUEST FOR ASSISTANCE

All request for assistance and reports of disruptive behavior should be directed to the closest available event staff personnel. Event staff personnel are positioned at each entry/exit portal throughout the stadium for your convenience.

SMOKING POLICY

Smoking is not permitted in any areas of the Florida Atlantic University stadium. The designated smoking area is located exterior of the stadium at Gate 4 near section 128.

WEB SITE

The Florida Atlantic University site on the World Wide Web is www.faustadium.com. This site contains all the up to date information about the Florida Atlantic University Stadium and building information.

FAU Stadium A-Z General Guidelines

Admission

- All guests entering FAU Stadium will have a valid for admission unless they are younger than two years of age. Once guests enter the stadium, they may not exit and re-enter.
- (FAU Football) Students are encouraged to print their tickets from the FAU "MyFau" web portal for each home game beginning two weeks prior to the home game. The pre-printed ticket and a current Owl Card is required for admittance thru Gate 3.
- Rules for admission are printed on the back of tickets issued to attendees. FAU students are also responsible for adhering to all Rules of Conduct as outlined in the FAU Student handbook.
- As you enter FAU Stadium, an attendant will scan the barcode located at the bottom of your ticket with a handheld ticket scanner. Please make sure that each person in your party presents his or her ticket individually.

Alcohol Policy

- No alcohol is allowed inside of the stadium and can't be sold at any time except for in the premium seating areas. Anyone in possession with Alcohol inside the stadium except for the suite and priority club / premier level, is subject to ejection from the stadium.
- Alcohol may only be served and sold on the Delray Acura Level, Delray Hyundai Deck and suites only by Chartwells who has an approved license. Alcohol must stay inside the Delray Acura Level, Delray Hyundai Deck and Suites level. CSC Management staff is stationed at each exit door to the club to insure that Alcohol does not leave the club area. All alcohol sales must stop at the end of the third quarter.
- The Florida Atlantic University's drug and alcohol policy forth at: http://www.fau.edu/policies/1.2 Alcoholic Beverages.pdf. This policy states that the sale, service, possession and consumption of alcoholic beverages shall comply with state and federal laws. This policy shall remain in effect for all home football games. Specifically, within the University Policy regarding Tailgating, the policy defines tailgating activities as follows: -"a small party or group within a designated space that does not take up any parking space or impede traffic in any way--on university premises that involve the consumption of alcohol shall be restricted to specifically designated locations monitored by the university police department. Tailgating shall not be permitted more than three (3) hours before the event or after the event has commenced. Kegs will not be permitted by any persons other than approved licensed alcoholic vendors".
- This policy applies to the all FAU campus locations and not the surrounding area. No public sale or distribution of alcohol is authorized on campus (except in permanent dining establishments). Kegs, glass containers and beer funnels are not authorized on campus.
- PROMOTIONAL ACTIVITIES INVOLVING ALCOHOL OR TOBACCO ARE NOT ALLOWED ON CAMPUS AT ANY TIME.

Alcoholic Beverages

- Alcoholic beverages ARE STRICTLY PROHIBITED from being brought inside of FAU Stadium. No alcoholic beverages are authorized in the stadium on game day (except in the Stadium Suites, the Delray Acura Level and the Delray Hyundai Deck level). Persons in possession of alcoholic beverages (outside of these levels) may be ejected from the stadium. No refunds will be granted in these cases.
- Possession or consumption of alcoholic beverages is prohibited by persons younger than 21 years of age. Anyone consuming alcohol must be prepared to show proof that he or she is 21 years of age or older.
- This policy applies to the all FAU campus locations and not the surrounding area. No public sale or distribution of alcohol is authorized on campus (except in permanent dining establishments).

ATM's and Locations

• There are 3 ATM locations within FAU Stadium. The locations are on the main concourse and on the Delray Hyundai Deck. On the main concourse, ATM's are located at sections 122 and 134 and on the Delray Hyundai Deck at section 205 around the corner form the Team Store.

Banner, Signs and Flags

• Signs are authorized inside of FAU Stadium after inspection; however, no banners, flags, signs with poles, sticks or braces will be allowed.

Bus Parking

• Parking for charter buses is available on event day. Parking passes may be pre-purchased via www.parkwhiz.com. Advance parking pass sales are strongly recommended. Bus parking will be allowed in Lot 5N just north of the stadium along Palm Beach Avenue.

Cameras

• No professional video cameras are permitted inside of the stadium. Still cameras (professional) or cameras with lenses over five inches long and/or 50 mm and above are also not permitted.

Concessions

• There are 10 concession stands located on the main concourse with 46 POS (points of sale), 4 POS on the second floor within the Delray Hyundai Deck at the Tiki Bar and 3 POS on the third floor Delray Acura Lounge. Current selection of fare includes Subway in the South, Mississippi Sweets BBQ, Pita Hut and PCI Professional Concessions in the East and Chicken Grill in the North.

<u>Disability Accommodations – Parking</u>

- Parking for guests with disabilities will be available with proper DMV permit on a first- available, first-served basis. The individual who was issued the permit must be in the vehicle. The designated Disability Parking area is Lot 5 (South) which is northwest of the stadium along Palm Beach Avenue and the stadium service road at the valet / passenger drop off area.
- Additional disabled parking spaces are available throughout the campus. All of these spaces are available on a
 first-available, first-served basis to any guest with a disability who displays an authorized DMV permit; however,
 no shuttle service will be available for these spaces.

Disability Accommodations – Seating

- Seating for guests with disabilities is located throughout FAU Stadium. Guests who require special assistance
 are urged to make all ticket arrangements well in advance by contacting the FAU Athletics Ticket Office at 866FAUOWLS (328-6957).
- On game day, special seating accommodations may be made at the SW ticket office plaza Gate 1-2 location.
 Additionally, guests may visit the Ticket Services window located on the stadium concourse near section 125-126 for inquiry.

Elevators

 The Martin S. and Jane Greenberg Tower has four elevators to accommodate Delray Hyundai and Acura Club seat holders, Suite holders, disabled guests, and credentialed media and staff. Guests with disabilities will receive priority.

Fan Services

- FAU is committed to providing guests the ultimate game day experience. Should any have questions or need assistance, FAN Services areas are located in and around FAU Stadium for your convenience. The following Fan Services locations are:
 - o Exterior of the stadium pre-game at the SW Gates 1-2 and SE Gates 3-4 Plaza Entrance Gates
 - o Interior of the stadium on the NE concourse at sections 125-126
 - o Interior of the stadium on the South concourse at section 137
 - o Interior of the stadium on Delray Hyundai Deck near sections 103-104

First Aid Rooms/Medical Services

• The Boca Raton Fire Rescue Department has teams that will provide emergency medical services on the campus and within the stadium on the event day. The First Aid rooms are staffed by members of Boca Raton Regional Hospital and are located on the SE concourse at section 130 and on the NW concourse at section 112.

Golf Carts / Other Vehicles

Non-official (Stadium Operations, AAA Parking, Boca Raton Fire Rescue golf carts are deemed Official) FAU golf
carts, all-terrain vehicles and utility vehicles are strictly prohibited within the FAU stadium proper. Advance
clearance and an FAU Police Department issued permit from the FAU Police Department is needed in order to
access FAU Stadium with a golf cart or other vehicle. The FAU Police Department can be contacted at (561) 2973500.

Lost and Found

• During the game, lost and found items will be taken to the Stadium Operations Center (SOC) located in the NW concourse near section 112. Unclaimed articles will be taken to the FAU Police Department. The FAU Police Department can be contacted at (561) 297-3500.

Merchandise

• Official FAU Owls merchandise can be purchased on game day at locations inside and outside of the stadium. The Team Store is located at sections 119, 122 and 134 on the main concourse and on the Priority Club level at section 202. Merchandise is also available online at www.fausports.com.

Parking

- The FAU campus includes enough parking spaces to accommodate event day crowds. On event days, the campus will be divided into three (3) different parking zones:
 - **Zone 1**: Entry from Glades Road onto West University Drive
 - Zone 2: Entry from Glades Road onto East University Drive
 - Zone 3: Entry from Spanish River Boulevard onto FAU Boulevard
 - ❖ Employee Parking: Will be in Lot 11 Auxiliary just west of the Stadium. Employees are encouraged to access lot 11 Auxiliary from BOTH North and South I-95 exiting onto West Yamato Road to Military Trail South to Spanish River. Left (East) onto Spanish River to FAU Boulevard and right to the stadium.
- Parking passes may be pre-purchased via the Park Whiz (<u>www.parkwhiz.com</u>) web site and enter "FAU Stadium" for the pre-purchase of parking passes.
- Parking is only authorized in designated parking lots and garages. Patrons who illegally park or along any campus roadways or in other non-designated parking areas are subject to towing and fines.

- University parking decals/hang tags will not be honored on event days except for permanently assigned campus green residential housing decals.
- Post-game traffic routing will be prioritized using all available exits to expedite movement of traffic off campus. It is strongly advisable to exit campus utilizing the same direction in which you arrived from.
- Bus Parking. Parking for charter buses will be available on game day. All buses must be registered and possess proper credentials for admittance to campus and parking. Additional game day parking and traffic information (including maps) will be posted on the stadium website at www.fausports.com.

Security Measures

- All persons entering the stadium are subject to visual inspection of all items carried into the stadium. Guests are encouraged to leave their belongings in their vehicle whenever possible.
- Searches may cause delays in entering the stadium. Gates open 60 minutes prior to the event start time or TBA. Guests are encouraged to arrive early.
- Law enforcement personnel may conduct random inspections of any vehicles parking near the stadium. Authorized FAU Police Department representatives have the right to stop any hazardous or inappropriate activities anywhere on campus. Including in the stadium. Individuals conducting hazardous or inappropriate activities are subject to arrest and prosecution under applicable state and federal statutes.

OUTSIDE CATERING FOR CONCERTS

Kitchen space is not available for outside catering services should a performer, band, or show arrange for one. Space outside of the building will be provided at no charge; however any water or electrical needs will incur a charge based upon amount needed.

CROWD AND FACILITY MANAGEMENT

Crowd and facility management at the FAU Stadium is accomplished by trained and qualified professionals employed by, or under contract to, the University. These professionals are experienced at managing facilities and interacting with crowds at similar sized facilities and events. Law enforcement and security personnel understand the underlying dynamics of large crowds as well as the distinction between crowd management and crowd control. Policies and procedures as well as plans to ensure the following are in place:

- Staff is responsible for facility operations and security is familiarized with the facility and its systems. They
 receive training on all building systems prior to initially opening the facility to the public and periodically
 thereafter.
- Staffs responsible for facility operations and security are properly supervised and have adequate experience with similar sized events and crowds.
- Qualified personnel conduct pre-event inspections of the site to determine potential hazards and vulnerabilities that will include, but not be limited to storage places, sanitation systems, fall hazards, and lighting.
- The overall site segregates the audience from operational areas, and signs and barriers are in place for restricted and potentially hazardous areas.
- Temporary structures and staging areas are installed in compliance with applicable construction codes.
- Parking is designated for event patrons, participants, teams, vendors, staff and volunteers as well as the media and emergency services.
- A traffic management plan has been developed by University Police and local public agencies addressing: a) site access and parking, b) pedestrian access, c) traffic flow, d) traffic surveillance and incident management.
- The traffic management plan includes a contingency plan to establish emergency access, alternate routes, road/lane closures, or traffic redirection when needed.
- All electrical equipment, connections, cords, cables, and wires are checked to ensure they are properly secured to prevent damage, tripping hazards or unauthorized access.
- The locations and operation of controls for lighting, sound and other electrical systems are identified in order to ensure they can be turned on or off in an emergency situation.
- Equipment using natural gas, propane, or other liquid fuels or gases are safe and in good condition, and are installed properly. All compressed gas containers are securely anchored in an upright position.
- All fuel containers and hazardous materials storage areas are restricted to authorized personnel only.

Crowd Management (Continued)

- Fire prevention strategies, including avoiding excessive concentrations of combustible materials, keeping all areas clean of rubbish or debris, and avoiding misuse of electrical equipment are enforced.
- Careful use of open flames, cooking, pyrotechnics, spark producing equipment and other incendiary activities are monitored and controlled.
- Fire detection and suppression systems are regularly maintained in accordance with code requirements
- Particular attention is paid to public health issues, especially in food, water and sanitary facilities, and safe work practices are enforced to avoid occupational hazards and injuries.
- Temporary water supplies are transported and stored in approved and protected containers and are tested for bacteriological safety.
- Proper crowd management and control strategies are in place to provide attendees with sufficient information and means and methods to access the event, so they may participate in the event in a safe, secure, and enjoyable manner.
- Security and event staffs are highly visible, properly trained, and are available in appropriate numbers for the event. Security and event staffs understand and enforce policies and procedures in place to restrict undesirable behaviors, and maintain law and order to protect the public safety.
- Security systems and personnel are in place to maintain controlled access to sensitive areas while allowing
 people to enter and use the facility. Simultaneously the system is able to evacuate the occupants in a quick
 and orderly manner.
- Appropriate admittance and credentialing systems are in place to facilitate and control access to the event areas.
- Suitable internal and external communication systems and procedures are in place to allow communication between stadium operations staff, security personnel, law enforcement, and other emergency responders.
- Risk Management and contractual review procedures are in place for Stadium events that are promoted or held by external organizations.

EMERGENCY MANAGEMENT

Command and Control

University Police assume initial incident command of game day security and managing emergency response; from traffic control and parking to crowd control and event safety. Mutual aid agreements are in place to provide personnel and resources from various external agencies such as the City of Boca Raton Police Department, City of Boca Raton Fire Rescue, Palm Beach County Sheriff's Office, Florida Highway Patrol and others. Depending on the emergency event or threat at hand, command and control may be assumed by another agency or unit or there may be a need for joint or unified incident command. Members of the EEG are kept informed and are in consultation with incident command throughout the life of an incident.

The stadium is equipped with an incident command center and an overflow room for additional emergency response personnel. Key emergency response unit/agency representatives are stationed in these two rooms to receive reports of potential or actual emergency events or threats, notify appropriate emergency response personnel, and initiate, facilitate, and direct response.

Security and police personnel are stationed at or patrol all areas/sections of the stadium and associated parking lots and tailgating areas to monitor and/or respond to problems. Communication capabilities and a clear reporting structure are in place for field units/personnel to notify the incident command center of any potential or actual emergency events or threats.

The general emergency procedures to be followed are:

- 1. Assess the situation
- 2. Evaluate and determine the extent of the emergency and assume control of the area
- 3. Determine the assistance needed
- 4. Notify incident command
- 5. Remain in charge of situation until relieved by higher authority

The most visible component of the system is a new light emitting diode (LED) video display that towers over the south end zone area. Measuring approximately 30 feet high by 50 feet wide the video display incorporates excellent clarity and contrast of video images, multiple levels of protection from the elements and a more robust cabinet design with an improved ventilation system. This technology and its control system allow for complete flexibility in programming. The video board can operate as a single giant display or be divided into multiple zones (windows) to show a wide variety of statistics, information, graphics, animation and live and recorded video.

SOUND SYSTEM

Included in the video board structure is the Daktronics custom sound system. The system delivers pounding bass energy, smooth mid and high range frequencies and high impact entertainment. Daktronics audio systems provide the latest in digital audio technology to deliver shaking bass, crisp highs and natural sounding vocal reproduction. The system also operates efficiently using reduced power due to more efficient digital amplifiers and power supplies.

The most spoken about feature of the stadium is a venue-wide digital media display network which incorporates over 70 professional grade LCD screens. This next generation broadcast solution provides an internet protocol television (IPTV) solution that delivers multiple live content channels to any display in the venue. The solution is built around a computer network structure; therefore it can be expanded to accommodate nearly any form of digital media.



TELEVISION

There is a designated production truck parking area on the North side of the stadium. At that location there are (3) 200 amp services, phone lines, and 6 fiber runs with electrical hook up.













Television crew parking is located within Lot 5 North of the Stadium and in close proximity to the production truck parking area. The Satellite truck can be accommodated adjacent to the production truck but may be in the roadway. With only 60 feet, there is not enough room to park a production truck, tractor, and satellite truck all in the allotted spaces provided.

The broadcast booth is on the 6th floor, room 610. It is approximately 1,100 feet from the Production truck. Each window has a small vent type window on the top that opens outward.










MAP OF SURROUNDING AREA OF FLORIDA ATLANTIC UNIVERSITY

FAU Stadium Facts and Figures

General Stadium Specs

- 1. Architect: Schenkel Schultz / HKS (West Palm Beach, Florida and Dallas Texas)
- 2. Construction Manager: James A. Cummings / Balfour Beatty
- 3. Stadium Seating Contractor: Dant Clayton (Louisville, KY)
- 4. 29, 419 Total Seats.
- 5. Total cost of \$70 million.
- 6. Features a tropical theme.
- 7. Only stadium in the United States that offers a view of the Atlantic Ocean.
- 8. Mixed Use / Multi-Purpose facility used for campus activities, convocations and graduations, concerts, speakers and conventions as well as collegiate, national, and international sport activities.
- 9. Consists of 144,470 sq. feet (591' x 698')
- 10. 91,179 sq. feet of total building area.
- 11. 277,940 sq. feet of total open space.
- 12. Total height of 145 feet (6 Stories plus Roof Stair).

Construction Figures

- 1. 1,116 tons of structural steel used at the Press tower and scoreboard.
- 2. 1,800 tons of structural steel used for the bleach systems.
- 3. 400 tons of Aluminum bleacher.
- 4. 9,000 cubic yards of concrete used in the building structures.
- 5. 3,800 cubic yards of concrete used for hardscape.
- 6. 3,000 cubic yards of concrete used in the foundations.

Lighting

- 1. 2000 International Series by Qualite 20% more efficient than conventional outdoor sports lights.
- 2. Total of 160 light fixtures clustered in 8 different positions around the stadium; 6 stand-alone posts and 2 banks atop the press box tower.
- 3. Stand-alone lights stand 130 feet above the field, two lights atop the press box tower stand 145 feet above the field.
- 4. Cost: \$500,000 dollars
- 5. Installation Cost: \$230,000 approx.
- 6. Meant to reflect light evenly across the field for maximum brightness for both spectators and television cameras.

Seating

- 1. Each seat is "individualized", which ensures a seatback for every ticketholder.
- 2. Total of 5,100 flip-up chairs located in the Priority and Premier Club sections.
- 3. Remaining seats will have individual plastic buckets attached to an aluminum bleacher with plastic back supports attached to the bleacher back.
 - a. Each of these seats is 19"- 20" wide.
- 4. Adding individual seats added approximately \$300,000 to the stadium cost.
- 5. On the east side of the stadium an FAU logo is designed into the seats using the FAU colors red, white and blue.
- 6. Total of 301 ADA seats.

Scoreboard

- 1. Daktronics 50' tall by 30' wide video board that can show live video, replays, statistics, commercials and animations.
- 2. Approximate weight: 18,000 pounds.
- 3. 47% larger than FIU's (Florida International University) video board and twice the size of UCF's (University of Central Florida) video board.
- 4. Total cost of the board and corresponding equipment was approximately \$1.7 million.
- 5. Video can be shown on all 1500 square ft. of the display screen.
- 6. Total of 1.8 million LEDs that are spaced 15 millimeters apart to provide a near high def. resolution of 600 x 1008.
- 7. A near 160 degree viewing angle.
- 8. There will be live feeds from three separate cameras that will feed into the video board.
- 9. Video board will be controlled by a touchscreen computer that is housed in the press box tower, which will allow the board to show real-time game statistics and out-of-town scores.
- 10. There will also be a smaller, more traditional scoreboard behind the south end zone.

Stadium Amenities

- 1. Two suite levels consisting of 24 total luxury suites.
- 2. 1 VIP Party Suite with seating for up to 90 guests.
- 3. 5,000 square ft., 1,082 seat, air conditioned Delray Acura Club level that includes a private lounging area as well as 136 loge seats which can be utilized for award banquets or VIP functions.
- 4. A 3,920 seat Delray Hyundai Deck level within a covered 16,000 square ft. Tiki Bar area.
- 5. Four complete locker rooms for teams with upwards of 75 members.
- 6. A 5,000 square ft. Promoter / Merchandise room.
- 7. A 4,220 square ft. football recruiting room that also may serve as a VIP room.
- 8. A 1,000 square ft. interview room that holds up to 40 + people and is connected up to the press box radio booths.
- 9. Two complete locker rooms for game officials.
- 10. 11 different concession stands as well as additional product kiosks. These are located on the main concourse with 46 different points of sale. 4 points of sale on the second floor within the Delray Hyundai Deck and 3 points of sale within the Delray Acura Club.
- 11. A covered 16,000 square ft. outdoor area that can be accessed by suite, loge, Delray Hyundai Deck and Delray Acura Club seat holders.
- 12. Several press rooms that are designed for radio and television broadcast.

Surface & Field

- 1. The playing surface consists of a first cut Celebration Bermuda Turf Grass, a tough and durable surface with a strong root system cut to a length of 5/8" inch.
- 2. The FAU playing field is the only natural grass field within the Sun Belt Conference.
- 3. The herring bone designed irrigation system is comprised of about 6,700 feet of irrigation pipe able to supply 100,000 gallons of water (8-9 inches) per hour to the playing field.
- 4. Sub base consists of a layer of 6 inch USGA approved top soil on top of 4 inches of course sand.
- 5. Irrigation system can send as much as 120 gallons per minute of re-claimed water onto the field.
- 6. The playing field is crowned at 7 ½" from the sidelines to the center of the field.
- 7. International FIFA sized soccer field measuring 120 yards by 75 yards.
- 8. Removable hinged goal posts making it ideal for soccer conversions.
