

CRIMINAL CHARGES AGAINST SEAN BOUSHIE

I have carefully researched Montana statutes, and I am filing charges against Sean Boushie for several hundred counts under Stalking, Assault, Aggravated Assault, Identity Theft, Criminal Defamation, Criminal Invasion of Privacy, Assault with Weapon, Negligent Endangerment, and Intimidation. I believe the federal crimes of cyberstalking and terrorism may also apply. I am not an attorney, so I may have missed many criminal statutes that he has violated.

VENUE

[Montana Code – Section 46-3-110: FILING THE CHARGE:](#)

(1) In all criminal prosecutions, **the charge must be filed in the county where the offense was committed unless otherwise provided by law.**

[Montana Code – Section 46-3-112: REQUISITE ACT IN MULTIPLE COUNTIES:](#)

(1) Except as provided in 46-3-110(2), **if two or more acts are requisite to the commission of an offense or if two or more acts are committed in furtherance of a common scheme, the charge may be filed in any county in which any of the acts or offenses occurred.**

(2) Except as provided in 46-3-110(2), **if an act requisite to the commission of an offense**

occurs or continues in more than one county, the charge may be filed in any county in which the act occurred or continued.

(3) If an element of an offense under 45-5-220, 45-5-625, 45-8-212, or 45-8-213 involves an electronic communication, the charge may be filed in the county in or from which the electronic communication was sent or in the county in which the electronic communication was received or to which it was sent

Sean Boushie committed these offenses in either Missoula County at the University of Montana or at his home in Ravalli County Montana.

Virtually all of the stalking under 45-5-220 was done by electronic communications in either Missoula County at the University of Montana or at his home in Ravalli County Montana. I am filing in both counties as some investigation will be needed to determine from which county various electronic messages were sent. There will be a significant number in both locations based upon day of the week, time of day, and IP addresses that I know.

Due to 46-3-112 (2), it appears that some of these offenses could go either way. I'll have to leave that to the experts.

GENERAL OVERVIEW

I fear for my safety and the safety of my family. I am in fear of bodily harm to myself and my family, violent injury to my property, and more.

I wish to file criminal charges against Sean Boushie for Stalking, Assault, Aggravated Assault, Identity Theft, Criminal Defamation, Criminal Invasion of Privacy, Assault with Weapon, Negligent Endangerment, and Intimidation.

There is absolutely no question that Sean Boushie has followed me online and contacted me through electronic communications for the purpose of harassing and intimidating me. He has attempted to terrify, threaten, harass, annoy, and offend me with lewd and profane language, lewd and lascivious acts, threats to inflict physical harm, and more.

Virtually all of the stalking and harassment has been cyberstalking, the use of electronic communications (Internet and email) to stalk and harass me and those acquainted with me.

The stalking includes the making of false accusations and false statements. These include that I am a pedophile, a pedophile lover, anti-gay, bigoted, a criminal operating a scam, a person who has sex with animals, a sexual deviant, a terrorist, a serial killer, and more.

The stalking includes monitoring, as the stalkers claim to be tracking my Internet activity. Sean Boushie has participated in my online radio talk shows to monitor and/or to disrupt the calls and the online chat. The monitoring includes repeated online posts of libelous, threatening, harassing statements.

The stalking includes threats, including death threats.

Any reasonable person in possession of this information would regard it as sufficient to cause another reasonable person distress.

The libel and slander is truly unbelievable. Sean Boushie and other stalkers invent one false claim after another. People who I don't know make statements in writing that have no truth whatsoever and can be easily proven to be false. It's like they feel they can say anything and get away with it.

Sean Boushie and other stalkers have repeatedly violated my privacy rights and copyright by using photos and videos of me that they have no legal right to use. Photographs of me have been doctored. Absolutely sickening videos have been produced about me.

My family is so terrorized by the actions of Sean Boushie that my wife of 42 years has just divorced solely because of her fear. My daughter will no longer speak with me or allow me to be around my two granddaughters. I no longer have contact with my son. I have lost my entire family.

I have 15 gigabytes of online posts, emails, videos, and more.

I know that Sean Boushie uses multiple aliases and screen names in her stalking of me.

I did file a complaint with the campus police, FBI, and Missoula Police, but the police told me I needed to make a police complaint in Cobb County to start the process. I did so -- Case #13007687, but that is not the law. The law is detailed above under "VENUE."

Since May 2012, Sean Boushie has emailed me under various names and email addresses. He has posted harassing messages and threats on my website, on my Facebook page, on my YouTube page, and on the sites and pages of others.

I sent several cease and desist emails to him as well as complaints to abuse@yahoo.com and abuse@gmail.com. I kept copies of those first emails, but I am currently unable to locate them. I have copies of 16 of the cease and desist notices provided to him.

I do not know Sean Boushie. I have never met him. I apparently became a target because I know and believe Crystal Cox, a woman who he hates.

I have received reports from others who say they have been cyber attacked by him. I have never emailed him except in response to emails and when copying him on abuse complaints filed with Yahoo and Gmail. I have never harassed him in any manner. I have written articles exposing him as a stalker, a liar, and one gross person, but that's it, and that is not stalking or harassment -- just the news, just the facts.

He has directly threatened my family – my ex-wife and son.

CRIMINAL CHARGES:

Mont. Code Ann. § 45-5-220. Stalking.

(1) **A person commits the offense of stalking if the person purposely or knowingly causes another person substantial emotional distress or reasonable apprehension of bodily injury or death by repeatedly:**

(a) following the stalked person; or

(b) **harassing, threatening, or intimidating the stalked person, in person or by phone, by mail, or by other action, device, or method.**

(2) This section does not apply to a constitutionally protected activity.

(3) For the first offense, a person convicted of stalking shall be imprisoned in the county jail for a term not to exceed 1 year or fined an amount not to exceed \$1,000, or both. For a second or subsequent offense or for a first offense against a victim who was under the protection of a restraining order directed at the offender, the offender shall be imprisoned in the state prison for a term not to exceed 5 years or fined an amount not to exceed \$10,000, or both. A person convicted of stalking may be sentenced to pay all medical, counseling, and other costs incurred by or on behalf of the victim as a result of the offense.

(4) Upon presentation of credible evidence of violation of this section, an order may be granted, as set forth in Title 40, chapter 15, restraining a person from engaging in the activity described in subsection (1).

(5) For the purpose of determining the number of convictions under this section, "conviction" means:

(a) a conviction, as defined in 45-2-101, in this state;

(b) a conviction for a violation of a statute similar to this section in another state; or

(c) a forfeiture of bail or collateral deposited to secure the defendant's appearance in court in this state or another state for a violation of a statute similar to this section, which forfeiture has not been vacated.

(6) **Attempts by the accused person to contact or follow the stalked person after the accused person has been given actual notice that the stalked person does not want to be contacted or followed constitutes prima facie evidence that the accused person purposely or knowingly followed, harassed, threatened, or intimidated the stalked person.**

As of July 21, 2013, there were 109 counts of the Stalking law that I identified on the website that I set up to document all of this – www.SeanBoushie.com. There have been several since, with the latest on August 3 and August 8, 2013, both of which were received by me in Missoula. I am experiencing substantial emotional distress AND reasonable apprehension of bodily injury or death because Sean Boushie has repeatedly harassed, threatened, and intimidated me by mail,

electronic communication, as defined in [45-8-213](#), including email, mail, and online postings. There are OVER 100 instances that I have identified and documented.

Sean Boushie has made many threats that I consider to be threats to kill me.

On August 4, 2013, I drove to Missoula from Billings. During that drive, a car in the lane to my right and just ahead of me burst into flames and a cloud of smoke billowed out, completely obscuring the roadway and the other vehicles. I grabbed my camera and was able to snap a couple of photos after I had slowed.



The smoking car is in the right lane in the photo above and cannot be seen for all the smoke. Because of the death threats that I have received, I didn't stop, though I believe the car in front of me did.

I posted news of this on my Facebook page. Then at 9:03 pm, I received this email from Sean Boushie in which he claims he shot the car to my right while trying to shoot me. Note: Lately, he uses my name with an e on the end as his alias when he emails me:

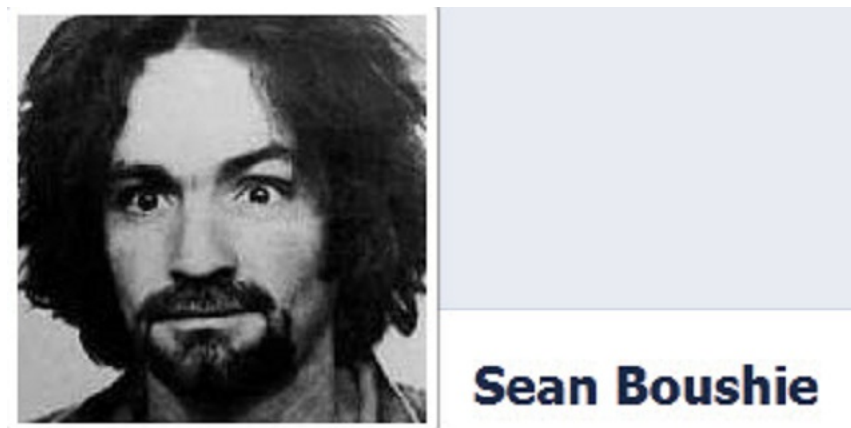
Sean Boushie's original posts on my Facebook page used a Glock gun in place of his photo:

Sean Boushie has threatened to shoot me. He says that when I come to Missoula Montana, a bulletproof vest won't do any good, implying he will go for a headshot.

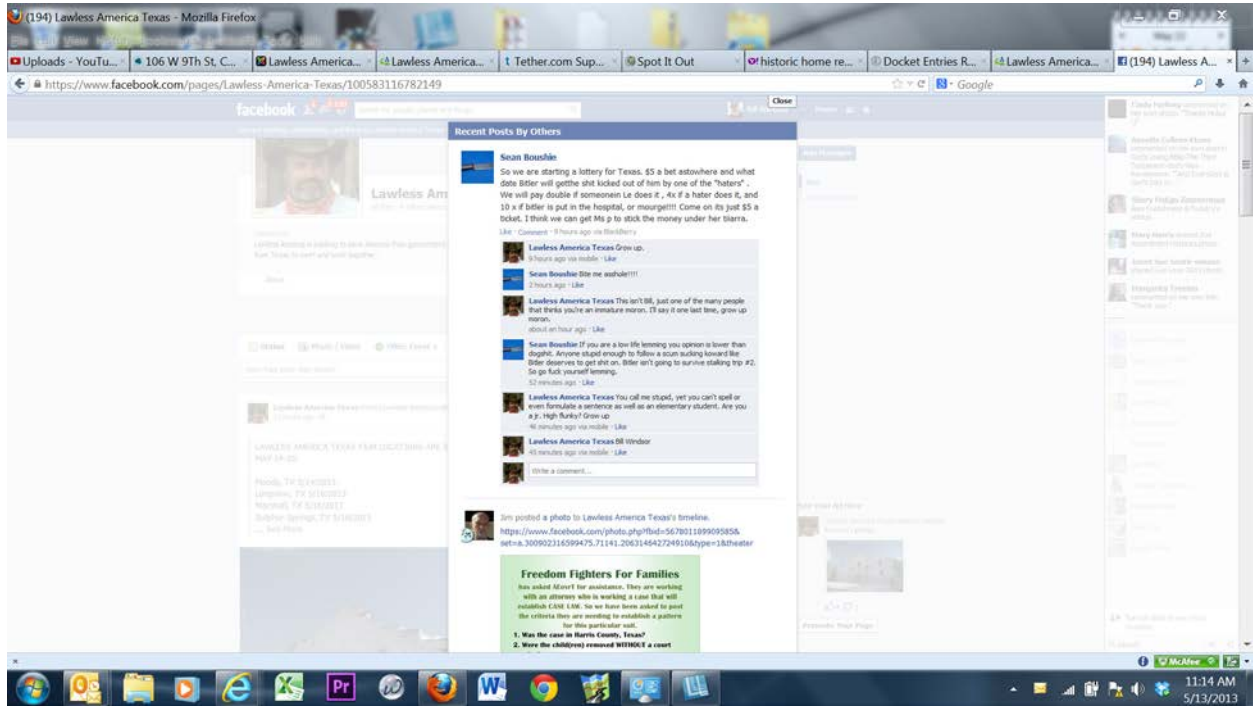

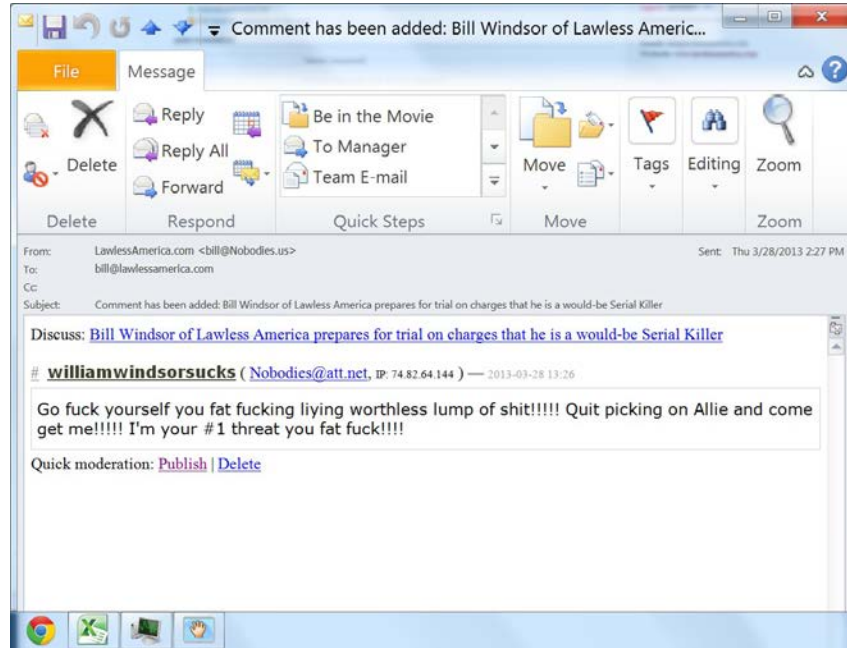

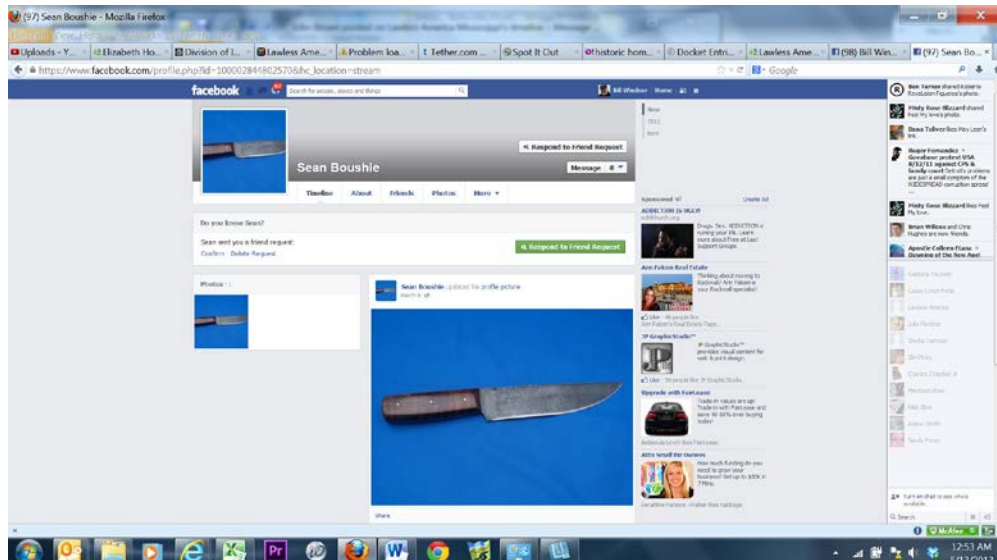

I fear for my safety and the safety of my family. I am in fear of bodily harm to myself and my family, violent injury to my property, and more.

When he changed his Facebook photo to be a big knife, Sean Boushie changed the address he was at to show my home address in Marietta Georgia, to indicate he was there with the knife:



I was not a gun owner before this happened to me, but I now own a gun. Because I do not yet have a carry permit, and because I travel all over the country, carrying a gun for protection is legally problematic. So, I bought pepper spray, a little buzzer-like stun gun, a portable alarm, a

dashcam, and a Louisville Slugger baseball bat. The pepper spray, stun gun, and portable alarm go everywhere I go except courthouses, police stations, and other places where these items are prohibited. The baseball bat and dashcam remain in my Jeep at all times. I keep my doors locked at all times, consciously try to always park under a light, sit with my back to the wall so I can see an entire room, walk briskly, and consider that anyone approaching could be a danger. I can no longer publish where I will be working because Sean Boushie and cyber-stalkers have threatened to come and hurt me. I am attempting to keep the location of my new residence a secret so stalkers will not come and harm me and terrorize me as some have published they will do. I heave a sigh of relief every time I turn on my car and it doesn't blow up. On two occasions, I have come to my car in the morning in a hotel parking lot to find the motor running, the air conditioning on high, and the car locked with the only key in my pocket.

I have purchased a bulletproof vest for here, and I wear it everywhere I go in Montana.

I do these things because I fear for my safety.

My family is terrorized by the cyber-stalking and threats. My wife and I rarely ever had a relationship problem in 42 years together, but she divorced me solely because she is absolutely terrorized. My adult children are very afraid. My daughter will not allow me to have any communication with my two precious granddaughters who I love more than words could ever express. When my wife announced she was divorcing me, she specifically stated that she was doing it in hopes that she could distance herself from Sean Boushie, the cyber-stalkers, and threats.

One of Sean Boushie's associates, Curtis Butler, has recorded a YouTube video in which he threatens to track me down wherever I move and do bodily harm to me. In the video, Butler admits that he is an alcoholic, and he is drinking Everclear straight from the bottle. Those who know what to look for indicate that he shows signs of being on meth. Curtis Butler is extremely frightening. No one in their right mind would record a video saying they were going to kill someone, but he did. Curtis Butler is absolutely someone who could do physical harm to me.

Sean Boushie has attempted to terrify, threaten, harass, annoy, and offend me with lewd and profane language, lewd and lascivious acts, threats to inflict physical harm, and more.

Since May 2012, Sean Boushie has emailed me under various names and email addresses. He has posted harassing messages and threats on my website, on my Facebook page, on my YouTube page, and on the sites and pages of others.

[Sean Boushie's YouTube page](#) was filled with links to videos about guns and explosives. Anticipating that his YouTube account might quickly disappear (as it did), I captured an [Activity Log](#) and screenshots: [Screenshot 1](#) -- [Screenshot 2](#) -- [Screenshot 3](#) -- [Screenshot 4](#) -- [Screenshot 5](#) -- [Screenshot 6](#) -- [Screenshot 7](#).

One of the YouTube videos that Sean Boushie has liked is titled "The Wrong and Right Way to Shoot Someone."

Sean Boushie has called me crazy in a wide variety of ways, says I am a "liar" (which I am not), and of "dubious moral character" (which also is not true). Sean Boushie goes on and on and on as if he doesn't have a concern in the world about the easily-proven libel and slander. He has threatened to come after me and make sure I am locked away forever. He makes veiled and sometimes not-so-veiled threats of physical violence. He indicates he plans to shoot me if I come near his home. I do not doubt for a second that this guy would attempt to have physical harm done to me.

He committed extensive harassment on the [Lawless America TalkShoe Show](#), and we have the chat logs to prove it.

One of the emails I received from him is from gofuckyourself@yahoo.com, and among other things, he threatens me with jail and says: "Bite me Asshole." He has sent me at least three emails with his name as KillBill. See <http://seanboushie.com/?p=1889>

MONT CODE ANN § 45-5-201. Assault:

(1) A person commits the offense of assault if the person:

(a) purposely or knowingly causes bodily injury to another;

(b) negligently causes bodily injury to another with a weapon;

(c) purposely or knowingly makes physical contact of an insulting or provoking nature with any individual; or

(d) purposely or knowingly causes reasonable apprehension of bodily injury in another.

(2) A person convicted of assault shall be fined not to exceed \$500 or be imprisoned in the county jail for any term not to exceed 6 months, or both.

Sean Boushie has purposely and knowingly caused me and my family to have reasonable apprehension of bodily injury.

As of July 21, 2013, there were 18 counts of Assault identified on the website -- [List of Sean Boushie Violations of the Crime of Assault](#). There is another one now with his claim of shooting at me on August 4, 2013.

On August 4, 2013, I drove to Missoula from Billings. During that drive, a car in the lane to my right and just ahead of me burst into flames and a cloud of smoke billowed out, completely obscuring the roadway and the other vehicles. I grabbed my camera and was able to snap a couple of photos after I had slowed.



The smoking car is in the right lane in the photo above and cannot be seen for all the smoke. Because of the death threats that I have received, I didn't stop, though I believe the car in front of me did.

I posted news of this on my Facebook page. Then at 9:03 pm, I received this email from Sean Boushie in which he claims he shot the car to my right while trying to shoot me. Note: Lately, he uses my name with an e on the end as his alias when he emails me:

Mont. Code Ann. § 45-5-202. Aggravated assault.

(1) A person commits the offense of aggravated assault if the person purposely or knowingly causes serious bodily injury to another or purposely or knowingly, with the use of physical force or contact, causes reasonable apprehension of serious bodily injury or death in another.

(2) A person convicted of aggravated assault shall be imprisoned in the state prison for a term not to exceed 20 years and may be fined not more than \$50,000, except as provided in [46-18-219](#) and [46-18-222](#).

In addition to the previous criminal charges that specifically apply to eligibility for Order of Protection, Sean Boushie has committed many other crimes against me.

Mont. Code Ann. § 45-6-332. Identity Theft

- (1) **A person commits the offense of theft of identity if the person purposely or knowingly obtains personal identifying information of another person and uses that information for any unlawful purpose**, including to obtain or attempt to obtain credit, goods, services, financial information, or medical information in the name of the other person without the consent of the other person.
- (2) (a) A person convicted of the offense of theft of identity if no economic benefit was gained or was attempted to be gained or if an economic benefit of less than \$1,000 was gained or attempted to be gained shall be fined an amount not to exceed \$1,000, imprisoned in the county jail for a term not to exceed 6 months, or both.
- (b) A person convicted of the offense of theft of identity if an economic benefit of \$1,000 or more was gained or attempted to be gained shall be fined an amount not to exceed \$10,000, imprisoned in a state prison for a term not to exceed 10 years, or both.
- (3) As used in this section, "personal identifying information" includes but is not limited to the name, date of birth, address, telephone number, driver's license number, social security number or other federal government identification number, tribal identification card number, place of employment, employee identification number, mother's maiden name, financial institution account number, credit card number, or similar identifying information relating to a person.
- (4) If restitution is ordered, the court may include, as part of its determination of an amount owed, payment for any costs incurred by the victim, including attorney fees and any costs incurred in clearing the credit history or credit rating of the victim or in connection with any civil or administrative proceeding to satisfy any debt, lien, or other obligation of the victim arising as a result of the actions of the defendant.

Mont. Code Ann. § 45-8-21. Criminal Defamation.

(1) Defamatory matter is anything that exposes a person or a group, class, or association to hatred, contempt, ridicule, degradation, or disgrace in society or injury to the person's or its business or occupation.

(2) **Whoever, with knowledge of its defamatory character, orally, in writing, or by any other means, including by electronic communication, as defined in 45-8-213, communicates any defamatory matter to a third person without the consent of the person defamed commits the offense of criminal defamation** and may be sentenced to imprisonment for not more than 6 months in the county jail or a fine of not more than \$500, or both.

(3) Violation of subsection (2) is justified if:

(a) the defamatory matter is true;

(b) the communication is absolutely privileged;

(c) the communication consists of fair comment made in good faith with respect to persons participating in matters of public concern;

(d) the communication consists of a fair and true report or a fair summary of any judicial, legislative, or other public or official proceedings; or

(e) the communication is between persons each having an interest or duty with respect to the subject matter of the communication and is made with the purpose to further the interest or duty.

(4) A person may not be convicted on the basis of an oral communication of defamatory matter except upon the testimony of at least two other persons that they heard and understood the oral statement as defamatory or upon a plea of guilty or nolo contendere.

Mont. Code Ann. § 45-8-220. Criminal Invasion of Privacy.

(1) Except as provided in subsection (2), **a person commits the offense of invasion of personal privacy if the person knowingly or purposely obtains or attempts to obtain personal or confidential information about an individual while posing as the individual.** A person convicted under this section shall be incarcerated for a term not to exceed 1 year or fined an amount not to exceed \$10,000, or both.

(2) Subsection (1) does not apply to a person who poses as another individual with the express consent of that other individual.

Mont. Code Ann. § 45-5-213. Assault with weapon.

(1) A person commits the offense of assault with a weapon if the person purposely or knowingly causes:

(a) bodily injury to another with a weapon; or

(b) reasonable apprehension of serious bodily injury in another by use of a weapon or what reasonably appears to be a weapon.

(2) (a) Subject to the provisions of subsection (2)(b), a person convicted of assault with a weapon shall be imprisoned in the state prison for a term not to exceed 20 years or be fined not more than \$50,000, or both.

(b) In addition to any sentence imposed under subsection (2)(a), if the person convicted of assault with a weapon is a partner or family member of the victim, as defined in [45-5-206](#), the person is required to pay for and complete a counseling assessment as required in [45-5-206\(4\)](#).

Sean Boushie has threatened me with a gun, with a knife, with Charles Manson's photo, with the use of KillBill as his email address, and by claiming he shot at me on I-90 on August 4, 2013.

Mont. Code Ann. § 45-5-208. Negligent endangerment.

(1) A person who negligently engages in conduct that creates a substantial risk of death or serious bodily injury to another commits the offense of negligent endangerment.

(2) A person convicted of the offense of negligent endangerment shall be fined an amount not to exceed \$1,000 or imprisoned in the county jail for a term not to exceed 1 year, or both.

Sean Boushie's cyberstalking, lies, defamation, slander, harassment, and threats feed other sick people who could pull the trigger or drive the truck. Curtis Butler is an excellent example.

Mont. Code Ann. § 45-5-203. Intimidation.

(1) A person commits the offense of intimidation when, with the purpose to cause another to perform or to omit the performance of any act, the person communicates to another, under circumstances that reasonably tend to produce a fear that it will be carried out, a threat to perform without lawful authority any of the following acts:

- (a) inflict physical harm on the person threatened or any other person;
- (b) subject any person to physical confinement or restraint; or
- (c) commit any felony.

(2) A person commits the offense of intimidation if the person knowingly communicates a threat or false report of a pending fire, explosion, or disaster that would endanger life or property.

(3) A person convicted of the offense of intimidation shall be imprisoned in the state prison for any term not to exceed 10 years or be fined an amount not to exceed \$50,000, or both.

Sean Boushie has repeatedly tried to intimidate me. He tried to stop me from coming to Montana to bring charges against him by threatening me with physical harm and death.

EVIDENCE

I have more than enough evidence for his conviction on hundreds of counts. The investigation of these crimes will be pretty easy. The main thing needed is to determine what was sent from his office computer and what was sent from his home computer or a mobile device.

Exhibit A hereto is the Second Amended Sworn Petition for Protective Order that I have filed in Ravalli County and will file in the Missoula Metropolitan Court.

Exhibit B hereto is the latest email, received by me the morning of August 11 in Missoula. As it is a Sunday, we can assume that he was at his home in Ravalli County.

Exhibit 3 to the Second Amended Sworn Petition is a sworn affidavit from me with 128 exhibits that provide the evidence. There is probably far more evidence and many more counts, but I have not taken the immense amount of time it would take to review the websites where I know he has posted defamatory, stalking information, such as <http://joeyisalittlekid.blogspot.com>

In my Affidavit (Exhibit 3), I go through in chronological order and identify each crime and provide the evidence.

Based upon a review of dates, times, and IP addresses, I believe at least the following exhibits provide evidence of electronic communication sent from Missoula: Exhibits 1, 2, 7, 8, 9, 10, 11,

29, 59, 72, 77, 78, 103, 114, and 117. A subpoena to Facebook will be needed to determine the date and time when online postings were made.

PLEASE NOTE: Each of these exhibits is online in electronic format and color at www.SeanBoushie.com. These are much easier to read online in color where you can zoom as needed. I will also burn all of the evidence onto a flash drive, if requested.

In addition to the above, there are dozens of websites and over 50 horrendous videos. I do not know the extent of Sean Boushie's involvement with those. I am happy to bring my laptop in and play as many videos as you would care to see.

I want charges filed both in Missoula and Ravalli County. I have concerns in Ravalli County as I have already identified two judges who appear to be corrupt.

SPECIAL NOTES

The University of Montana has issued a gag order on the administration and faculty; no one is allowed to speak with me. This came from Royce Engstrom. All I wanted the University to do was to admit or deny whether they employ Sean Boushie as a cyberstalker for government entities. The refusal to talk makes them even more suspect.

One of Sean Boushie's personal emails is missoulagloryholefun@yahoo.com. It is possible that what Sean Boushie may have on some University officials, law enforcement, or courts could have something to do with exposing the perverse sex lives of some powerful people. If someone goes around to glory holes having sex with the guys in the next stall, this is certainly a possibility. This is only a hypothesis based upon the discovery of his use of this email address.
