Whereas by Warrant under Our Royal Sign Manual bearing date the eighth day of April 1965, a Commission to be called the National Board for Prices and Incomes issued, and Commissioners were appointed, to consider such questions relating to prices charged for goods or for the application of a process to goods or for services; or such claims, settlements or questions relating to pay or other conditions of service or employment; or such questions relating to other money incomes, as were referred by any of Our Ministers for examination:

And Whereas by Warrant under Our Royal Sign Manual bearing date the third day of May 1965, Our Trusty and Well-beloved Duncan Alexander Cox Dewdney, Esquire, was appointed a Joint Deputy Chairman of the said Commissioners:

And Whereas by Warrant under Our Royal Sign Manual bearing date the eighth day of March 1966, Our Trusty and Well-beloved Hugh Armstrong Clegg, Esquire, was appointed to the Body of the said Commissioners:

And Whereas by Warrant under Our Royal Sign Manual bearing date the eighth day of July 1966, the said Duncan Alexander Cox Dewdney, Esquire, having resigned his appointment as a Joint Deputy Chairman, was appointed to the Body of the said Commissioners:

And Whereas by Warrant under Our Royal Sign Manual bearing date the first day of June 1965, the persons named in the First and Second Schedules to that Warrant, being respectively persons nominated by organisations representing employers and persons nominated by organisations representing workpeople, were appointed to be Special Members of the said Board:
