chairperson's report

for the year ending 30 june 2012



Over 125 years Wyatt has maintained a commitment to compassionately and respectfully support South Australian people who are experiencing financial disadvantage. In celebrating this milestone, we reflect upon the intention of William Wyatt and note that the world, as he knew it when he formed the Trust, has changed dramatically. Our grant making has stayed aligned to his original stated intentions while keeping apace with huge societal changes.

During this year Wyatt has implemented the new strategic plan which had been adopted in April 2011. This has involved immediate change of staff structure and the organisation of grant making into four portfolios. The definition and measurement of the outcomes that we are aiming to achieve is providing a challenge which causes us to reflect and renew our grant making. Our grants and their measurable impact are outlined in this report.

In this year of continuing volatile financial markets Wyatt has experienced a reduction of income. Despite this we have provided grants of \$3.287m, including \$1.489m from the Initiative Fund provided for affordable housing through approved housing providers. By the end of the next financial year Wyatt will have provided \$5.1m through this special fund formed from the Trust's significant growth in the favourable financial climate of 2002 – 2007.

Wyatt Governors have again enthusiastically provided their time and expertise to the organisation and this is much appreciated. Bill Fowler completed his term of office in October 2011 having very ably served nine years including undertaking the Chairmanship from 2007 – 2009. Anne McCutcheon has been appointed to the Board and we are very pleased to welcome her.

There have been changes in the staff with the adoption of the new Strategic Plan and Matthew Rudd, Grants Portfolio Manager - Employment, Karen Carroll, Finance and Administration Manager and Clare Randall and Emily Zweck, Receptionists have joined the Wyatt team.

Elisabeth Gazard, Wyatt's Chief Executive since 2001, has decided to retire, and we have appointed Paul Madden to take up this position from July 2012. Elisabeth Gazard has been at the helm during a period of significant change for Wyatt.

During the earlier years of her appointment she was able to introduce contemporary philanthropic practice to Wyatt, and has, over her term, developed links with other developing and established philanthropic practitioners in Australia.

As Wyatt's corpus grew, Elisabeth oversaw the scaling up of grants expenditure through a series of organisational strategic reviews and resultant new programs. She leaves Wyatt in the position of leadership in South Australian philanthropy, having overseen the introduction of the Strategic Plan, and an exceptional staff team ready to take on new challenges and to excel.

Brian Lilley has provided financial advice and support as Financial Consultant over the last seven years. His work has been invaluable as we developed a sound investment policy and made significant financial changes such as selling Wyatt's commercial property. We wish him well in his future ventures and thank him for his service to Wyatt.

During the year Wyatt invited Australian academics and expert practitioners to join with us and form a panel of External Thought Leaders. I was delighted that they so eagerly accepted our invitation to assist us to review and learn about the needs of our community and the measures which can support financially disadvantaged people to achieve education, employment, housing and financial wellbeing.

I wish to thank my fellow Governors and all of Wyatt staff members for their excellent support and work over this year. Having reached the 125 year mark of grant making, we look forward to the next years, anticipating further innovation and challenge in our work to achieve satisfying, productive lives and active participation in the community for South Australians experiencing financial disadvantage.

Housing Options \$277,000

Through partner organisations providing services for people experiencing homelessness or at risk of homelessness, grants for packages of household goods, removal costs, rental subsidies. Low cost retirement housing for older people who are at risk of homelessness or living in unsustainable accommodation.



Initiative Fund \$1,489,000

Support for new-build rental accommodation for 95 individuals or families through partner housing organisations. Grants for packages of household goods for families housed and supported through the Australian Government's Nation Building Economic Stimulus Plan Social Housing Initiative. No interest loans for HomeStart approved home buyers.



Education Retention and Re-engagement \$438,000

Bultawilta Scholarships for Indigenous secondary students from 13 secondary schools across South Australia. Scholarships provided in conjunction with The Smith Family and Yalari. Supporting the re-engagement of young parents and young people living independently in metropolitan and regional SA. Supporting low-income specialist music students at four secondary schools and supporting first year music students at the Elder Conservatorium of Music. Promotion of early childhood education through scholarship places at several Children's Centres. One-off grants to support engagement of families in early childhood education.



Employment Opportunities \$428,000

Supporting transitional pathways and innovative employment generation projects with key partners. Support to individuals to take the first steps on their career pathways through University Scholarships for country and Indigenous students and scholarships for TAFE fees. Work Start Grants, coming under Wyatt's small grants program, have also provided a flexible and accessible service to support individuals across the state attain their career and employment goals. To further our impact with supporting sustainable employment, partnerships have been established with organisations that have been able to provide innovative solutions to support disadvantaged groups with industry engagement and social enterprise models.



Financial Wellbeing \$786,000

Financial support for six partner organisations to extend financial counselling services for people experiencing a financial crisis. The funding assists clients to manage their financial obligations. Subsidies for people taking No Interest Loans (NILS®) through partner organisations. Small grants for individuals and families experiencing financial hardship for essential domestic goods and services, employment-related costs and items contributing to school retention and re-engagement. Grants and provision of accommodation at Wyatt Victor Harbor Holiday Units as respite for carers and those receiving care.

william wyatt LSA, MRCS 1804-1886 Apothecary and Surgeon



Dr William Wyatt and Mrs Julia Wyatt travelled from Plymouth, UK arriving in Holdfast Bay, South Australia in February 1837. During his life in Adelaide, Wyatt held a variety of official positions including Colonial Naturalist 1837-1856, JP, Visiting Magistrate and Coroner 1837, Secretary, Medical Board, Royal Adelaide Hospital 1838-1885, Director, Savings Bank of South Australia 1840-1846, Governor, St Peters College 1847-1886, Trustee, Holy Trinity Church 1847-1886, Chief Inspector of Schools 1851-1874, Governor, Botanic Gardens 1857-1878, Governor, Public Library 1862-1868 and Treasurer, RSPCA 1875-1885. Dr Wyatt set up his home first in Grenfell Street and later at Kurralta, Burnside. His son, William, the only one of his five children to survive childhood, died in 1872 aged 34. Wyatt's wealth was derived from his purchase of land in the city and elsewhere in March 1837. In 1881 he wrote his Will, setting up his Trust and naming the first Governors - prominent Adelaide businessmen. He died in June 1886 and the first meeting of the Wyatt Governors was held soon after. On 15 July 1886 the first grant of \$5 was paid to J.W.B., retired lawyer. The Wyatt Trust is now a significant fund, the benefit of which is provided to improve opportunity and quality of life for South Australians who experience financial hardship. "Keeping a Trust: South Australia's Wyatt Benevolent Institution and its Founder" by Carol Fort (Wakefield Press, 2008) tells the story of the life of William Wyatt and The Wyatt Benevolent Institution Inc.
