PRESIDENT'S REPORT 2003

What a year! With the dust still settling on what has been undoubtedly the greatest festival of Rugby ever seen, it is an appropriate time to reflect on the season just completed, and gaze a little into the crystal ball.

The early part of the year required the Executive to examine and prioritise its duties for 2003. Essentially, we focussed on four areas; referee reimbursement, the establishment of a "club room", tidying up the Constitution and the Annual Dinner. The first two of these issues were widely discussed with the NSWRU and, with the great help of John McKay, Patrick Wilson and George Ayoub, it appears that these issues are all but finalised. We have developed a strong and cordial relationship with the NSWRU and look forward to this continuing.

In recent times, the NSWRRA Constitution has undergone several changes with a number of excellent people putting in much time and effort to produce the current document. However, it was brought to the attention of the Executive that there were some minor wording issues which, in the unlikely event of legal challenge, may come under scrutiny. We are extremely fortunate to have the expertise of Brian Lulham to assist in this area.

Without question, the greatest challenge for us this year was to stage a function to do justice to ourselves, and to an event of the magnitude of Rugby World Cup 2003. It was vital that this event was something special, given the importance of the occasion and those in attendance. Accordingly, many hours were spent in the planning and implementation of the function, which combined the NSWRRA Annual Dinner with a need to honour those chosen to officiate at Rugby World Cup 2003. The resulting "International Referees' Dinner" was a resounding success, as those in attendance will attest. Many people contributed to the evening, especially my fellow members of the Executive: Tim Morris, Rob Tosswill and Tony Hackett. Also, the NSWRU Referees Department: George Ayoub, Robin Timmins and Rob Mancell assisted greatly.

The RWC Referee team led by IRB Referee Manager, Mr Steve Griffiths were extremely co-operative and their enthusiasm for the event was instrumental in its success. Our MC, Toby Lawson, and Guest Speakers, Gordon Bray and Vince Sorrenti showed true professionalism and lifted the event to an unprecedented level. However the person who deserves the most gratitude and credit is our own Simon Cardiff. Simon has much experience in event management which certainly came to the fore at this special occasion.

Whilst on the RWC 2003, our Association is extremely proud of Peter Marshall and Stuart Dickinson for their selection and the high standard of their refereeing not only at RWC but on the international stage in 2003.

It was also great to George Ayoub called up to Touch Judge following injury to Queensland's Scott Young, and to have Matt Goddard and James Dickson actively contributing at RWC matches.

Most members will be aware of Peter Marshall's retirement from active refereeing following the completion of the World Cup. The contribution to world refereeing, of both Peter and also Wayne Erickson who retired within the last year cannot be overstated. Peter has been appointed to position of Referee Manager with the Australian Rugby Union and will no doubt continue to advance the cause of Australian Refereeing through his many talents.

Of course, the achievements of the members of the NSWRRA are not confined to the higher levels. It was great see the often unseen efforts of John Salisbury rewarded with the Dick Webb Clubman of the Year award. Many other referees reached personal milestones which were recognised at the International Referees' Dinner. Congratulations are also due to those referees honoured with Grand Final appointments and those who reached personal goals at all levels.

The Executive would also like to acknowledge the ongoing efforts of Robin Timmins. Despite the roles of the NSWRRA and NSWRU Referee Department gradually becoming more defined, there remains considerable overlap. Robin is always there to assist wherever and whenever possible, and for that we are extremely grateful. Similarly, Brian Kinsey, Cliff Dodds and their respective boards all do a tremendous amount of work, most of which goes unnoticed. In addition, thanks must go to George Ayoub who, in the five years he has held the position of NSWRE Referee Manager has played a huge part in maintaining and indeed raising the standard of refereeing in NSW. George is moving on to concentrate on his own refereeing with the ARU and for that we wish him well.

I am grateful for the sterling job my Executive has done in 2003. Tim Morris (Secretary), Robert Tosswill (Treasurer) and Tony Hackett (Elected Member) have all performed their assigned tasks with diligence, enthusiasm, and good humour.

It is true that the NSWRRA is one of the world's great Rugby Refereeing Societies. The high esteem is which we are held worldwide has been built over many years by many eminent refereeing identities, most notably our Life Members. These people have formed the standards and values of which

we are so proud. It is important that these are maintained, and passed on to each successive generation. For this to happen it is vital that we, the current members, embrace refereeing for all the right reasons. We must resist negativity and self-interest at all costs if we are to maintain the ethos of this august body. We are but one component albeit an important one, of a very complex organization which is Rugby in NSW.

As there is some "unfinished business" I will be putting my hand up in 2004. In the meantime, it has been an honour to hold the office of President and I wish you all the best of health in the off-season and look forward to season 2004.

NSW Referee Department 6 Monthly Report 2003

In 2000 the Referee Department completed a four (4) year strategic plan that set about strengthening our commitment to developing match officials across the state. Our major focus in 2003, the last year of this plan, is to further develop our referee coach resources and equip our personnel in the skills required to assist our match officials week-in-week-out.

In 2003 we appointed one of our senior coaches as Referee Coach Coordinator to develop strategies and work closely with the Australian Referee Coach Coordinator to up-skill our referee coaches in both Sydney and the Country Zones. To date we have held two seminars for these coaches. Our Referee Coach Selectors have also been moving around the grounds assisting our coaches by watching them in action giving advice to our match officials.

It is the Referee Department's desire to see the standard of Referee Coaching rise to match that of our officials, which would help strengthen our ability to provide quality match officials to our competitions.

Other major achievements of 2003 have been our ability to deliver courses in a timely and professional manner with the appointment of our Community Rugby Referee Coordinator. Both our database of match officials has been updated while a record number of courses across the state has been provided for the rugby community.

Our referee education nights are attracting record crowds, held once a month in the cricket auditorium at Aussie Stadium. The appointment of a senior referee to assist with compiling material for these nights has made these evenings very worthwhile for our members.

All our match officials have been included in groups with a coach provided for them to use and develop their skills. This structure has allowed referees and referee coaches to work closer together throughout the season.

Our top ranked referees continue to provide the bulk of match officials in the national and international arena. We have five (5) match officials on the National Panel with all these officials being represented at both RS12 and international matches.

Our match officials were rewarded with selection as referees and reserve referees for the Rugby World Cup 2003 (RWC2003). Peter Marshall & Stuart Dickinson were selected as referees. George Ayoub, Matthew Goddard & James Dickson were selected to act as reserve T.J's. for the competition.

The Tooheys New Cup (TNC) was a success for our Match Officials with a number of young and talented referees appointed to games at this level. Special mention to Brad Wahl who refereed his first 1st Grade game this year and showed he has great potential for the future. Others such as James

Leckie, Ben Heap, and Andrew Lindsay are referees that will strengthen our ability to provide quality match officials to both NSW and ARU level in the future.

Our referee development squad members have all moved up the ranks within the broader refereeing community allowing us to appoint them to games that will test their abilities. Our Development Squad Coaches have been working tirelessly with these referees to develop their skills for the next levels of competitions.

John McCarthy reached a milestone in 2003 Refereeing his 100 first grade game in the TNC. John later became a most worthy winner of the Trendwest Referee of the Year award presented at the Catchpole medal awards night. Club Coaches voted for this award after every round of the TNC who recognised John's ability and experience as a quality 1st Grade referee. This is a great achievement and we congratulate John on these two milestones.

All our courses have been scheduled in for 2004 and beyond. Our Referee Coordinator has been working hard to ensure there is an even spread of courses across the state. He has worked with our volunteers to coordinate dates and times for the courses required in their zone.

The NSW Referee Association Dinner was held on November 5 with all World Cup Referees invited as guests to this annual event. Gordon Bray who was guest speaker and Vince Sorrenti who made a special appearance to brighten up the evening entertained them.

In the coming weeks the Referee Manager & the Referee Coordinator will be working on the scheduling of courses across the state while also completing the next four (4) year strategic plan for the department.

Thanks once again to the staff here and to you for what was one fantastic season ending with a great tournament in the RWC. I hope you enjoy the break and come back refreshed for another season of refereeing.

COUNTRY RUGBY UNION REFEREES ASSOCIATION 2003 PRESIDENT'S REPORT

I have over this last year once again been amazed at the improvement yet again in the quality of Refereeing at representative level across the age groups and the senior level in the Country.

This quality has come about through a number of factors that have been set in place in the last few years. The first is that of coaching, where before a referee was appointed, did his job and was gone, the position is now dramatically changed. The referee has the benefit before games and carnivals to talk with his or her coach or coaches and then after the game there is more discussion and suggestions for improvement.

Secondly there is feedback from the referee to the appointments board as to how their coaches helped or were found wanting. This enables the coaches to be assessed and to take steps to improve their coaching.

Thirdly the coaches and referees go back to their Zones and impart this knowledge so that improvements can continue throughout the Country.

Finally the support shown at Junior and Senior Levels to the referee has shifted from "them versus us" to what we are all hoping to achieve, to provide a platform for improvement of all skills which in turn provides a better game for all players.

I thank the Board, Committee and all Country Referees in the Association for their efforts and support and it has been greatly appreciated.

The next year with the new format proposed we will face challenges where before we had an approach of coaches and referees all together at carnival time at the Senior level discussing new ideas and approaches to situations and finding common agreement and all refereeing that way. Now we will have to adopt a new way to continue the development of "common purpose refereeing". We do not want to have Northern Hemisphere –v-Southern Hemisphere approach to refereeing.

We will meet this challenge with your support and your ideas.

NSW COUNTRY REFEREES COACHING and GRADING BOARD CHAIRMAN'S REPORT for SEASON 2003

The season 2003 started out with another (new) round of games for us to appoint to - the Northern Provincial Championships, which involved five games spread over various locations. The logistics here proved tricky, as was (apparently) obtaining the funding from the organizers. It was however a welcome opportunity for us to give some quality games to our panel of referees.

The continuation of the Australian Rugby Shield gave some of our members an opportunity at a higher level and we trust this will continue. Congratulations to Nathan Pearce and Grant MacNeill, and to Matt Blackharn and Andrew Lees as reserve referees in the three games hosted in this competition by NSW Country. Nathan went on to referee the final, a first for Country referees. Well done Nathan, and also Grant - both received good reports throughout.

Assigning of referees to Carnivals was done on the basis that, yet again, the format changed during the season. There was the Northern Under 20's championship at Kempsey in April, Country Carnival (reduced number of zones) at Forbes in June, and the "on again off again" Country Schools which I will come to later. The reduced format for the Country Carnival meant we only appointed five referees instead of the usual seven. Four were appointed to Kempsey to what turned out to be a competitive and challenging environment. Country Schools' administration was almost unmanageable, with constantly changing, and tardy, requests for referees. Ultimately we did not appoint at all. I feel our Executive should approach the Schools organization and agree some guidelines by which we can/cannot meet their requests.

Continuation of the coaching of the Coaches took place, whereby CGB members were observed doing their feedback sessions, and in turn supplied with feedback to help them improve. I as chairman did "one-on-one" sessions with the referees after they had received their coaching feedback. This meant that even better information was available to assist with the "coach-the-coach" work.

Continuation and expansion of the RAP (Referee Advancement Program) has resulted in a number of referees being given the opportunity to show their wares at an early stage of their careers. We intend to continue this trend throughout 2004, as it is becoming obvious that we are in need of developing talent for the years to come. All the RAP referees were given

opportunities "in the middle" at the 14/15's Carnival and also at other rep games as and when appropriate. The performances were impressive.

The continuation of the CGB seminar again proved a very worthwhile addition to our overall approach to the job at hand. This time we allocated a session to a former panel referee recently retired, Greg O'Donnell, to pass on some suggestions and recommendations from the "rank and file". I would like to offer our very deep appreciation to NSW Rugby Referees' Department and to thank George Ayoub for support in conducting this seminar. Unfortunately George was unable to attend in person.

I would congratulate Central West zone on the excellent performance from their Touch Judges at Country' Week. Country Juniors kept us in the loop for the whole season which gave significantly more opportunities to all levels, but especially those in development. This meant significantly more logistical work than in previous years, and to this end I thank Peter Charker for his patience and good work in this area.

Finally, I would like to thank the members of the CGB for their enthusiasm and support, for 2003, and whilst I prefer not to single out individuals, the support from Austin Rummery was, as ever, outstanding.



1. STATEMENT OF ACCOUNTING POLICIES

NOTES TO AND FORMING PART OF THE FINANCIAL STATEMENTS FOR THE YEAR ENDED 30 SEPTEMBER 2003

1. STATEMENT OF ACCOUNTING POLICIES

The Association is not a reporting entity as defined in Statement of Accounting Concepts SAC 1, Definition of the Reporting Entity, and therefore is not required to prepare financial statements in accordance with Statements of Accounting Concepts and Accounting Standards.

This is a special purpose financial report prepared solely to meet the requirements of the Associations Incorporation Act 1984.

The financial statements are based on historical costs and do not take into account changing money values or, except where specifically stated, current valuations of non-current assets.

The following specific accounting policies, which are consistent with the previous period, have been adopted in the preparation of these statements:

Income Tax

The Association is exempt from tax under S.23(g)(iii) of the Income Tax Assessment Act, 1936, as amended.

2. LITIGATION

In the matter of Sydney Rugby Referees' Association Inc. & ORS ats Luke Hyde, Supreme Court of NSW proceedings no. 13884 of 1988, the Honorary Auditor has been advised by Solicitors Cornwall Stodart who acted on behalf of Sydney Rugby Referees' Association in this matter, that the matter was settled on 17 April 2001. Cornwall Stodart have advised that they were not party to the settlement negotiations and they advised the Honorary Auditor in verbal discussions that there was no record on the Court file of the settlement having taken place or details of the terms of settlement. Cornwall Stodart have requested the Solicitors acting on behalf of Luke Hyde to provide details of the terms of settlement and these will be made available to the Sydney Rugby Referees' Association as soon as they become available. As at the 12th February 2004 the terms of settlement have not been received. The Honorary Auditor was advised in verbal discussions with Cornwall Stodart that there were some 20 defendants in the matter.
