# PRESIDENT'S REPORT

In recent times, rugby seasons appear to have been getting longer, and 2014 proved to be no exception.

Whilst traditional competitions such as NSW Suburban and Sydney Premier Grades themselves did not change greatly, the introduction of a number of new Sevens tournaments early in the year, as well as the inaugural National Rugby Championship towards the end, meant our Refereeing resources were again tested. I am delighted to report that despite the pressure of expectation, our referees across all levels rose to the challenge and performed admirably, competently and professionally.

However, the year was not without other challenges.

The somewhat parlous financial state of our game, including the NSWRU itself, was clearly explained early in the year at our AGM by the Executive Director of the NSWRU, Mr Bruce Worboys. We were asked, as were other stakeholders, to contribute in whichever way possible. Due to years of careful planning, and prudent financial management by successive Executive Committees, this Association is fortunate to be in a sound financial position. Your Executive committed funds to offset partial costs of referee on-field communication equipment for 2014. Following discussions with Mr Worboys and the President of NSWRU, Mr Nick Farr-Jones, funding of this essential resource was shared between NSWRRA and NSWRU, with whom we share a strong and valued relationship.

In order to offset the expense to this Association, your Executive sought financial assistance from the SRU Premier Clubs. It was proposed that each club would also contribute a relatively small one-off amount to assist with the significant cost of communication equipment. Despite being the major beneficiaries of the use of this equipment, the Premier Clubs decided not to contribute, which was extremely disappointing. For this reason, and because ongoing expenditure of this nature is financially unsustainable, the arrangement as it existed in 2014 will not continue. My personal thanks go to David Jones-Prichard, Guy Sainsbury and my Executive colleagues for their extensive work as the Financial Sub-Committee which presided over this matter.

As has been frequently alluded to in the recent past, this Association has a major role as a support network for its members. It is great to share in the joys of life outside Rugby, such as weddings, births - all new additions to the greater refereeing family. From a personal viewpoint, it has been wonderful to see the personal development of those who were not long ago the "new kids on the block" in their transition to parenthood, and our congratulations go to them and their partners. There is a role in the tough times, too.

Our members were all devastated to find out the news about the diagnosis of our good mate and colleague, Guy Grinham. The importance of the support we can provide as a group was clearly evident by Guy's attendance at the Annual Dinner following treatment earlier that day. Guy and his family have a tough road ahead and I know that our members, particularly those closest to Guy, will be there to support him wherever and whenever possible as he fights and wins his battle – which we trust he inevitably will.

Situations such as Guy's certainly put life in perspective, and serve as a reminder of why we pursue our passion of rugby refereeing. That is certainly not intended to disregard refereeing



based issues which surface from time to time, but should underline the need to maintain a sense of reality if and when they do surface.

To that end, in a predominantly volunteer organisation such as ours, it is crucial that any problems, real or perceived, are dealt with rationally and by following proper processes. There is little to be gained by generating or disseminating what often amounts to rumour and gossip through insensitive chat, or worse, the very public social media. Most people will not be surprised to hear that most issues we face are not new, and often revolve around the fact that we have limited resources. That said, I am confident that most are being dealt with by the appropriate personnel, and that as is the case with most such matters, proper communication is essential.

We are fortunate to have such a wide range of referees in age and experience. It is especially pleasing to see so many emerging young referees who are not only very technically skilled, but are also individuals of high quality. The future of refereeing in NSW is in excellent hands. It is also important to recognise the contribution of our more experienced, ahem, mature referees, who, if I can steal a Sanzar mantra, can be relied upon to referee "any game, any time". Of course, it can be a difficult juggling act in giving newer referees exposure at higher grades, and ensuring our more experienced referees remain motivated.

Congratulations go to all those who met or exceeded personal goals in 2014. Whether it be passing your Competency Test, your first Judd Cup, Kentwell Cup, Grand Final, Shute Shield or Test match, all are significant achievements which should be applauded. Again, our presence on the representative stage was significant, with a number of our referees, ARs, TMOs, coaches, JOs and members of the Judiciary involved. Special mention goes to Amy Perrett, who took on and defeated all comers to be appointed referee for the Final of the Womens' Rugby World Cup. Oh, and Amy and Craig got married as well. Not a bad year, really.

Socially, our main highlights for 2014 were our French themed night, from which we managed to raise a small sum to assist the finances; the annual pilgrimage to the Woolwich Pier for Grand Final night; and the Annual Dinner & Awards Night which was another great success, held in the magnificent grounds of the Royal Sydney Yacht Squadron at Kirribilli. All splendid evenings.

I wish to acknowledge and thank all our referees, referee coaches, trainers, Referee Departments of the NSWRU and ARU, administrators, committee members and sponsors for the tireless work you all do for a common goal – that is, Rugby and Rugby refereeing. Especially Ron Mancell, Robin Timmins, Alex Richards, Scott Rogan, Mick Tanzer, Pete Marshall, Ian Fraser, all of whom do an amazing job.

Finally, my sincere thanks to my Executive team of Edward Martin, Phil Baird and Tim Wills. You fellows are superb to work with, and I only wish everyone could see just how much you do behind the scenes.

It has again been my privilege and pleasure to serve as your President. I look forward to seeing you all fit and raring to go in 2015.

# NSW RUGBY REFEREE DEPARTMENT REPORT

2014 was a very challenging year for the Referee Department as we tried to come to grips with the changing financial landscape. Our budget was smaller than in previous years and we had less to fund what arguably have become more things to do.

Communications equipment has always been a major spend for the department. In 2014 we purchased off the shelf equipment for our referee coaches and this will mean a saving of over \$20K on a yearly basis for years to come. NSWRRA agreed to fund the communications equipment for 1<sup>st</sup> grade and the department undertook to service it on a weekly basis and turn it around to achieve another saving of around \$12K.

Our ongoing education program continued with assistance from Jamie McGregor and we continued to be relevant and effective during the season.

The department again provided referee education and development in the form of courses, education nights and seminars for the association.

The development groups continued in 2014 with the MRIP being expanded and more referees being involved in ongoing development. For 2015, we will be re-invigorating the PRP with new coach and new direction and we will continue all of these programs in the new-year. Other states and Associations look upon our development program as the gold standard and are trying to emulate them.

We again used some external tournaments as development activities for our referees. The CHS Carnival was held in Newcastle and we had 8 referees and 3 referee coaches in attendance over the three days of competition. The Central Coast 7's and the Darwin 7's were also used as development activities and we are in the happy situation of the Department providing the Referee Manager for both of these tournaments. 7's has become a big part of talent ID and development. The State School 7's at Narrabeen late in the season was a good example of this where we identified the 15 of the youngest referees in the association and put them through their paces. This sort of activity will continue in the new-year.

The 1st Grade Premier Coaches and 1st Grade Referees again met before the season commenced and discussed how the game was to be played and refereed in 2014. The same can be said for Sydney Suburban as we conducted a series of seminars for them and closed the loop on a fairly successful "adopt a referee program".

2014 saw the continuation of the Respect Rugby program. Success of the program continues to be varied. The department has conducted a review of the program and a number of changes and additions are to be added to the program in 2015. There will be a need for re-education early in 2015 to highlight these changes and to reinforce the program generally.

In 2015 we will be introducing Soloshot2 (robotic camera) for use by referee coaches in suburban rugby. Soloshot2 allows the referee coach to film a game using the robot (which actually does all the filming) whilst the referee coach can watch the game and take notes. The referee will then get a copy of the game on a memory stick and will be better able to review his own performance with a visual record of the game. It is hoped we can find money in our budget to purchase two of these units so that we can get more video for the referees outside of Premier Rugby.

We will have a new clothing sponsor for 2015 which will mean changing all of our gear for the season. Gilbert has come on board as our clothing supplier and will also be supplying footballs for Premier Rugby.

We would also like to acknowledge the support of the NSWRRA Executive, the Referee Coaching Panel and all referees who participated in 2014.

I would like to acknowledge again the support of my two colleagues in the referee department.

I am proud to say all our members represented themselves and the association with distinction. Angus Gardner had another strong attending the iRB Junior World Cup in New Zealand, refereed NZ Maoris v Japan, Super Rugby and Sydney First grade Grand Final. Andrew Lees refereed Super Rugby as did James Leckie. Anthony Moyes continued to represent us at the iRB Sevens tournaments around the world with distinction. Ian Smith, Ed Martin, Will Houston and Michael Hogan all were involved in Super Rugby as assistant referees. George Ayoub and I continued as TMO's in Super Rugby and Tests throughout the year. The Associations was represented strongly at the Australian Rugby Union Gold under 15's, 17's and national championships - by referees, assistant referees and referee coaches.

I would like to thank the members of the Referees Management Committee – Dan Cheever, John McCarthy, Frank Meiklejohn and Mick Tanzer for the time and effort they put in throughout the year. In particular a special thankyou to Mick for the assistance he gave me and the many times he filled in for me when I was interstate on business.
