**2014 STATE CENTRAL COMMITTEE NOMINATION FORM
RULES (2012 Constitution and Bylaws)**

Pursuant to Article V, Section 2. Nomination and Filing.

2A. Any citizen resident in the State of Hawai'i, who is or will be a member of the Democratic Party of Hawai'i for one (1) year before the next election shall be eligible to be a candidate for election to Party Chairperson.

Any citizen residing in the State of Hawai'i who wishes to become a candidate for election to Party Chairperson or for election to the State Central Committee shall file a nomination paper with the Secretary of said County or the State Central Committee at least twenty (20) days prior to the State Convention, except that papers for the County Representative seats shall be filed at least ten (10) days prior to the County Convention, and except that papers for the Caucus Representative seats shall be filed after certification by the Caucus, but at least twenty (20) days prior to the State Convention.

In the event that no papers have been filed by the filing deadline, the filing deadline shall be extended until ten (10) days prior to the State Convention. However, no additional nomination papers shall be allowed for those positions for which papers had been filed by the filing deadline. If a member has resigned from the Party in the two (2) years prior to re-enrollment in the Democratic Party of Hawai'i, the re-enrolled member must be a member in good standing for at least one (1) year before the next election prior to being elected Party Chairperson or for election to the State Central Committee.

2B. The nomination paper of a candidate for Party Chairperson, National Committeeman and National Committeewoman shall be signed by not less than ten (10) certified members of the Democratic Party of Hawai'i from at least two (2) County Organizations. Signatures may be electronic.

2C. The nomination paper of a candidate for Youth Representative shall be signed by not less than ten (10) certified members of the Democratic Party of Hawai'i, all of whom are members of the Party who are thirty-five (35) years of age or younger.

2D. The nomination paper of a candidate for a State Central Committee member shall be signed by not less than five (5) certified members of the Party from the nominee's Senatorial District or Caucuses.

2E. The nomination paper for a State Central Committee member filing as a County Representative shall be signed by not less than five (5) certified members of the Party from the nominee's County.

The nomination paper of a candidate for a caucus seat shall be certified by the caucus and signed by the caucus chair and one other officer. The caucus representatives are elected at the Democratic State Convention.

**CAUCUS POSITION NOMINATION
RULES (2012 Constitution and Bylaws)**

Pursuant to **Article V, Section 2** – Papers for the Caucus Representative seats shall be filed after certification by the Caucus, but at least twenty (20) days prior to the State Convention (May 4, 2014). In the event that no papers have been filed by the filing deadline, the filing deadline shall be extended until ten (10) days prior to the State Convention (May 14, 2014). However, no additional nomination papers shall be allowed for those positions for which papers had been filed by the filing deadline.

If a member has resigned from the Party in the two (2) years prior to re-enrollment in the Democratic Party of Hawai'i, the re-enrolled member must be a member in good standing for at least one (1) year before the next election prior to being elected Party Chairperson or for election to the State Central Committee.

Section 2. Nomination and Filing.

2A. Any citizen resident in the State of Hawai'i, who is or will be a member of the Democratic Party of Hawai'i for one (1) year before the next election shall be eligible to be a candidate for election to Party Chairperson.
