## **University Student Learning Outcomes Achievement Report Academic Year 2013-2014**

Fresno Pacific University systematically assesses the effectiveness of its programs as faculty engage with students in providing experiences that contribute to the achievement of the University Student Learning Outcomes (USLO). Course signature assignments are one tool used to evaluate institutional effectiveness and are used as a direct measure of student learning. In courses deemed summative to a program, faculty develop signature assignments with associated analytic scoring rubrics whose criterion lines are aligned to the USLOs. Faculty evaluate student signature assignments with these rubrics and the results are systematically collected and analyzed. The University has met its 90% benchmark for the total percentage of students it anticipates will Meet plus Exceed expectations for each USLO.

**USLO-1 Oral Communication:** Students will exhibit clear, engaging, and confident oral communication – in both individual and group settings – and will critically evaluate content and delivery components. For USLO 1, Oral Communication, 96% of students Met + Exceeded institutional expectations of performance.
