President's Report, 2010-2011

Last year at this time, the future of the Historical Society of Rockland County was uncertain. The Historical Society was faced with a deficit, dwindling membership, poor attendance at exhibitions, and a diminishing revenue stream. We managed to pull through this past fiscal year without an executive director or a curator of collections, both necessary for overseeing the operation of our four-acre site and care of our vast collection of artifacts.

We were blessed to have Trustee Clare Sheridan serving as acting director, with her only compensation being the pure joy of serving the Historical Society. Trustees and volunteers stepped forward to develop and work on an array of programs, exhibits and events to bring in funds, attract visitors to our site, and inform people of our mission. Office Manager Joanne Potanovic, Bookkeeper Patty Brenner, and Acting Public Relations Coordinator Dan Dwyer enthusiastically did their jobs and at the same time stepped in to volunteer their time in various ways. Through it all we learned that we really care about our history, we care about our historic house and outbuildings, and we care about our History Center building.

Currently our Endowment Fund is healthy, our Operating Fund has grown, and we have a Capital Fund that has allowed trustees to make necessary repairs, but we are not out of the woods yet. We have still to take in sufficient income on a sustainable basis to hire back the fulltime staff that we had. After many years of deferred maintenance, the Blauvelt House and the History Center building need significant work. Recently the trustees had the property appraised. That appraisal is now being studied to help us determine what is in the best interest of the Historical Society as the trustees continue to plan for the future.

In planning the Historical Society's future, we need to focus our efforts. Granting agencies and the New York State Council on the Arts have told us that we try to do too much, that we are too ambitious, that we lack focus. How can our Blauvelt House be put to better use, and how can it and our vast collection be better joined together as tools to tell the story of Rockland's people? This is the challenge we face, but the bottom line, as a friend with long experience in the museum world told me, it's all about people. It's about opening the eyes of children to the rich history that is their inheritance. It's about people who care for our gardens, who research and write about Rockland's past, who serve as a docent at the Historical House Tour. It's about all of us wanting to keep history alive.

Interim Director's Report 2010 - 2011

During the fiscal year 2010-2011 the work of the Historical Society's Board of Trustees and staff was guided by the difficult financial realities that continue to face the Historical Society. We are among many not-for-profit entities in the region that have struggled with funding challenges. Despite this challenging climate, many interesting and important events and programs occurred, primarily due to the hard work of a small but committed paid staff and an extremely hard working group of volunteers.

The trend continues for historical societies and museums all over America continue to struggle with reduced funding. In addition, funding organizations, such as NYSCA, are sustaining further cuts. Since HSRC depends on these sources for operating and project funds, we are ever more dependant on our membership for individual support. Like last year, we worked with an austerity budget and I am happy to report that we have been successful in running HSRC without a deficit in 2010. Once again, our budget for the 2011/2012 fiscal year projects another year of "living within our means." This budget includes funds to hire a museum professional on a part-time basis. The Board of Trustees recognizes that the lack of paid museum professionals is unsustainable.

This past year, the Board of Trustees worked very hard reviewing our current mission, analyzing the contents of our collection as well as our collections policies and procedures. In addition, each of our committee chairs led a comprehensive review of programs and events to determine the best and most cost effective plan for the future. We continue to create a tiered organizational plan that will allow us to adapt to the ongoing sustainable income that we are able to raise. Sustainable revenue is the key to our long-term survival.

This year, we did an in-depth review of our membership database. We are happy to report that we have 600 paid members. Our efforts resulted in the highest membership revenue since 2007, almost doubling last year's total membership revenue. However, in order to thrive, HSRC must continue to recruit new supporters, further revitalize our existing member base and continue to retool our programs. By doing all of these important steps, we are hopeful that we will be able to create an ongoing, sustainable revenue stream from our supporters, allowing us to continue and thrive. In short, we will hope for the best, but continue to be fiscally prudent so that we are prepared for what the future may bring.

Our members came through for us this year in a big way by helping us create wonderful and interesting exhibitions. Many of them did this as an in-kind donation which allowed us to have our doors open with stimulating exhibitions at little or no cost to the Society. For this, we are truly grateful.

The 35th annual dollhouse and miniatures show was, once again, a success. The exhibition was curated by our own staff member Joanne Potanovic who compiled a unique and superb group of exhibitors. Illustrations, quilts as well as room scenes and full doll houses were all on view to the delight of viewers. This year the exhibition also included model airplanes, hanging from the ceiling, which were a delight to our visitors.

Our 2011 Annual Dinner took place in March at The View in Piermont. The HSRC award for Lifetime Service was presented to The Beckerle Family. The Dinner Committee, with the staff, produced a splendid event with music and silent and live auctions. For the first time, we included an informative video presentation about the honorees which was a terrific addition to the evening's program. All of this helped to create an event that allowed us to exceed our fundraising goals.

Other interesting events such as the Historical House Tour, entitled "Piermont Places" were a terrific success. We did fundraiser in partnership with the Piermont Historical Society. Our bus tours to places such as the D&H Canal Museum continue to be popular. This year we began a new outreach through the local radio station WRCR 1300am. "Crossroads of Rockland History" airs on the third Monday of each month and explores the interesting history of our county. In 2011, we renewed our membership with the RBA (Rockland Business Association) and have been involved in activities with them as another way to reach out to the business community of Rockland. Our programming was also enhanced with joint events with the New City Library, The Rockland Audubon Society and the Clarkstown Garden Club.

Staff members who work to keep our varied programs and daily operations on course include Joanne Potanovic of Stony Point, membership and office manager; Patrice Brenner of New City, bookkeeper; Robert Carrol of New City, caretaker, and Marianne Leese of Montebello, historian.

Volunteers are a truly vital of our operations. Our board of Trustees has stepped into the shoes of vacancies in our staffing. Dan Dwyer, after finishing his appointment through Americorps has stayed on as a volunteer helping us with our media outreach and press releases. Joyce DeSousa is a mainstay of our on-site educational programs, Donna DeSousa and Caroline Tapley are master gardeners at work in the HSRC's gardens and Lisa Levin and Betty Perry assist in the collections and library. Office volunteers include Marie Lombardo and Joyce Voce. Loyal Blauvelt House docents include Ruth Begany and Stephanie Patteris. Adele and Bob Schnell, Dorothe Flieger, Bernie Smith are all people we count on! Richard Anderson and the Friday Work Crew, have been busy doing many things to improve our buildings and grounds. There are so many more and the great news is that we continue to work on an active recruitment campaign with the help of Penny Leonard, and Patricia Cropsey. This has resulted and will continue to result in new help which we so desperately need. We are

indebted to the volunteers who work in all areas of our Historical Society. Thank you all!

There were some grant awards received during 2010-'11. We seek to cover broad support from towns, county, state and national sources, with varying results each year. From the New York State Council on the Arts we received funds for folk arts programming. County funding for 2010 was received, although it was less than the prior year. We received town funding for our radio program from the Town of Ramapo and we were delighted to have "Rockland Voices" underwritten by The Provident Bank Charitable Foundation. We will be preserving this exhibition on DVD so that it can be available even when these objects are not on view at the History Center.

We received significant private anonymous donations this past year that were critical to our financial success. We challenged our membership to match these contributions and we had modest success. These individual contributions and bequests, grand and modest, received or utilized in 2010 were the lifeblood of our existence. The individuals who made them thought it important to contribute to the continuance of the society's work, and we are grateful and strengthened by their insight and support. Our thanks go also to those members who generously gave to the annual appeal. All of these donors have challenged us to be better and hopefully they will inspire the rest of our membership and history lovers throughout Rockland to give generously to keep history alive at The Historical Society of Rockland County. We look forward to our members' continued participation in our journey to best serve the people of Rockland, to work together with like-minded organizations and extend the HSRC's reputation in the Rockland community.

Publications Report 2010-2011

A Catch of Grandmothers: A Poem by Firth Haring Fabend went into its third printing this past year. Thanks to donations from the author and two Historical Society members, we were able to cover the cost of printing 1,000 copies.

The Society's best-selling publication, Rockland County: Century of History, edited by Linda Zimmermann, is nearly out of print. Quotes for reprints of the hard cover and the soft cover have been requested. Funding for the reprint will need to be pursued.

Another publication that has gone out of print is Frank Bertangue Green's 1886 The History of Rockland County. The Society first reprinted the original 1886 edition in 1989 with a name index added.

All proceeds from our publications go into the Operating Fund. There is no publications fund; therefore, an author who wants the Historical Society to publish his or her work must come up with a funding plan. Funding for reprints must also be raised.

The South of the Mountains has entered its 55th year of publication under the editorship of Marjorie H. Johnson. Receipt of the history quarterly is a valued benefit of membership.

At this time there is no active Publications Committee. Anyone who is interested in reactivating this committee is welcome to speak to me. Needed is to bring our publications program into the digital age.

Sadly, this past year we lost a member who had been active on the committee: Jules Loh, a retired award-winning AP reporter, who died in August 2010. An expert editor and proofreader, he assisted with editing True Stories from Mine Hole, written by Leonard C. Cooke and Audrey S. Lawson, and had fun doing it!

Collections Committee Report 2010 -2011

Over the past year, the charge for the Collections Committee has been to start to give the Society's collections a sharper focus and in the process necessarily reduce their bulk.

The Committee feels that, to be part of the collection, an object should above all have a clear relationship to the County of Rockland and to the Society's mission. It should also be original, have been correctly accessioned and be in acceptable condition. These criteria obtain for the archival collection in the Library and the Vault. They obtain also for the thousands upon thousands of artifacts presently housed in the Collections Storage Room, in the Blauvelt House, and in the Barn – everything from ploughshares to pinafores, from toys to typewriters, from wigs to weathervanes.

Meeting weekly, the Collections Committee has started with the archival materials: family papers, letters, diaries, business records, maps, photographs, postcards, the printed records of the activities of political parties and debating clubs.

Much of this material had been properly accessioned: when the Committee determined such material should be removed from the collection, trustee approval was required and proper procedures had to be followed. Other things were drop-off donations, which presented problems of their own. We have removed duplicates, mildewed material, photocopies, and reams and reams of printed material with no connection to the County. We have also effected transfer of archival material to other institutions -- for example, the Scott Webber collection to the Orangetown Historical Museum and Archives which is consolidating material related to Camp Shanks, and copies of Lederle's in-house magazine to the Pearl River Library.

Before she left in last spring, Jessica Kuhnen, Collections Curator, had begun digitizing the collection and had made considerable progress. We are hoping that Senator Morahan's 2010 member item grant (frozen in Albany at present) might be used to enable further digitization, either by employing an outside agency, or possibly by buying a scanner and paying an intern to do the actual work.

Building and Grounds Committee 2010-2011

During the fiscal year just ended, the Building and grounds Committee, like the rest of the Society worked very hard to minimize expenses and do what we could with volunteer labor. The committee consists of Clare Sheridan, Liz Barhydt, Marianne Leese, Joseph Holland, David Scharf, Pat and Jim Cropsey, and myself. Richard Anderson has joined the committee recently, and Arthur Gunther has been an active helper.

We had a tree service remove and prune trees that were a danger to people or buildings, and spray our hemlocks to keep them from dying. We also cut up fallen trees and cleared dead limbs ourselves.

We hired ADT to replace the old heat detectors in the Jacob Blauvelt house with smoke detectors which will give an earlier warning of smoke or fire. The existing wiring was used, resulting in a great savings over a complete new system.

We established a Friday Morning Work Crew that did a variety of jobs in all of our buildings and on the grounds.

We replaced most of our incandescent light bulbs with more efficient compact fluorescent and halogen bulbs.

We reorganized and inventoried the contents of the Carriage House, Shed and Barn following the dislocation that was necessary for the restoration work done in these buildings over the prior two years.

We rebuilt and restored the small first floor bathroom in the Jacob Blauvelt House after finding a rotted floor under the toilet. Richard Anderson undertook the completion of the project as a personal contribution, installing a new floor and repainting the room. Arthur Gunther installed a new toilet which he and his wife Lillian donated to the Society. Rich was on the job and detected a drip from a pipe in the kitchen above. He and Joanne Potanovic got a plumber to come and repair it before any serious damage was done.

Art tested all the electrical outlets in the Jacob Blauvelt House to verify that they are properly wired and grounded.

We studied options for the repair or replacement of a broken air conditioning system serving the east half of the museum building, obtained proposals, reviewed them, and made a recommendation to the Board for the purchase of a new system.

We reluctantly deferred for another year a New York State Environmental Defense Fund grant for work on the Jacob Blauvelt House because of our

inability this year to raise sufficient funds to match it. We hope that the economy may improve sufficiently for us to do so next year.

We have prioritized lists in preparation for work that should be done on the Jacob Blauvelt House and the Museum building next year and in following years. With the barn in great shape, it is time to turn more attention to deferred maintenance in our main buildings..

This year's favorable outcome was due to strong membership renewals, higher than planned special events income, together with special individual one-time contributions and the sale of The Tanner Atlas. In addition, savings were achieved by not filling planned staff and consulting positions. These savings were offset slightly by audit expenses, building maintenance and program expenses that were higher than anticipated.

Endowment Committee Report 2010/2011

The Endowment Fund of the Historical Society of Rockland County grew from \$974,000 to \$1,020,000 during the most recent fiscal year.

This increase is after disbursing five per cent (5%) of the portfolio value to the Society to cover its normal operating expenses.

The portfolio is invested in a combination of income producing securities, growth stocks and mutual funds.

A portion of the portfolio is managed by Maribeth Holland of Sutton Place Capital Management and a portion of the portfolio is invested in a select group of Admiral Class Mutual Funds at Vanguard.

Historic Sites and Historical Markers Report, 2010-2011

Our Jacob J. Blauvelt House marker was redone, thanks to the generosity of Marjorie Hornblower Johnson, sponsor of the marker. The old one, erected 1980, had incorrect information on it; and its post had been damaged. The new marker corrects the text and gives additional history about the site. It was installed this past summer on the south lawn of the Jacob J. Blauvelt House where visitors to the site can easily read it.

In the works is a marker recognizing Betty Friedan's contribution to the feminist movement with her best-selling book *The Feminine Mystique*, written and published when she was living in Grand View in the 1960s. The marker, when completed, will be installed in front of Village Hall in Grand View. It is being sponsored by the National Organization for Women, Rockland Chapter. Sculptor Cristina Biaggi of Palisades has created a bas relief of Ms. Friedan that will be fused to the marker.

Concerns for several historic properties in Rockland County came to the attention of the Historical Society. Efforts were made to find a nonprofit to rent and occupy the 18th-century Dutch sandstone house at 312 Strawtown Road, West Nyack, owned by United Water New York. The house has been unoccupied for several years and is in need of extensive repair. In February the Clarkstown Historic Review Board voted to disapprove a petition by United Water to demolish the house.

Concerted last-minute efforts were made by concerned citizens and Historical Society members to save the historic 1860s Malloy building in Stony Point, owned by the State of New York. It was recently demolished so that Route 9W can be widened and a park created.

The Historical Society was contacted in regard to the 19th-century Bardon store/post office/railway station at Route 304 and Bardonia Road, Bardonia. The Bardonia Civic Association is keeping a close eye on the potential demolition of the building and development of a QuickChek on the site.

The Historical Society is interested in preserving historical sites and informing people of their options, such as pursuing nomination to the State and National Registers of Historic Places. It is difficult to convince property owners not to destroy a historic site or make unsympathetic alterations. Often the only way to save a site is to purchase it, but too often the resources are not available. Another alternative is to work with local municipalities to create historic preservation laws, which the Village of Montebello, the Town of Orangetown and the Town of Clarkstown already have in place.

2010-2011 Special Events and Programs Submitted by Clare Sheridan

Exhibition: Rockland Voices: This **semi-permanent** exhibition was made possible by generous support from Provident Bank Charitable Foundation. It related early history through historic objects and documents. Stories of the people, buildings and sites were told using highlights from Historical Society's varied collections. For example, through **Tunis Smith's diary**, the exhibition looked at observations from a farmer's diary in the lower Hudson --ordinary, extraordinary, and vivid details of farming as a way of life and the relationship farmers had to the landscape, weather, crop production and sales. With the help of items such as **Elizabeth Van Houten's Sampler**, the exhibition explored childhood in that period of time and information about her and her family.

Exhibition: Why Archives Matter: a traveling exhibition developed by the Upstate History Alliance, was shown in the back gallery of the museum from March 21 through May 9. The exhibition explored the meaning, use and preservation of archives and historical records using visuals from repositories throughout Upstate New York, including photographs, maps. **Why Archives Matters**, featured items from the Historical Society's permanent collection and included Civil War diaries; WWI exemption letters; a 1775 Stony Point Deed, WWII era cards, Woman's Suffrage handbills; cotton horse thief poster from Clarkstown circa 1890 and an 1877 Ramapo tax ledger.

Exhibition: Images of Rockland in Photographs and Words Arthur Gunther, III

The retired editorial page editor, columnist and staff photographer of The Journal-News in Rockland County, worked with our own Joanne Potanovic to create a beautiful exhibition of photographs to compliment some of the essays from The Column Rule. The book Gunther created in 2006. Gunther served with the Journal News for 42 years. He wrote more than 6,000 pieces for the newspaper, including about 2,500 weekly columns. In May 2010, Gunther was awarded the Arts Council of Rockland (ACOR) County Executive's Arts Award for Visual Artist of the Year.

Exhibition: Rockland History: Through Your Eyes – Images that define our sense of place & time.

Curated by George Potanovic

We asked 39 artists for images that define their sense of place and time in Rockland County history. The exhibition had an exciting feature... guests were encouraged to download the mp3 audio tour into i-tunes and then they listened to it on their i-pod at the exhibit. The audio tour was also available on a CD player with headphones available from the front desk.

Exhibition: Following in their Footsteps

Photographs, by George Potanovic, of local scenes from the exact place where the photographer, made the original photograph up to 100 years earlier graced the historic Jacob Blauvelt House.

This project was made possible, in part, with funds from the Individual Artist Grant program of the Arts Council of Rockland and the Decentralization Program of the New York State Council on the Arts.

Exhibition: Snapshots in Time:

The Palisades Mall is our newest venue. "A Snapshot in Time – Pictorial Moments in Rockland History" opened at the Palisades Center mall in West Nyack, and will be on display throughout 2011. The multi-photo exhibit depicts various aspects of life in the area from the year 1880 through the 1960s. HSRC provided the photos, the mall donated the space, KDF Reprographics prepared the images for display and served as artistic director. Liz Barhydt was instrumental in making this long-term exhibition happen.

Exhibition: Miniature and Doll House Show

Our 35th annual doll house and miniatures show was titled: A Celebration. This year's exhibition showcased the work of miniature artist Sandra Mirque. Sandra, originally from Rockland County, now resides in Orange County, NY. Sandra has been exhibiting at the HSRC for many years now. Each of her detailed room boxes tells a story and are very appealing to those of us who are young at heart.

Sandra also graciously created a hand-made Tuscan-themed room box which she donated to the HSRC for the raffle. All proceeds from the raffle will be donated to the HSRC.

We were pleased to be exhibiting pieces by collage artist Elizabeth Parsons of Monroe, NY -- this was Elizabeth's first time exhibiting at the HSRC. We also showed beautiful art dolls and dollhouses by West Nyack artist &

Marianne B. Leese

He earned a Bachelor of Science Degree in Public Administration from the University of Maryland in 1960 and later attended continuing education classes at Rockland Community College. He was appointed a Lieutenant Colonel in the New York State Guard in 1994, and a Colonel in 1998, from which he retired in June, 2004.
