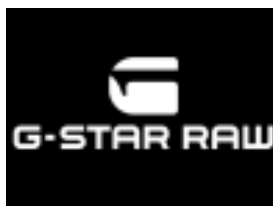
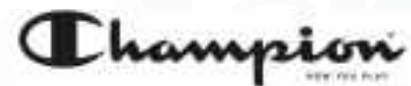

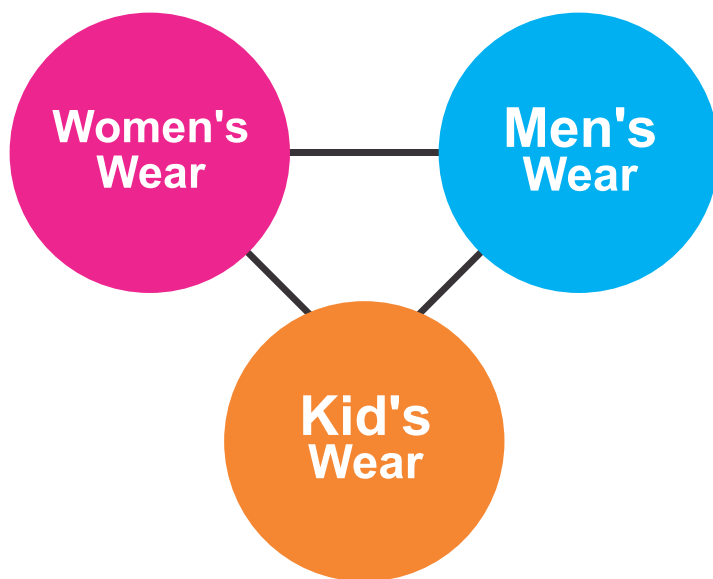

Buyer Promotion Scheme
