




WASHINGTON'S ECONOMY






ATTRACTING NEW JOBS TO WASHINGTON

Would you favor or oppose Washington giving special tax rates to new businesses in order to incentivize them to locate here?






TRANSPORTATION FUNDING

When it comes to funding transportation projects in Washington, please tell me which of the following you would prefer:


- 1. Leaving gas taxes at current levels and making the transportation department use their current budget to maintain existing infrastructure.


If the elections for state legislature were held today would you prefer to vote for the Republican candidate or the Democrat candidate?

- 2. Republicans and the majority caucus retaining control of the state senate is a bad thing because it will create more gridlock in our state government.






WASHINGTON'S POLITICAL CLIMATE

Please tell me which political party will do a better job handling each of the following issues – the Republican Party or the Democratic Party: *Funding Education*




Please tell me which political party will do a better job handling each of the following issues – the Republican Party or the Democratic Party: *Growing the Economy and Creating Jobs*

On a scale of 1 to 10 with 1 being not at all concerned and 10 being highly concerned, please tell me how concerned you are about protecting the environment in Washington?










To the best of your knowledge, does the majority of the public favor or oppose shipping fossil fuels like oil and coal along Washington's railways?

Agree/Disagree: King County has too much influence over policies that affect all of Washington State.






CARBON REDUCTION IN WASHINGTON






SHELLFISH AND TIMBER

Would you favor or oppose Washington's state agencies implementing policies that will support the growth of shellfish farming in Washington?




To the best of your knowledge, when private forest lands are harvested for timber, how often are trees replanted – always, almost always, some of the time, rarely or never?






TRANSPORTATION ISSUES IN WASHINGTON






NEW MEDICAL SCHOOL IN EASTERN WASHINGTON

In general, would you favor or oppose Washington State University establishing a new medical school to increase the number of doctors who are educated and trained in the State of Washington?






STATE LIQUOR LAWS


As far as you know, as a result of the new law allowing private liquor sales, do you believe the price of liquor in Washington has gone up, gone down or stayed about the same?






STATE MARIJUANA LAWS



STATE GUN LAWS






WASHINGTON'S MINIMUM WAGE

Would you favor or oppose raising the state's minimum wage to \$12 per hour?




If the state's minimum wage were increased to \$12 per hour, do you think the number of jobs in Washington would increase, decrease or stay about the same?
