REGISTRATION FORM - RADIOACTIVE MATERIAL  
IN CERTAIN MEASURING, GAUGING OR CONTROLLING  
DEVICES UNDER GENERAL LICENSE

R313-21-22(4) of the Utah Radiation Control Rules establishes a general license authorizing persons to own, acquire, receive, possess, use, or transfer radioactive material in certain devices. Registration of radioactive material under this general license is completed once Form DRC-13 has been filed along with the \$20.00 registration fee to the Division of Waste Management and Radiation Control and a Certificate of Registration has been returned. Pursuant to R313-70-5(3)(a), a general license Certificate of Registration is valid for a period of five years provided the annual fee is paid.

The device to be registered is the smallest “device containing the radioactive material” accessible to the registrant while following the manufacturer’s instructions. For example: If you possess a gas chromatograph, you should register the electron capture detector (which contains the radioactive source) not the gas chromatograph (which contains the electron capture detector).
