PREFACE

Graham Flight, who had been elected in the most recent General Election held on April 2, 1985 publically resigned his seat in the House of Assembly on June 26, 1987 and shortly thereafter, tendered his resignation as is required by the *Legislative Disabilities Act*, to His Honor, the Lieutenant-Governor. As a result the Provincial Electoral District of Windsor-Buchans was without representation. Mr. Flight resigned, he said, to afford the Leader of the Liberal Party of Newfoundland, who was not an elected member of the Legislature, an opportunity to seek election to the House of Assembly in a By-Election in Windsor-Buchans. A Liberal Party Convention held in St. John's had, earlier, on June 6, 1987 elected CLYDE K. WELLS Leader of the Liberal Party of Newfoundland.

The Administrator in Council commenced a By-Election in Windsor-Buchans by Proclamation dated November 25, 1987 in which it was directed that:

- (1) a Writ of Election for the Electoral District of Windsor-Buchans be issued on the 25th day of November, 1987;
- (2) the last day of Nomination of Candidates would be the 7th day of December, 1987 and on that day nominations must be made at the Provincial Court in Grand Falls; and
- (3) the day of Polling would be the 17th day of December, 1987.

Regulation 211/87, dated November 25, 1987 ordered the use of the March, 1985 Official List of Electors for the By-Election.

Three Candidates were nominated — Helen Joe a New Democrat; Sean Power a Progressive Conservative; and Clyde K. Wells a Liberal. These three candidates represent the only parties active in the Province at present.

Regulation 221/87 ordered Advance Polls held in the towns of Windsor and Buchans on both Saturday, December 12, 1987 and Monday, December 14, 1987. A Proclamation dated December 7, 1987 (Regulation 222/87) ordered Special Polls held on Polling Day in the following locations:

Western Community College, Stephenville Grand Falls Central Community College, Grand Falls Central Community College, Gander Fisher Institute, Corner Brook Cabot Institute, St. John's The Health Science Centre, St. John's The Grace General Hospital, St. John's St. Clare's Mercy Hospital, St. John's The Waterford Hospital, St. John's The Leonard A. Miller Centre, St. John's James Paton Memorial Hospital, Gander Central Newfoundland Regional Health Centre, Grand Falls The R.C.M.P. Facility, Grand Falls Bishop's Falls Correctional Centre, Bishop's Falls Salmonier Correctional Institution, Salmonier Her Majesty's Penitentiary, St. John's

Newfoundland & Labrador Correctional Centre for Women, Stephenville

These provide patients in acute care facilities an opportunity to exercise their franchise. Similar administrative procedures were in place in Correctional facilities. Special Polls for students and all other qualified electors were established in educational institutions. Moreover, in the District regular polls were set up in the R.C.M.P. facility in Buchans and also in the A.M. Guy Memorial Hospital there, pursuant to the *Election Act* at s.s. 53(8). They are significant primarily because extant electoral law does not provide for Proxy and/or Absentee voting. Special Polls administratively enable electors outside the Electoral District to vote. The specific choice of locations is the result of a careful study of germane information by the Chief Electoral Officer and a recommendation, subject always to reasonable limitations, made usually between elections.

PREFACE (Continued)

Clyde K. Wells, the Leader of the Liberal Party, was elected with a majority of 428 votes. He was sworn in as member for Windsor-Buchans in the House of Assembly at Government House in St. John's by the Lieutenant-Governor, The Honourable James A. McGrath, P.C., LL.D., on December 31, 1987.

The March, 1985 Official List of Electors has been used in three By-Elections since the April 2, 1985 General Election. Statistics on the number of electors affirmed or sworn on Polling Day in these elections is set out below. These electors names are not on the Official List of Electors.

This is an indication that the 1985 Lists are aging. There appears to be a significant difference between Urban and semi-rural Electoral Districts.

Section 63 of the *Election Act* precludes persons other than electors, one by one if necessary, the election officials, and candidates agents (one per polling station) from being permitted to remain in a polling station. The exceptions to this rule are the Candidates and/or their Official Agents. The *Election Act* discusses Official Agents at s. 121. Because the competition to win is intense, runners, outside agents, and others, (generally political party workers) unlawfully enter the polling space. Further, it is difficult to find agents who will remain throughout the 12 hours of polling. These facts present difficulties which affect the conduct of the polls and indeed affect peace and good order. As a result s. 63 was and shall continue to be strictly enforced.

Section 11A of the *Election Act* clearly states the Military must vote where they are stationed. Officials encountered Military electors stationed at C.F.B., Gander who regarded Windsor-Buchans as their permanent domicile. While the *Canada Elections Act* permits such an electoral practice, the provincial electoral law does not.

The statistics on Special Polls are provided in totals as are Advance Polls to protect the secrecy of the ballots cast by electors. Sometimes in Special Polls there are very few electors and if all vote for the same Candidate the secrecy of the poll is compromised, after the fact.

The Notice of Grant of Poll is included to assist interested persons with future activities.

A very sincere thank you is extended to the many election officers who conducted this By-Election so very well. Similarly, the Co-operation of political parties, the candidates, and workers was outstanding.

For this By-Election a plan was in place to defer the election if absolutely necessary. Indeed this plan applies to any election and major officials are carefully briefed. The *Election Act* as s. 35, s. 54, and s. 55 refers. The circumstances were such because of an extremely inclement weather forecast. Thus a decision was taken to stand ready to implement the plan. However it was not necessary as the weather improved significantly, particularly in the District. These remarks are made to point out to electors that weather cannot dictate the outcome of any election. Electors only have this prerogative.
