
PROGRAMS YEAR IN REVIEW

2011–12 HIGHLIGHTS

HMI Year in Review

- » HMI awarded over \$380,000 in financial aid, more than 20% percent of the school's operating budget, to semester and summer students. In total one-third of our students received scholarship awards to make their semester or summer experiences possible.
- » The HMI Apprentice Program announced a partnership with Colorado College, through which participants in Colorado College's Master of Arts in Teaching program can enroll in HMI's Apprentice Program as part of their teaching practicum in order to earn their degree.
- » Sixteen semester alumni returned to HMI in April as founding members of the Alumni Council. They enthusiastically learned about the progress of HMI as an organization and brainstormed ways in which they can contribute to HMI's future including improving our alumni relations and resources. They also connected with fellow alumni and current students, and shared their semester experiences.
- » HMI hired three former Semester Apprentices to fill three faculty openings. A formal search was conducted for each of these positions, and these three individuals each rose to the top of their respective pools; therefore, we take great pride in the efficacy of HMI's Apprentice Program.

HMI Semester Need Based Financial Aid Amounts



HMI Semester

- » The HMI Semester welcomed Rebecca D'Elia, former French faculty, to the role of Dean of Students. Over the course of the year, she worked with the faculty to develop a clearly documented Residential Life Curriculum. Now, HMI has formally outlined all three legs of the stool–Academics, Wilderness, and Community and will continue to revise and balance them in the years to come.
- » HMI continues to receive applications from students who attend different schools and from various regions across the country. This year over 100 different schools were represented in the applicant pool and our percentage of public school applicants increased by 9%.
- » Students in Semester XXVIII participated in a Science Research Project with a PhD candidate who studied the efficacy of learning environments, specifically how students use their learning environment to learn science on extended field trips. The study will provide useful information to enrich HMI's Natural Science course and experiential learning opportunities throughout our curriculum.
- » Over the summer, HMI supported Semester faculty in a range of professional development opportunities. Opportunities included attending the National Association of Independent Schools School Leadership Institute, participating in the Klingenstein Summer Institute through Columbia Teachers College, beginning a Masters in Science in School Leadership at the University of Pennsylvania, visiting a variety of school apprentice and mentor programs to learn and collaborate, teaching in a summer program at Colorado Rocky Mountain School, and living in Costa Rica speaking mainly Spanish.

Summer Programs



- " Twenty-two students attended the HMI Summer Term of 2012; this represents an increase of almost 20% from last year's inaugural summer. They participated in a new integrated curriculum: A Sense of Place. The class involved studying and exploring many facets of Leadville through scientific, environmental, and social lenses.
- » HMI awarded over \$56,000 in scholarships for summer programs including the Summer Term and the

High Peaks Adventure. Scholarships were granted to nine students in the HMI Summer Term, or over 50% of summer program participants.

- With the generosity of the Kayne Foundation, HMI, in partnership with Full Circle of Lake County and the Lake County Public Schools, led two Lake County Backpacking Trips, each with eight middle school students. We were excited to be able to lead two trips this year as the smaller groups allowed us to create a rich group environment, have a greater impact on each student, and reach more Lake County students.
- » The High Peaks Adventure received a record number of applicants for the scholarship that is awarded to a local Lake County Middle School student each summer. In addition to the Lake County Backpacking Trip, we were thrilled to offer another opportunity for a local middle school student to participate in an HMI course.

"The HMI experience doesn't end when they come home in December. We have discovered with both Will and Alex that what happened in those 4 months stays with them and is so much a part of how they finish off their high school years and chart the next path. It really keeps growing. You don't always see it in January, February or March during the re-entry. I remember noticing it with Will about a year afterwards, and I see it now with Alex. It's hard to describe, but during their senior years both boys had a clear sense of purpose about who they are and where their strengths and interests are. It is very powerful."
