Defining Child Marriage

Child marriage occurs when one or both of the spouses are below the age of 18. In developing countries, child marriage is widely practiced. Child marriage is a human rights abuse – it constitutes a grave threat to young girls' lives, health, and future prospects. The right to a 'free and full' consent to a marriage is recognized in the Universal Declaration of Human Rights. Consent cannot be 'free and full' when the bride is a young girl.

Why It Matters

- Child marriage perpetuates a cycle of gender inequality, domestic abuse, maternal mortality, health problems, and poverty.^{5 6}
- **Inequality**: Younger girls are particularly vulnerable to being married to men who are significantly older or men who have multiple wives.⁷
- **Domestic Abuse**: Many child brides are abused by their husbands and families. As a result, many opt for self-immolation and other forms of suicide.⁸
- Maternal Mortality: Complications related to childbirth and pregnancy are the leading cause of death worldwide for girls ages 15 to 19.9

- Health Problems: Girls who have babies also have a high risk of suffering from obstetric fistula - a condition that causes incontinence.¹⁰ Girls with fistula are often abandoned by their husbands and isolated from friends and family.¹¹
- Poverty: Girls who marry young are more likely to be poor and remain poor. 12
- Education: Child brides are almost always forced to drop out of school. 13

Who Is Affected?

- More than **60 million** girls worldwide are child brides. 14
- More than 100 million girls are expected to marry in the next decade. 15
- In South Asia, 48% of women between 15 and 24 are married before age 18.16
- In Afghanistan, 57% of girls are married by the age of 16.17
- In **Afghanistan**, where *Sharia* (Islamic law) is influential, girls can legally marry at age **15**. ¹⁸In **Bangladesh**, **66%** of girls are married before age **18**. ¹⁹
- More than half of the girls in Mali, Mozambique, and Niger are married before age 18.²⁰
- In **Malaysia**, Muslim girls under the age of **16** can marry with the permission of the *Sharia* court. The minimum age for non-Muslim girls is **18**.²¹

- In Iran, the legal age of marriage for girls is age 13.22 In 2009, more than 43,000 girls under age 15 were married in Iran.23
- In **Sri Lanka**, there is a dual legal system the minimum age for non-Muslim girls is age 18, while Muslim girls are allowed to marry at age **15**.²⁴
- In **Saudi Arabia**, there is no minimum age for girls to marry. There are more than **5,500** child brides below the age of **14**.²⁵
- In Yemen 52 % of women are married before they are 18²⁶

In The West

- In Canada, ²⁷²⁸ Australia, ²⁹ and the United Kingdom, ³⁰ hundreds of teenage girls are flown abroad to South Asia, the Middle East, and Africa and forced into marriage.
- There are approximately 1000 cases of forced marriage a year in Australia.31
- There are up to 8000 cases of forced marriage annually in England.³²

- Karma Nirvana, a UK forced marriage hotline, receives 500 calls a month.33
- There were **3, 443** cases of forced marriage in **Germany** according to the latest date.³⁴
- A majority of the cases of forced marriage reported in the UK involve **South Asian** families. But there have been cases involving families from **East Asia**, the Middle **East**, **Europe and Africa**.³⁵
- The Iranian and Kurdish Women's Rights Organization helps **Middle Eastern** women and girls living in the **United Kingdom** who are forced into marriage.³⁶ Several girls are in their early teens the youngest girl helped was **9** years old.³⁷
- Many of the girls flown abroad and forced into marriage are from **Pakistan**. 3839
- A recent study found that there were 3000 cases of forced marriage in the US in the last two years alone.⁴⁰

Why Does It Happen?

• Girls are viewed as objects in deeply patriarchal societies. Families consider girls a burden and marry them off early as possible. 414243.44

- Women are often traded as commodities or a way to settle a dispute. For instance, in Pakistan, 'vani' is a tribal custom in which young girls are given as child brides to settle feuds and disputes.⁴⁵
- The practice is culturally and religiously condoned. Clerics, imams, and other religious authorities conduct child marriages in traditional Islamic ceremonies.⁴⁶

Laws and Law Enforcement

In the East

- Statistics about child marriages are incomplete families often circumvent the law by deliberately not registering underage marriages.⁴⁷
- However, though most countries have laws that regulate marriage, the laws may not be applied and few prosecutions are ever brought against lawbreakers.⁴⁸

In the West

- In Belgium, Norway and Germany have recently added criminal penalties for forced marriage.⁴⁹
- Forced marriage will soon become a criminal offense in **England, Wales**, **Northern Ireland, and Australia**. 5051
- In **2011**, **Scotland** passed legislation to provide help with those threatened with forced marriage and those already in a forced marriage.⁵²
- In the UK, there is a forced marriage unit and a forced marriage hotline.
