Census 2011: what we do

The data in this section covers how we occupied ourselves, whether we provided care for less able members of society, what levels of qualifications we had, whether we were employed and if so where and how many hours we worked, and what industries and occupations we were employed in.

Unpaid care

10.6% of usual residents¹ provided unpaid care to family members, friends, neighbours and others because of long-term physical or mental ill health or disability, or problems related to old age, an increase of one percentage point since 2001. Of this group, nearly 27% provided 20 hours or more unpaid care, compared to nearly 23% in 2001.

Qualifications

33.7% of residents aged 16 and over had a level 4 qualification and above compared to 29.9% in Gloucestershire, 27.4% in the South West, and 27.2% in England & Wales (rank 2 within E & W = 56). This is an increase of 9.7 percentage points since 2001

18.5% had no qualifications compared to 19.6% in Gloucestershire, 20.7% in the South West and 22.7% in England & Wales; this is a decrease of 4.8 percentage points since 2001. The group who reported no qualifications includes those aged 16 and over who were still studying.

A smaller percentage of residents were undertaking apprenticeships (3.2%) in the District compared to 4% in Gloucestershire, 4.3% in the South West, and 3.6% in E & W

Economic Activity

In 2011, there were 60,075 residents aged between 16 and 74; of these 72% were economically active³, similar to Gloucestershire (72.5%), and higher than the SW (70.2%) and E & W (69.7%)

The percentage of full-time employees decreased by 3 percentage points from 39.5% in 2001 to 36.5% in 2011, and the percentage of part-time employees and self-employed both increased by 1.8 percentage points over the decade

The District had a high proportion of self-employed people; 16.1% compared to 11.2% in Gloucestershire and 9.7% in England & Wales (rank within E & W = 10)

16.2% of residents were retired compared to 14.9% in Gloucestershire, 15.8% in the South-West and 13.8% in England & Wales (rank within E & W = 121)

¹ A usual resident of the UK is anyone who, on census day, was in the UK and had stayed or intended to stay in the UK for a period of 12 months or more, or had a permanent UK address and was outside the UK and intended to be outside the UK for less than 12 months.

Employment

41,529 residents aged 16 and over were in employment, 51.4% were male and 47.1% were female

The percentage of the workforce that were female increased 2.5 percentage points over the decade from 44.6%, and conversely the percentage of the workforce that were male decreased by 2.5 percentage points

Overall, there was a fall in the proportion of full-time workers, and a rise in the proportion of part-time workers over the decade. The fall in the proportion of full-time workers was entirely attributed to male workers, while for female workers - there were increases in both the part-time and full-time work categories

69% of residents aged 16 and over in employment worked full-time (31 hours and over) – 45.1% males, 23.8% females - a decrease of 4.6 percentage points

31% of residents aged 16 and over in employment worked part-time (30 hours or less) – 7.8% males, 23.2% females - an increase of 4.6 percentage points over the decade

2.5% of residents aged 16-74 were unemployed but looking for work, 0.9% were long term unemployed and 0.2% had never worked – all lower rates compared to Gloucestershire, the SW, and E & W

Industry (based on all usual resident aged 16-74 in employment)
As well as being the largest industry of employment nationally in 2011, the wholesale and retail trade was also the largest employer in the District (15.8%). The next largest groups were 9.7% in education and 9.3% in human health and social work activities

In comparison to other local authority areas in E & W, we have a relatively higher proportion of residents working in agriculture, forestry and fishing (rank within E & W = 34), accommodation and food services (rank within E & W = 46), and professional, scientific and technical activities (rank within E & W = 57)

The three largest industries for males were wholesale and retail, construction, and manufacturing; and for females, wholesale and retail, human health and social work activities and education

Occupations (based on all usual residents aged 16-74 in employment)
The largest categories were professional occupations (17.3%), followed by managers, directors and senior officials (15.6%), and skilled trades (14.1%)

Males tended to be engaged in skilled trade occupations (23%), and as managers, directors and senior officials (19.2%), as well as professional occupations (17.1%)


Females tended to be engaged in administrative and secretarial occupations (17.8%), professional occupations (17.5%), and caring, leisure and other service occupations (16.2%)




Ecomomic activity - all male usual residents aged 16-74

Economic activity - all female usual residents aged 16-74






Industry - all residents aged 16-74



Industry - all female usual residents aged 16-74 in employment





Occupations - all residents aged 16-74 in employment




Occupation - all male usual residents aged 16-74 in employment
